**Guests – All guests of sponsoring members** are required to register at the Pool Office and pay the appropriate fee(s). **PROOF OF NON-RESIDENCY IS REQUIRED** at the time of sign in. Daily guest passes will be issued and **MUST BE WORN BY ALL GUESTS** for the duration of their visit. There will be a charge of \$20 for each guest 13 years of age and over and \$17 for each guest under age 13 or senior citizens 65 and older. *Guest fees apply to all guests.*

# GARDEN CITY SWIMMING POOL

## 2025 ELIGIBILITY AND CHARGES

**Family Pass - \$560:** Resident families of the Village of Garden City are eligible. Family season passes include only immediate members (one or two adults and their unmarried children under 25 years of age) residing at the same address as a single housekeeping unit.

**Family of Two Pass - \$390:** Two resident family members residing at the same address. If one of these persons is under the age of 13, the other must be over 18 years of age.

**Senior Citizen Couple Pass - \$360:** An adult couple who reside in the Village of Garden City, living at the same address as a single housekeeping unit and either applicant will be 65 years of age or older before July 1, are eligible for this reduced rate. Proof of age is required (Medicare card not acceptable).

**Individual Pass - \$315:** An individual who is a resident of the Village of Garden City and is 13 years of age or older is eligible. Applicants under 18 years of age must attach a letter of permission from a parent or guardian to their pool application. An individual pass does not entitle any other member of the individual member's family to use the pool or its facilities.

**Non-Resident Caregiver Pass - \$270:** If you employ a non-Village resident as a caregiver for a member of your family, you may apply for this category for your caregiver. This pass is a restricted membership, and holders of this pass will only be admitted to the Pool while in the company of the resident pool Member that they are employed to care for.

**Senior Citizen Individual Pass - \$240:** If you meet the above requirements for individual membership and will be 65 years of age or older before July 1<sup>st</sup>, you are eligible for this reduced rate. Proof of age is required (Medicare card not acceptable).

**School District Family - \$670:** FAMILIES THAT ARE NOT RESIDENTS OF THE VILLAGE OF GARDEN CITY, BUT RESIDE WITHIN THE BOUNDARIES OF THE GARDEN CITY SCHOOL DISTRICT AND MEET THE FAMILY REQUIREMENTS ABOVE ARE ELIGIBLE.

**Guest Book - \$150:** Residential households will have the option to purchase a guest book for an additional fee. Books include 10 guest passes that may be used for residents without a pool membership or out-of-town guests. Each household is limited to **ONE guest book per season.** Passes will be accessed via your CommunityPass account and will expire on 9/2/2025. Unused passes will not be rolled over to the following pool season. All purchases are final, no refunds will be made after the opening date of the pool.

### NOTICE TO ALL APPLICANTS

- The Village of Garden City reserves the right to reject any application containing a false statement and may deny membership for the season.
- In rejecting the application, the Village will retain \$20.00 of the applicant's fee as a reasonable cost for processing the application.
- Season Pool Passes may be revoked at any time without a refund if secured by means of a false statement on the application form.
- Pool Passes will be revoked if presented by anyone other than the person to whom issued. Season Passes are non-refundable.
- Pool Passes may be revoked at any time for failure to comply with all sanitary and safety rules, as well as regulations as specified for administration of the Pool facilities.
- No refunds will be made after the opening date of the Pool.
- The Village of Garden City reserves the right to add or modify regulations as deemed necessary by the Pool Management
- **Completed Pool Passes will not be mailed back to applicants.** Completed passes can be processed at the Pool Photo Center by any adult family member.
- The Village assumes no responsibility for personal property. Jewelry, wallets, and other articles of value should not be brought to the Pool.
