## From the desk of the Pastor...

As I write this, we are just concluding the Season of Advent, the start of a new liturgical year. By the time most of you read this, we will have started a new calendar year. I have just completed the first semester of my Th.D program and most of you do not know how much soul searching I have been doing as a result of that doctoral work. It is easy, in the life of the local church, to get caught up in so many things: stewardship, building issues, administrative tasks required by one's denominational governing body, etc. All of these are important, but when one does these things for decades, they can become one's preoccupation. Now, with General Conference looming in February, I realize how much mental energy I have spent being concerned about the future of United Methodism and debates over issues of human sexuality. Indeed, there seems no end to the list of things about which one can become concerned, or at least TOLD that one should be concerned!

**I**t is easy, in the life of the local church, to get caught up in so many things... All of these are important, but when one does these things for decades, they can become one's preoccupation...

Many of us are familiar with the biblical story of Mary and Martha. Jesus loved to spend time with these two friends of his, and their brother Lazarus. The scriptures tell us that Martha expressed concern about preparing a meal, and trying to do a million things at once when Jesus came to call. Her sister, Mary, caused Martha no small amount of consternation as Mary sat quietly at the feet of Jesus while Martha fussed and fumed in the kitchen. Jesus then reminded Martha of the most important thing, and that Mary had chosen the better part.

Stephen Richards Covey (October 24, 1932 – July 16, 2012) was an American educator, author, businessman and keynote speaker. You might be familiar with one of his bestselling books, *The 7 Habits of Highly Effective People*. He is also the author of one of my favorite quotes: "The main thing is to keep the main thing the main thing." Somewhere along the line, in the midst of Charge Conference reports, Wesley Improvement Projects, figuring out how best to encourage a congregation to tithe and attend church regularly, I lost sight of "the main thing." It took a great doctoral mentor named Dr. Leonard Sweet and the nudge of God's Holy Spirit to get me back on track.

## Did Ya Know? A Finance Tidbit



If you are required to take a required minimum distribution (RMD) from your IRA or other qualified retirement plan because you are 70.5 years old or older, you can have your RMD paid directly to Wesley UMC. Instead of getting a charitable deduction, the distribution is tax-free, which in turn might reduce the amount of your taxable Social Security income. If this strategy appeals to you, please reach out to your retirement plan trustee or custodian - he or she will need time to process the paperwork and make the distribution to Wesley UMC.

If you elect to make a donation to Wesley from your retirement distribution, please contact Laura Waltrup to assist with providing any necessary information to your financial advisor and for instructions as to where you would like your distribution to be applied: a lump sum in lieu of weekly tithing or a designated donation for a special purpose such as Wesley Improvement Projects (WIP), Endowment, etc. Thank you!

**From Your Lay Members to Annual Conference:  
Final Pre-Conference Report on the Special Called Session of General Conference  
February 23-26, 2019, Regarding Human Sexuality**

This is our final piece in *The Wesley Journal* covering The Way Forward and the special session of General Conference coming up February 23-26. We hope that these columns in the *Journal* have helped you understand more about what is happening with the future of the United Methodist Church and our discussions on human sexuality.

We will continue the conversation on January 27<sup>th</sup> after the Outreach Committee sponsored Baked Potato Luncheon. After the luncheon has ended, we will be showing pieces of a talk that was given by Tom Lambrecht at Oakdale UMC in Olney, MD, this past October. The Rev. Tom Lambrecht was a member of the Commission on the Way Forward and is also Vice President and General Manager of Good News. He gave a very balanced talk to help folks better understand the options our denomination is facing and the possible impacts on the local church resulting from February 2019. After the video, we will field any questions you might have regarding the possibilities and how we can work through all of this together as Wesley Church.

Also, in this edition of the *Journal* you will find a summary chart that will help explain the three main plans before the General Conference and their direct impact. Each plan has a column, and in each row, we have listed the impact on various groups and individuals. For the impacts that might affect you the most, pay attention to the rows labeled, "Local Church" and "Lay People." This chart was based on a similar one developed by folks from the Great Plains Annual Conference, as well as Matt's research and work as a reserve General Conference Delegate. This is meant to serve as a reference for you as you learn about the Way Forward. It would also be helpful to bring along if you plan to attend the viewing of the video.

Looking forward to the General Conference, there has been a large effort by the Council of Bishops to promote the adoption of the One Church Plan. With a heavy emphasis on unity of the church, they seek to provide space within the denomination for multiple viewpoints on the questions of human sexuality and sexual practice. That being said, many of the conservative caucus groups (including the Wesleyan Covenant Association) have openly stated that if the One Church Plan were to pass, many traditional and conservative individuals and congregations would consider exiting the United Methodist Church regardless of the cost. On the same token, voices from the very progressive circles of the denomination have indicated that the One Church Plan does not go far enough toward inclusion for LGBTQ individuals within the life of the church. They are recommending a plan (The Simple Plan) that compels ordination of LGBTQ people and celebration of same-sex marriages in every church and conference. This has created a large amount of uncertainty as to the future of the United Methodist Church and its remaining united regardless of what plan passes.

These divergent and competing ideas are all coming into the Special General Conference in February. It is important to note that the delegates of the special session are almost all the same persons as were present in 2016. In 2016, legislation similar to all three plans was considered, and the delegates were set to pass resolutions very much like the Traditional Plan. Legislation similar to the Connectional Conference Plan, the One Church Plan and more progressive solutions had all been rejected by the 2016 General Conference. It was concern for the integrity of the denomination that caused the 2016 General Conference to hit the pause button and seek the Commission on the Way Forward process, and the special session in 2019.

With that in mind, while the atmosphere has changed since the 2016 General Conference, those who are watching this process play out believe the session is not likely to pass anything radical. In fact, it is quite possible that the delegates will not agree to pass anything at all. This would leave the position of the denomination exactly where it is today, but also not do anything for the current stalemate. However, because the stalemate has been so dysfunctional, should nothing pass, many conservative churches (especially in Africa and the Southern US) have already indicated their desire to exit the denomination. Regardless of the outcome in February, the church will certainly be impacted.

Therefore, we continue our call for you to pray for the United Methodist Church. Pray for the Holy Spirit to work within and around the delegates as they depart for St. Louis. About 45% will come from outside of the United States, so pray for approvals of visas and travel for the overseas delegates and for everyone's safe travel. Pray for those who will preside over the sessions, both the Bishops and the lay people, that they would seek to serve God and be sensitive to the movement of God's Spirit. Also pray for Wesley UMC and ask that we can treat each other with love and care as we discern our future together. This is God's church, and he has promised to be with us as we seek his will together. If you have any questions through these next months, please feel free to talk to Matt, Linda or Rev. Amy.

Summary of Plans for General Conference 2019

It's the start of a brand new year! Have you been thinking of beginning an adventure with fictional characters who rely on our Heavenly Father to guide them? Use some of the following to help you to start a relationship with some inspiring and multi-faceted characters in fiction. (Information in parentheses indicates where library items are shelved.)

*The Preacher's Daughter* by Beverly Lewis (Fiction) *The Preacher's Daughter* begins the captivating new series ANNIE'S PEOPLE and introduces an Amish community to Paradise, Pennsylvania—a heavenly sounding place, but one that has seen its share of heartache and mystery. A moving story of friendship, secrets, and love. Annie Zook, the only daughter of an Old Order Amish preacher, wants to please her parents and her Plain community, but a hidden passion stands in the way. Creating fine art is strictly forbidden by Annie's church district. Her secret has already cost her the affection of handsome Rudy Esh. She must choose between her art and the People...the only life she knows. Volume 1 in the Annie's People Series.

*Love Story* by Karen Kingsbury (Fiction). From the day they met, John and Elizabeth were destined to fall in love. Their whirlwind romance started when they were young college students and lasted nearly thirty years—until Elizabeth died of cancer. So when John Baxter is asked to relive his long-ago love story with Elizabeth for his grandson Cole's heritage project, he's not sure he can do it. The sadness might simply be too great. But he agrees and allows his heart and soul to go places they haven't gone in decades. At the same time, Baxter family friend Cody Coleman is working through the breakup of his complicated relationship with Andi Ellison. He is determined to move on when a chance sighting changes his plans—and heart. Can Cody convince Andi to give their love another try, or is it time for them to say goodbye for good? As school comes to an end, Cole presents his report on the love story between his grandparents John and Elizabeth Baxter. It is a tale that touches the hearts of the entire family, and one that causes Cole to better understand his own beginning.

*Running Around (and Such)* by Linda Byler (Fiction). Lizzie Glick longs to fit into her quiet Amish community. Her sisters, Emma and Mandy, are ready to get married and settle into the traditional rhythm of having children and keeping house. But Lizzie isn't sure that's what she wants for her future. It isn't that Lizzie doesn't want to stay Amish. It's just that there's so much to figure out! Stephen, her quiet, gentle friend, hints that he might be interested in a relationship deeper than friendship, but Lizzie is also drawn to the charming Amos who seems to have eyes for everyone but her. She has certainly attracted the attention of the egg-truck driver. A thrill runs through her every time the worldly man comes to pick up an order, each time extending his stay a little longer. How long will she keep this a secret from Emma – and Mam and Datt? What will become of Lizzie? She has too hot a temper. She hates housework and dislikes babies. Despite all odds, will the faith and love Luke and Meredith share be enough to bring them back together again? Or will Meredith begin a new life with another? - The VANCO buttons [electronic giving] have been changed to include WIP
- The Finance "end of year" letter from Lee Ann will mention WIP
- Enabling the congregation to hear things is very important.

**Update from Seminary Student Matt Sichel:** Lord willing, Matt will graduate in the Spring. He may take a year off before pursuing his doctorate. He may have the opportunity to teach at his seminary during that year.

- Matt, one of our two Lay Members to Annual Conference, a reserve delegate to General Conference, and a member of the Wesley Covenant Association (WCA), met with the Bishop and other members of the WCA to discuss the special February 2019 session of the General Conference of the UMC. The Bishop has been very transparent and forthright. She wrote a letter published in the Baltimore-Washington Conference newsletter earlier in the year advocating the "One-Church" plan. The WCA is advocating for the "Traditional" Plan [there are multiple plans that came out of the UMC Commission on The Way Forward earlier this year.] Part of the WCA's response to the Bishop was also printed in the Conference newsletter. The Bishop wanted to have an open dialogue. She is committed to leading the Annual Conference through February of 2019; however, she is leaving her options open.
- **The Bishop has insisted that churches MUST be talking about the upcoming session of the General Conference on Human Sexuality.**
- Rev. Amy raised the issue of talking about what might be vs. what will be. Answer: when you get the weather report and there are many possibilities for the path of the hurricane, you "prepare for the worst and hope for the best." Some congealing does seem to be happening/beginning around certain ways forward.
- Mike Sichel asserted at multiple points during the conversation that we must be communicating with the congregation.
  - ❖ There will be a discussion with the Wesley Congregation in January. It was previously suggested that there be a panel discussion.
  - ❖ There have been presentations/discussions around the conference about The Way Forward. One of these, featuring Tom Lambrecht, was video recorded. The suggestion was made that we have a group video showing.
- Another question was raised: Do we, as Wesley UMC, need to decide which plan [to adopt/support]? Answer: Not yet. BUT, if the Annual Conference votes and we don't like the result, then the congregation must decide how to move forward (according to most plans.)
- Discussion continued. More people are thinking practically, as in "What does this mean?" Ideas for clarifying the answer to that question include:
  - ❖ Publishing a chart already made suggesting what could/would happen to whom under each major plan [see pages 7 and 8 in the January 2019 issue of The Wesley Journal.]
  - ❖ Having a Town Meeting after February 2019.
  - ❖ Holding a question and answer session.
- The Special Session of the General Conference will be held February 23<sup>rd</sup> through 26<sup>th</sup> [in St. Louis, MS.] **The council decided that there will be a group showing of a shortened version of the Tom Lambrecht discussion video after church on January 27<sup>th</sup>** (this coincides with the Outreach Potato Luncheon and will be brought up to Vicky Wilmer.) This video showing needs to be advertised. Kim Peake will make posters about being informed.
- **On March 10<sup>th</sup>, there will be a Town Hall in place of Sunday School to report out about the Special Session which will have already occurred.** A decision will not be made by Wesley UMC at that time; instead, the outcome of the Special Session will be presented on/discussed.
- Discussion about the actual Special Session renewed. Matt provided details about the form in which the session will take, including what each day would hold (day 1 – worship & prayer, etc.)
- **The denomination (UMC) has asked for prayer for the Special Session. Rev. Amy suggested a Wesley UMC Prayer Vigil for the session from 2/23 to 2/26.**

Mike Sichel (and all) were thanked for our service. Mike thanked the committee. Thanks were extended to Jason Martin for coordinating the new computer for the library. The meeting was closed in prayer by the Chairperson, Mike Sichel, at 8:17 PM.
