

Release, Waiver, Indemnification, Hold Harmless,
And Assumption Of the Risk Agreement

Whereas, in return for instruction in firearms, use of premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned agrees to the following:

The undersigned, individually and as guardian of any minor children that are participants as listed hereinbelow, agrees to indemnify, hold harmless and defend the Buck and Bull Club, and any of its employees, directors, officers or agents, from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: the discharge of firearms; the course of instruction; the Buck and Bull Club range, buildings, land and premises (hereinafter the "premises"); and, any injuries and damages sustained by the undersigned and/or and of undersigned's family members, while on the premises. And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, the State of Texas, or under any theory of law or equity, the undersigned will indemnify, hold harmless and defend the Buck and Bull Club, from any and all cost, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against the Buck and Bull Club, whether individually, jointly, or in solido with the undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees. The undersigned expressly indemnifies and holds harmless the Buck and Bull Club from the undersigned's and undersigned's family members' negligence and gross negligence, if any, as well as any sole and/or concurrent negligence and gross negligence, if any, attributed to the Buck and Bull Club.

The undersigned furthermore waives for himself/herself and his/her executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he/she may have or which any arise against the Buck and Bull Club, (including but not limited to any and all injuries, damages or illnesses suffered by the undersigned or the undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: the course of instruction; the premises, including any latent defect in the premises; the undersigned's presence on or use of said premises; the undersigned's property (whether or not entrusted to the Buck and Bull Club); and, the discharge of firearms. The Buck and Bull Club shall not be liable for, and the undersigned, on behalf of himself/herself and his/her executors, administrators, assignees or heirs, hereby expressly releases the Buck and Bull Club from any and all such claims.

The undersigned hereby expressly assumes the risk of entering the premises and of taking part in activities on the premises which include, but are not limited to, the discharge of firearms and the firing of live ammunition.

The undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all the Buck and Bull Club Range rules and procedures and make sure that any minor children participants abide by such rules and procedures. This instrument binds the undersigned and his/her executors, administrators, assignees or heirs.
