# MAINTAINING OUR DUTY OF CARE?

Working with the Diocesan Registry to ensure our buildings are safe for our church members and the community that frequents them.

There have been a number of incidences within the Diocese involving falling bells causing injury and fires possibly caused by overloading of electrical points. We have a duty to ensure that our buildings, how we use them, and maintain them, are safe for our church members and the community that frequent them.



Natural disasters have also caused increases in cost of policies by

the Insurance companies who are now considering compliance to rules and ensuring duty of care in their quotations.

When many of our buildings were constructed there were rules regarding safety for occupancy and use. As some maintenance was undertaken, things were updated according to later revised and established rules. Once again these rules have been updated and compliance is being enforced by significant fines. Consequently, the Parish is currently undergoing a number of inspections to assess the compliance of our of our buildings.

This inspection activity is needed for the following reasons:

**Safety of parishioners, staff and contractors**: Ensuring the safety of everyone who uses our property is paramount. Risk management initiatives help to identify hazards that can cause injury, such as fire risks, structural issues, or security vulnerabilities, and enable us to

These inspections must be conducted by experienced, accredited professionals, and in some cases may also involve follow-up work or remediation planning. As a result, while the costs may seem high, they are necessary to ensure the safety, legal compliance, and long-term integrity of our buildings.

This will, of course, make a difference to our budget as we continue to cover the cost of continuing inspections, prioritise and make the rectification works where necessary.

- *mission priorities*: consciously sets both immediate and long-term goals
- **sacrifice**: able to call for, and make, personal and corporate *sacrifices* to bring about the vocation, vison, and mission priorities and living out faith.

#### address them proactively.

**Compliance and legal protection**: We must adhere to a complex framework of legislation and regulations governing property safety and risk management.

*Duty of care*: We have a duty of care to ensure the safety of all people who use our property and to prevent foreseeable harm.

**Protection of assets**: Risk management helps to identify potential risks to our assets and to implement measures to address them.

**Insurance benefits**: Our existing, and prospective, insurers look favourably on organisations with robust risk management practices in place. Demonstrating sound risk management may increase other insurers' interest. Greater competition can produce more favourable premiums and coverage terms.

*Financial stability*: We can avoid significant future financial impositions by identifying and mitigating risks before they result in losses.

**Reputation management**: A significant incident, such as a fire or injury on Diocesan property, can damage our reputation. Proactive risk management helps to avoid such incidents.

*Ministry continuity planning*: Pre-loss testing and risk management help us to continue our ministry activities with no (or minimal) disruption. This includes having plans in place for emergency response, business continuity, and disaster recovery.

Consequently, the following inspections are currently taking place to ensure all of our properties remain safe, legally compliant, and fit for purpose:

- Electrical (non-residential)
- Electrical (residential)
- Fire Safety and Planned Maintenance
- Gas Safety
- Asbestos Management
- Emergency Evacuation Diagrams, and
- Essential Safety Measures.

The cost of the initial inspections is to be covered by the Diocesan budget, but the Parish will be responsible to meet the cost of:

- any rectification works at their properties arising from the property compliance and inspection activities undertaken in 2025, and
- Future routine property compliance and inspection activities at their properties from 2026 onwards.
