Dan will check into if we can cut back earlier in the Spring after we take over the trails on April 15. We need help in cutting around signs because the club cannot spray herbicides. We have weed whips and tools to do this if you don't have your own. To spray herbicides on county/federal land it must be done by DNR or county employees trained and certified. Please help with brushing where you can. Also sweeping or cleaning intersection crossings.
