AS PER NM LIVESTOCK BOARD

- ALL horses must have a negative coggins, original signed report, within one year. Copies or faxes WILL NOT be accepted.
- All out of state horses must have a CVI (health paper) within 30 days of the sale
- All New Mexico Horses from out of District must have a Form 1 inspection or Form 1-H (permanent horse card).
- All horses from in District, without a Form 1 or permanent horse card, will have to have a bill of sale, registration papers, owner's registered New Mexico brand, or other accepted proof of ownership documents.
- All horses will be inspected prior to sale.
- All horses will be issued an inspection to travel from the state.

Conditions:

1. XIT HORSE SALES/KW VENTURES and its associates act as agents only and are not responsible for buyer/seller error or misunderstanding. All guarantees are strictly between the buyer and seller.
2. If horse is registered and sold as registered and registration papers, transfers, or correct breeding report are not presented to office prior to sale, proceeds will be held until paperwork is received.
3. The commission will be **8%** of the selling price.
4. If Seller guarantees the horse **"Sound"** it is between the Seller and Buyer.
5. Seller's money will be mailed **five days (5)** or before to seller.
6. Consignor has the privilege to **"NO SALE" OR "PASS OUT"** his horse in RING. No cost to pass out, but other fees will apply.
7. The catalog fee is non-refundable and cost is \$125 and due when consigning horse.
8. CONSIGNOR AGREES TO NOT PRIVATELY SELL OR WITHDRAW CONSIGNED HORSE PRIOR TO SALE unless injured/sick with vet release.
"NO SHOWS" WILL BE CHARGED \$350 PER HEAD WITH OUT VETERINARY VERIFICATION.
9. **ALL HORSES-** Must have current Coggins, Health Certificate and Brand Inspection from their state. See above requirements from New Mexico Livestock Board.

NOTICE: Videos are welcomed and encouraged and will be available only for internet preview. All consignments must go through the sale ring. Alley trading is NOT allowed, all sales must go through office. This is a CONTRACT and you have consigned your horse to the sale at XIT Horse Sale in Roswell, NM.
