## **TERMS & CONDITIONS**

These Terms & Conditions ("Terms") govern your participation in any program, session, service, or event offered by Next Touch Academy. By registering, enrolling, attending, or allowing your child to participate, you ("Client," "Parent," "Player," or "you") acknowledge that you have read, understood, and agree to be bound by these Terms.

### 1. SERVICE DESCRIPTION

Next Touch Academy provides youth sports training programs, including but not limited to group sessions, private training, partner/trio training, seasonal programs, camps, clinics, and special events. Session types, schedules, pricing, and capacity limits may vary.

NTA reserves the right to modify, cancel, or update any program offering at any time.

### 2. PAYMENT TERMS

All payments must be made in full at the time of booking unless otherwise stated. NTA accepts electronic payments, including but not limited to credit/debit cards, bank transfers, Zelle, or payment processors integrated through our website or registration platforms.

#### 2.1 Late Sign-Up Fee

Registrations made within **2 hours** of a session start time will incur a **\$5 late registration** surcharge.

#### 2.2 Non-Payment

Failure to complete payment will result in loss of registration, removal from the roster, and/or denial of participation.

## 3. REFUND & CREDIT POLICY

All sales are considered final unless otherwise stated.

#### 3.1 Drop-In Sessions

- Non-refundable unless canceled by NTA or a documented medical reason is provided in advance.
- Makeup sessions are not guaranteed.

#### 3.2 Training Cycles (5 Weeks for Summer/ Winter - 6 Weeks for Fall/ Spring)

- Full refund within **24 hours** of purchase.
- 75% refund or full credit if requested before Week 1 begins.
- No refunds after the cycle starts.
- Credits may be issued for documented injuries or emergencies at NTA's discretion.

#### 3.3 Starter Packs

- Non-refundable once the first session has occurred.
- Refundable only if unused and requested within **7 days** of purchase.

#### 3.4 Unlimited / All-Access Packages

- Non-refundable and non-transferable.
- No adjustments or credits will be issued based on attendance.

#### 3.5 Private, Partner, and Small Group Sessions

 Cancellations must be made 24 hours (private/partner/trio) or 48 hours (group 4+) in advance. Late cancellations or no-shows result in full charge.

#### 3.6 Membership Fees

• Premium Membership fees are non-refundable and non-transferable.

# 4. ATTENDANCE, MAKEUPS & CANCELLATIONS

#### 4.1 Parent/Player Responsibility

Clients are responsible for arriving on time and prepared for sessions.

#### 4.2 Makeup Policy

Makeups may be available within the same cycle, space permitting. They are not guaranteed and cannot roll over to future cycles.

#### 4.3 Weather & Field Conditions

NTA may cancel, delay, or relocate sessions due to weather, field closures, or safety concerns. Makeups or credits will be offered when possible, but **refunds will not be issued** for weather-related changes when reasonable alternatives are provided.

## 5. PLAYER CONDUCT

Players are expected to demonstrate:

- Positive attitude
- Safe behavior
- Respect toward coaches and other players

Appropriate effort and focus

NTA reserves the right to remove any player whose behavior endangers others or disrupts the training environment, without refund.

## 6. PARENT CONDUCT

Parents/guardians agree to:

- Model positive sideline behavior

- Respect coaching decisions
- Communicate concerns privately and professionally

Violation may result in removal from the premises or termination of service.

Parents may opt out in writing prior to participation.

In the event of injury, you authorize NTA staff to seek or administer necessary medical care.

NTA reserves the right to terminate service to any client at any time for:
