

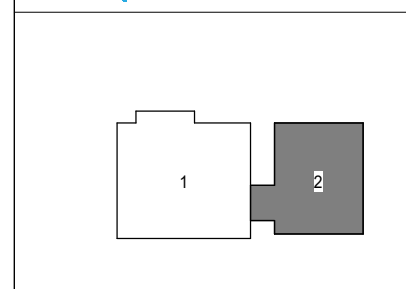
MEZZANINE PLUMBING PLAN - UNIT 2
