INTERIOR

The aircraft is configured with eight elegantly appointed, fully belted leather seats. A spacious cabin-class entry door provides easy access to a comfortable stand-up cabin. The refreshment center is conveniently located behind the pilot's seat, adjacent to a small upright coat closet. Upon entering the cabin, passengers will find a dual-seat couch positioned sideways, followed by four center seats arranged in a club configuration, complemented by two large, stowable, and foldable tables. Additionally, two forward-facing seats are situated behind the club configuration. At the rear of the aircraft, there is a fully belted, flushable lavatory adjacent to a portable sink. The interior of the aircraft was refurbished in 2015, ensuring a modern and inviting atmosphere.
