Chief Mountain Regional Solid Waste Services Commission Bylaw No. 001-20

BEING A BYLAW RESPECTING THE APPOINTMENT OF A BOARD OF DIRECTORS AND DESIGNATION OF THE CHAIRPERSON OF THE CHIEF MOUNTAIN REGIONAL SOLID WASTE SERVICES COMMISSION

WHEREAS pursuant to Section 602.07(1) (a) of the *Municipal Government Act*, the Chief Mountain Solid Waste Services Commission must pass a bylaw respecting the appointment of its Directors and the designation of its Chair, and

WHEREAS a bylaw passed under Section 602.07(1) (a) of the *Municipal Government Act*, must be approved by the Minister of Municipal Affairs before coming into force.

NOW THEREFORE the Board of Directors of the Chief Mountain Regional Solid Waste Services Commission enacts the following:

1. DEFINITIONS

- 1.1.1."Act" means the Municipal Government Act, R.S.A. 2000, c. M-26;
- 1.1.2."Board" means the Board of Directors of the Commission;
- 1.1.3. "Chair" means the chairperson of the Board;
- 1.1.4. "Commission" means the chief Mountain Solid Waste Services Commission;
- 1.1.5. "Director" means a person appointed to the Board of Directors of the Commission in accordance with this Bylaw;
- 1.1.6."Members" means the member municipal authorities as set out in the Regulation.

2. BOARD OF DIRECTORS

- 2.1. The Board shall consist of twelve (12) Directors that shall be appointed as follows:
 - 2.1.1.One (1) Director, who shall be an elected official from Cardston County.
 - 2.1.2.One (1) Director, who shall be an elected official from the County of Warner No. 5.
 - 2.1.3.One (1) Director, who shall be an elected official from the Town of Raymond.
 - 2.1.4.One (1) Director, who shall be an elected official from the Town of Cardston.
 - 2.1.5.One (1) Director, who shall be an elected official from the Town of Magrath.
 - 2.1.6.One (1) Director, who shall be an elected official from the Village of Stirling.
 - 2.1.7.One (1) Director, who shall be an elected official from the Town of Milk River.
 - 2.1.8.One (1) Director, who shall be an elected official from the Village of Warner.
 - 2.1.9.One (1) Director, who shall be an elected official from the Village of Coutts.
 - 2.1.10. One (1) Director, who shall be an elected official from the Village of Glenwood.
 - 2.1.11. One (1) Director, who shall be an elected official from the Village of Hill Spring.
- 2.2. A Member may revoke the appointment of its appointed Director and may appoint a replacement Director.
- 2.3. The Directors shall elect, from amongst their number, the Chair and the Vice-Chair at the first Regular Meeting of the Board in November of each year.
- 2.4. The term of office for the Chair and Vice-Chair is one (1) year.

3. AMENDMENTS

- 3.1. In accordance with section 191(2) of the Act, a bylaw to amend this Bylaw does not come into force until the bylaw is passed:
 - 3.1.1.by a majority of the Directors of the Board; and
 - 3.1.2.approved by the Minister of Municipal Affairs.
- 3.2. Thirty (30) days' notice shall be provided to the Directors and the Members when an amendment to this Bylaw is being considered.

4. SEVERABILITY

4.1 If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed, and the remainder of the bylaw is deemed valid.

This bylaw will come into force once approved by the Minister of Municipal Affairs.
