



RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

By submitting my entry, I hereby acknowledge that as participants, parents and guardians (collectively "Participants") that equine events such as barrel races/rodeos/ jackpots and other equine activities (hereinafter separately and collectively referred to as "Events"), are dangerous activities and participants in an Event as a competitor, an independent contractor, volunteer or spectator, exposes themselves to substantial and serious risk of property damage, personal injury or death.

CLARK COUNTY WESTERN HERITAGE FOUNDATION DBA CLARK COUNTY BARREL RACING ASSOCIATION (hereby referred to as "CCBRA") participants acknowledge that participation in CCBRA sanctioned events will involve such hazards.

Participants are informed about NRS 41.519 (limitations on liability; duties of a participant in an equine activity) and are fully aware that participation in CCBRA events will expose said participant to the possibility of substantial and serious risk of property damage and or personal injury or death. Participants agree that they will act in a safe and responsible manner when engaged in CCBRA Events. As such Participant hereby forever release and discharges CCBRA its sponsors, production entity, their affiliated, related or subsidiary companies, and the Officers, Directors, employees and agents of all and separately each entity or organization from liability for any and all property damage, personal injury or other claims arising from participation in the CCBRA Events, including claims that are known and unknown, foreseen and unforeseen, future or contingent. CCBRA participants shall not now or at anytime in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the aforementioned arising out of or related to the actions, causes of action, claims and demands hereby waived, released or discharged by CCBRA. This provision shall be binding upon each CCBRA participant, their spouse, parent, guardian, legal representatives, heirs, successors, agents and assigns.

CONSENT RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

CERTIFICATION OF IRS INFORMATION: Under penalties of perjury, I certify that: 1) the number shown on this form is my correct taxpayer identification number, AND 2) I am not subject to withholding due to failure to report interest and dividend income, AND 3) I am a U.S. person, AND 4) the Foreign Tax Compliance Act code entered on this form (if any) indicating that the payee is exempt from FATCA reporting is correct. You MUST cross out item 2) if you have been notified by the IRS that you are currently subject to backup withholding because of reporting of interest or dividends on your tax return.

Participant must be at least 18 years of age or parent legal guardian must sign this release in order to participate in any CCBRA Event.

Participant agrees to be bound by the Rules of CCBRA, as applicable. Participant further acknowledges that participation in an Event as a competitor exposes the participant to serious risk of property damage, personal injury or death. Participant assumes the risk of competition in any Event entered and expressly waives and releases any and all claims applicant may now have, or may in the future, for property damage, personal injury or any other claim which applicant now has, or may have in the future against CCBRA, its officers, directors, employees, CCBRA sponsors, or any CCBRA -sanctioned event entity, their affiliated, related or subsidiary entities, any committee, any Event producer, or production entity. This provision shall be binding upon applicant, their spouse, legal representatives including parents or guardians, heirs, successors, and assigns.

CCBRA PARTICIPATION IS SUBJECT TO COMPLIANCE WITH ALL CCBRA RULES. COMPLETE AND UP TO DATE RULES ARE POSTED ON WWW.CLARKCOUNTYBARRELRACING.COM

The Internal Revenue Service does not require your consent to any provision of this document other than the certifications required to avoid backup withholding. I understand that CCBRA may disclose to event producers, committees or similar representatives information contained on this form for filing of IRS 1099s or other business purposes.

Media Release - The Participant consents to being photographed and/or videotaped during participation in any CCBRA Events and consents to the use of those photographs or videotapes in the promotion of CCBRA, including but not limited to their use in promotional literature and their release to print media, television, social media, or other electronic media. This provision shall be binding upon each CCBRA participant, their spouse, parent, guardian, legal representatives, heirs, successors, agents and assigns.
