When I got outside her mother Ms. Joan and our other neighbor Meechie and Morkea and myself got in the car and proceeded to go to 8th and Race. When we got to 8th and Race, Morkea and Ms. Joan

got out of the car and I sat in the car with Meechie and waited. A few minutes later she came out, she came back out and she said to me that they wouldn't let her see her daughter, I went on to say that that's not right she is a child she is not supposed to be in there by herself and Morkea told me that India's dad is in there. Now we are in front of 8th & Race and Bruce came out and then a few detectives came outside. The detectives started to talk to Morkea and Ms. Joan.

- Q. The detectives that came out can you describe them to me?
 A. One was a tall white guy and there was a black one with a backpack.
- Q. Could you hear the conversation between the detectives, Morkea and Ms. Joan?
 A. Yes a little but not completely.
- Q. Can you tell me what you heard?
 A. The tall white detective was asking Morkea to sign something and her response was "No." that was the same detective that told them that India confessed and that she needs to sign these papers and Morkea told them I'm not signing nothing! And I'm like naw she supposed to be in there, she a minor and we went back and forth with them and after that we pretty much left.
- Q. Who were you referring to when you said "she need to be in there"?
 A. Morkea.
- Q. Who was going back and forth and what was the extent of the dialog?
 A. Me, Morkea and Ms. Joan and we were telling the police that Morkea should have been upstairs with India because she is a minor.
- Q. Was anyone else there when everyone was going back and forth?
 A. I'm not sure who was out there it was very chaotic out there.
- Q. Do you remember what time the police came down and told Morkea that India had confessed?
 A. I want to say about 5ish maybe quarter after but no later than 5:30 PM.
- Q. How can you be sure that it was that time?
 A. I was just thinking about how it was evening and what time I was cooking when Morkea knocked on my door to take her to 8th and Race. I'm basing it on what time I normally cook my dinner and I cook start cooking my dinner at 4:00PM- 4:30 PM.


