Q. MY NAME IS DET. WINWARD, CAN YOU TELL, ME WHAT HAPPENED TODAY?

A. I WAS COMING FROM MR, LEROYS HOUSE, IM HIS AIDE FOR HOME HEALTH CARE, I WAS WALKING DOWN RUGBY ST GOING TO CATCH THE 18 BUS ON WOOLSTON. THEY CALL THEM KNICKERBOCKERS OR SOMETHING ALL THE KIDS WEAR THEM. THE PANTS THEY COME UP TO HEAR (C/W MOTIONS TO HER SHIN). HE WAS WEARING A BLACK HIP HOP SHIRT, IT HAS A SILVER TRACE OR DESIGN ON IT. THEY WERE WALKING TOWARDS ME AND HE LEANED LIKE HE WAS GONNA FALL. I SPOKE TO THEM, I SAID, 'HI, HOW ARE YOU DOING?' AND HE LOOKED LIKE HE WAS GONNA FALL. SHE POINTED A GUN AT ME AND SHE SAID, 'GIVE ME ALL YOUR STUFF. I JUST TOOK MY WORK BAG AND MY POCKETBOOK OFF AND I THREW THEM ON THE GROUND AND I START RUNNING. SHE SAID, 'GET HER TRANSPASS, GET HER TRANSPASS.' SO I THREW IT IN THE STREET, I KEPT RUNNING AND I RAN TO THE LITTLE GIRL WHO WAS SITTING IN THE CAR AND THEN I RAN TO MR LEROYS NEIGHBOR AND TOLD HIM I JUST GOT ROBBBD AND HE CALLED POLICE. A, I DON'T KNOW HIS NAME, I SEE HIM EVERYDAY, HE WORKS IN THE STORE, HES LIGHT SKINNED AND MISSING A FRONT TOOTH, HES LIKE MY AGE.

Q. WHERE IS THE STORE?

A, RIGHT THERE ON WOOLSTON NEXT TO RUGBY. THEY HAVE A DUMPSTER IN THE BACK, ITS RIGHT ON WOOLSTON WHERE I CATCH THE 18 BUS. -

Q. WHO HAD THE GUN?

A. THE GIRL FIRST I THOUGHT IT WAS A WATER GUN. BUT IT WAS A .22. IT WAS SMALL AND BLACK, IT WAS

Q. CAN YOU DESCRIBE THE GIRL?

A. SHE HAD ALL BLACK MUSLIM CLOTTES ON, SHE WAS LIKE 25 AND 30, SHE WAS HEAVY LIKE 180 LBS, LIKE A SIZE 18, SHE WAS DARK SKINNED. SHE WAS ABOUT 5'6, SHE WAS LITTLE TALLER THAN ME. SHE HAD THE GUN. SHE WAS AGGRESSIVE.

Q. WAS HER FACE COVERED?

A. NO

Q. DID YOU SEE WHERE SHE PULLED THE GUN FROM?

A. IT HAPPENED SO FAST, HE FELL OVER AND SHE HAD THE GUN.

Q. CAN YOU DESCRIBE THE MALE?

A. HE WAS LIKE 130 LBS WET. HE HAD SHORT CUT HAIR, HE WAS BROWN SKINNED. I DIDN'T SEE THE TEAR DROPS ON HIS FACE BUT THE STORE GUY SAW THAT. HE WAS LIKE 5'2, SKINNY. HE WAS ABOUT 24, NO MORE THAN 24, HES A YOUNG BOY. THAT SHIRT HE HAD ON ITS LIKE TRACED WITH SILVER.

Q. WHAT SIDE WAS HE ON WHEN HE APPROACHED YOU?

A. HE WAS ON MY LEFT HAND SIDE. SHE WAS IN FRONT OF ME.

Q. WHAT DID THEY TAKE FROM YOU? :

A. I DROPPED MY WORK BAG, ITS DARK BLUE WITH WHITE FLOWERS ON IT, BIG FLOWERS, MY GLOVES AND UNIFORM TOP ARE IN IT. A DARK BLUE UMBRELLA IS IN IT. I DROPPED MY BLACK VINYL POCKETBOOK. IS A PROFESSIONAL POCKETBOOK, IT HAS LITTLE METAL THINGS ON THE BOTTOM SO IT WON'T GET DIRTY. THE STRAP IS MAGNETIC.

Q. WHAT WAS IN YOUR POCKETBOOK?

A. I HAD A POLKA DOTS COLORED PURSE SOCK, THERE WAS CHANGE IN THERE. MY BLACK WALLET WAS IN THERE, IT HAD MY LICENSE AND BANK CARDS, MY GREY PHONEBOOK, MY JOB PAPERS. MY CELLPHONE,

Q. WHAT KIND OF CELLPHONE?

A. NOKIA I THINK. IT'S BLACK, MY DAUGHTER BOUGHT ME THE PHONE AND SHE PAYS THE BILL.
