- 5. Applicants must make themselves available for a personal interview should the Board of Directors so decide.
- 6. Lessees or guests are not permitted pets of any kind.
- 7. Use of this apartment is for single-family residence only.
- 8. No commercial vehicles, trucks, boats, trailers, motor homes, mobile homes, campers, recreational vehicles, motorcycles, mopeds, etc. are permitted on the property.
- 9. Moving of furniture is not permitted on Sundays or holidays. Hours for moving are from 8:00 a.m. to 5:00 p.m. Monday through Saturday. Elevators must be padded for moving.
- 10. Residents must wear a cover-up when walking through the building. Bare feet are not permitted.
