



Lido Surf and Sand Condominiums

To Renters:

Lido Surf & Sand is a residential family condominium. To make living at Lido Surf & Sand a mutually satisfying experience, the Board of Directors has established rules and regulations. These rules are enforceable since they form a part of the owner's original condominium contract. Each proposed adult occupant, other than a parent and dependent child (which is considered one applicant) must complete the attached application and authorization forms in their entirety. If any question is not answered or left blank, the application will be returned, not processed and not approved.

1. Complete the attached application form and background check form and return to the office.
2. Attach a copy of the proposed lease to this application.
3. Attach a non-refundable processing fee of \$150.00 payable to **Lido Surf & Sand Owners Association, Inc.** Acceptance of the processing fee does not constitute approval of this transaction.
4. Submit the completed application at least 30 days prior to the lease start date.
5. Applicants must make themselves available for a personal interview should the Board of Directors so decide.
6. **Lessees or guests are not permitted pets of any kind.**
7. Use of this apartment is for single-family residence only.
8. No commercial vehicles, trucks, boats, trailers, motor homes, mobile homes, campers, recreational vehicles, motorcycles, mopeds, etc. are permitted on the property.
9. Moving of furniture is not permitted on Sundays or holidays. Hours for moving are from 8:00 a.m. to 5:00 p.m. Monday through Saturday. Elevators must be padded for moving.
10. Residents must wear a cover-up when walking through the building. Bare feet are not permitted.

I agree to abide by all of the restrictions contained in the association Documents, Rules and Regulations and any restrictions that are or may in the future be imposed by Lido Surf & Sand Owners Association, Inc. In making this application, I am aware that the decision of the Lido Surf & Sand Owners Association, Inc. will be final and no reason will be given for any action taken by the Board of Directors. I agree to be governed by the determination of the Board of Directors.
