

30-YEAR ANNIVERSARY

The Coalition of City Neighborhood Associations (CCNA) was formed in 1990 to "preserve, protect and enhance city neighborhoods and to address the needs of neighborhoods and stand in support of those needs" and is now celebrating 30 years of successfully serving its mission for city neighborhoods through the dedication of member neighborhoods and their representatives.

Successes of CCNA in the first decade of the organization included: establishment of a City Neighborhood Services Department to provide support and assistance to city neighborhood associations; development of Neighborhood Action Strategies; amendment to the City Comprehensive Plan to include a Neighborhood Chapter; increased notification requirements to neighborhoods by developers for land use changes from 200 feet to 500 feet; and requirement for developers to meet with neighborhoods prior to submission of projects.

Successes of CCNA in the second decade included: a supermajority charter amendment for certain zoning decisions; campaign finance reform to limit campaign contributions and allow only individuals to contribute to campaigns; requirement for a second neighborhood meeting in the planning process if significant changes to a project occurred; defeat of 17th Street extension through neighborhoods; a megahouse ordinance with a 35 foot height limit on single family homes; an affordable housing Comprehensive Plan amendment; and hosted the Florida Neighborhoods Conference in Sarasota in 2007.

Successes of CCNA in the third decade included: support for Police Advisory panels; input to Duany Downtown Master Plan with particular regard to administrative approval component; support for neighborhood compatibility in planning process; involvement in zoning text amendments; opposition to proposed Walmart at Ringling Shopping Center; support of extension of the Legacy Trail; support of Bayfront Park development; support of extension of Downtown and Newtown CRAs; input on Lido Pavilion project; and input on Selby Gardens Master Plan.

CCNA has provided important input on discussions and decisions on neighborhood issues including: commercial intrusion, traffic, code compliance, historical designations, commercial vehicles, street maintenance, noise, street lighting, homelessness/vagrancy, preservation of parkland, affordable/workforce housing, tree mitigation, front-yard parking, flooding/stormwater problems, crime/safety, neighborhood police substations; and

Additionally, CCNA has been involved in community issues such as FDOT replacement of Ringling Bridge, Downtown Bus Transfer Station, Downtown Master Plan, consolidation of city /county fire departments, dual taxation, consolidation of city/county government, elected mayor, Payne Park development, Fruitville Road improvements, School Avenue zoning and street closure, Sarasota Memorial Hospital expansion, North Trail zoning, South Lido Beach improvements, Bay Estuary Program, Lift Station 7/87, Impervious Surface Overlay, New Beginnings in Newtown, Palm Avenue Parking Garage, parking meters, roundabouts. CCNA encouraged member associations to serve on city advisory boards, held important candidate forums for city commission elections and supported a number of members to become city commissioners; and

CCNA represents 31 active city neighborhoods, meets the first of each Saturday mornings of the month to continue address the interests and concerns of member neighborhood associations and has had for 30 years some of the most dedicated caregivers of this community determined to preserve, protect and enhance one of our most valuable resources – our neighborhoods.

Success in which CCNA played a significant role included:

- Increased notification to property owners within 200 feet to property owners within 500 feet of land use changes and requirement for developer to meet with neighborhoods.
- Establishment of Neighborhood Services Department
- Supermajority charter amendment for certain Comp Plan amendments
- Campaign finance reform to limit campaign contributions to \$200 to any one candidate and to allow only individuals to contribute to campaigns
- Zoning text amendment to require a second neighborhood workshop if any substantial change in the application occurs meeting in the planning process if significant changes to a project occurs
- Commission decision to prohibit 17th Street extension through neighborhoods
- "Mega house" ordinance with a 35 foot height limit on single family homes
- Comprehensive Plan amendments, including Neighborhood Chapter and attainable housing requirement
- Commercial vehicle ordinance for residential areas
- Florida Neighborhoods Conference June 2007 in Sarasota
- Establishment of a CCNA website
- Candidate Forums
