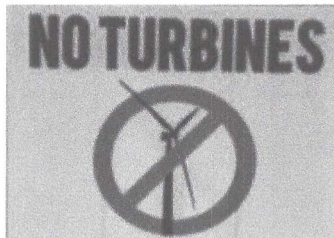


Who is Ingham County Citizens United

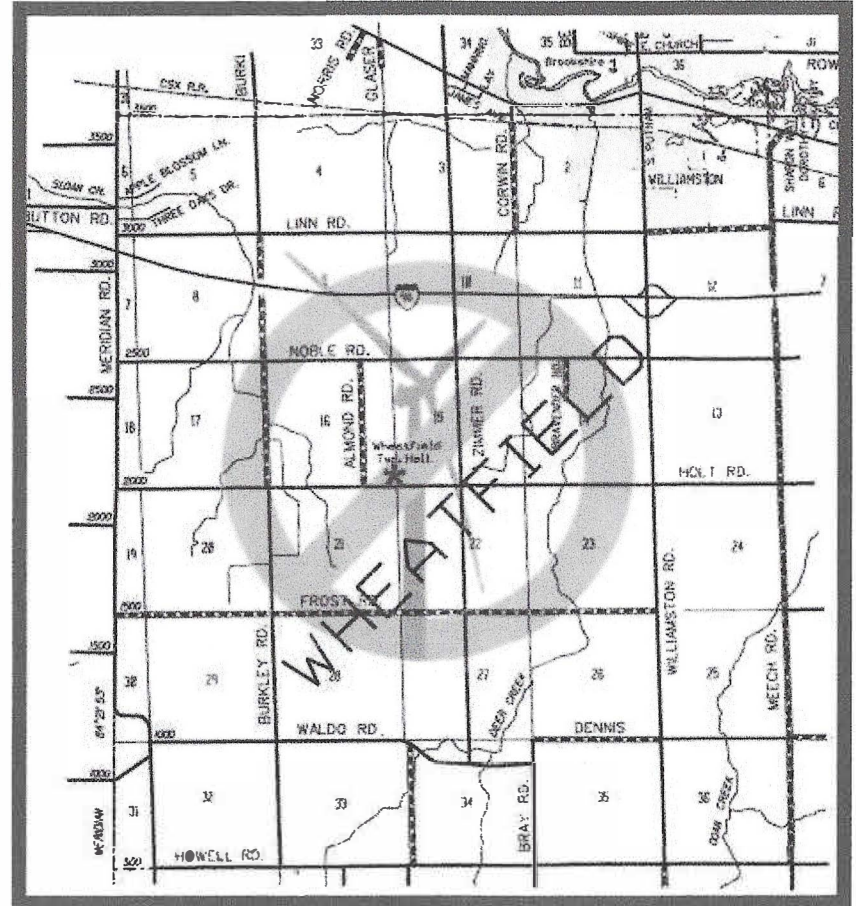

 - Being a good neighbor by assuring Wheatfield's ordinance is compatible with the adjoining townships
 - Ensuring that green energy does not harm our property values, protects wildlife, wetlands, and flood plains
 - Preventing a future tax burden for the township due to lack of safety measures, including destruction of roads during construction and loss of farmlands.

Your Country Neighbor's Call to Action



The Wheatfield Township Planning Commission is proposing to allow 500' turbines to the neighborhood.

Silence = Approval

The Wheatfield Township Planning Commission is working to bring 500' wind turbines to our township. Here is what has happened in other communities when wind farms are installed:

- **Reduction of property values by 35 %** and up to 14 miles away
- **Health issues** like sleep deprivation from audible and Inaudible vibration/pulsation or shadow flicker; **NOISE**
- Turbines **kill** bats and birds, especially hawks and eagles
- **Interference with** cellphones, televisions, **emergency radio** signals, emergency fights, and weather radars
- **Ruined roads** during construction that the **township will have to fix**
- Communities have had **significant tax burden** passed along to residents! Changes in tax laws favor the utilities and have **cost** local governments with wind farms **millions of dollars** in past and future revenues.
- **Safety issues with damage** from oil leaks, turbine fires, and **ice throws**
- Wheatfield's ordinance would allow 500 feet tall turbines in the area. This is 100 feet **MORE** than neighboring townships
- A 500' turbine is visible from over **25 miles away**
- Turbines are as loud as an air conditioner running **all.the.time.**
