For the protection of all parties' name in this contract, we, the seller, require that you, the buyer, have your puppy examined by a licensed veterinarian within 72 hours of purchase and strongly encourage you to do so. Failure to have the puppy examined within this time frame will void this guarantee and vaccinations given before the next due date. We are not responsible for any veterinary fees or medications. \_\_\_\_\_

If in the opinion of your veterinarian, the puppy has any physical problems, which makes it a poor health risk, we will provide you with a healthy replacement or refund. This replacement or refund will be determined by the seller. To qualify for said replacement or refund, you must return the puppy alive and the same condition when buyer received puppy. You, the Buyer, must also provide a signed statement from veterinarian showing date of examination, stating why puppy is a health risk, and describe symptoms supporting their finding/opinion. Under no circumstances may the puppy be euthanized without prior written consent of the seller. To do so cancels all guarantees. \_\_\_\_\_

If the puppy is returned to the seller, all registration and/or applications to register must be returned. The buyer will sign and all papers showing the ownership of the puppy have been return to the seller. \_\_\_\_\_

We will not guarantee against conditions brought on by stress and/or environmental changes that are beyond our control once the puppy leaves our care.
