H.R. 3584, the Veterans Cannabis Analysis, Research, and Effectiveness (CARE) Act

The Veterans Cannabis Analysis, Research, and Effectiveness (CARE) Act, would require the VA to conduct and support research on medicinal cannabis for treating veterans with PTSD, chronic pain, and other conditions. Our nation's veterans deserve access to the most effective treatments and therapies available, including alternative options available under the law. Therefore, it is imperative that Congress and VA support safe and effective innovations for the purpose of delivering new evidence-based treatments to improve veterans' health and quality of life.

DAV supports H.R. 3584, in accordance with DAV Resolution No. 203, which calls for comprehensive and scientifically rigorous research by the VA into the therapeutic benefits and risks of cannabis and cannabis-derived products as a possible treatment for service-connected disabled veterans suffering from PTSD and chronic pain.

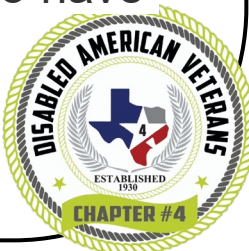
H.R. 3644, the Addressing Care Timelines (ACT) for Veterans Act

Currently, a veteran must contact the VA within 72 hours of receiving non-VA emergency care; otherwise VA may deny payment for these services even if the veteran is eligible for treatment. Veterans suffering medical emergencies should not have to worry about whether VA will deny coverage or refuse payment because of administrative notification time requirements.

H.R. 3644, the Addressing Care Timelines (ACT) for Veterans Act would provide an additional 24-hour period for veterans to inform the VA when receiving care at a non-VA facility under the Veterans Community Care Program.

DAV supports H.R. 3644, in accordance with DAV Resolution No. 205, which calls for the improvement of emergency care benefits for service-connected veterans: specifically, for VA to provide a more liberal interpretation of the law governing payment for emergency care and reimbursement to veterans who have received emergency care at non-VA facilities.

H.R. 3225, the Build, Utilize, Invest, Learn, and Deliver (BUILD) for Veterans Act

H.R. 3225, the BUILD for Veterans Act, aims to enhance the VA's capital asset program by improving planning and oversight, providing more consistent funding, and strengthening capabilities to start and complete projects to better serve veterans, their families, caregivers, and survivors.

In keeping with the support provided for the Senate version of this bill, S. 42, DAV also supports H.R. 3225, in accordance with DAV Resolution No. 247, calling for modernization of the VA's health care infrastructure to provide veterans with the quality care and benefits they deserve.



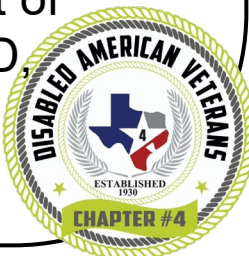

S. 1975, the Discharge Review Board Accountability Act of 2023

S. 1975, the Discharge Review Board Accountability Act, would require a study on the compliance of military discharge review boards to follow statutory requirements related to the application of “liberal consideration” during the decision process for certain conditions. Liberal consideration standards relate to a review of discharge status and requests for correction of military records based on mental health conditions to include post-traumatic stress disorder (PTSD), sexual assault or sexual harassment. The report must cover seven key areas in determining if discharge review boards are using the liberal consideration standards required in their decision-making process.

This legislation, S. 1975, is in accordance with DAV Resolution No. 113, which calls for a more liberal review of other than honorable (OTH) military discharges for the purpose of eligibility for Department of Veterans Affairs benefits and services in cases where veterans may have been suffering with PTSD, traumatic brain injury, or experienced military sexual trauma or harassment.
