*The information provided on the reverse side is subject to the following Terms and Conditions: "Owner" refers to the owner(s) of any boat, motor, trailer, PWC, etc.*

1. Owner authorizes the requested repair work to be done along with the necessary materials.
2. Thompson Marine employees may operate the boat, motor(s) and trailer on any waterway or elsewhere for the purpose of testing, inspecting, pick up or delivery at Owner risk.
3. An express mechanics lien is acknowledged on the boat/motor/trailer named on reverse to secure the amount of repair.
4. Thompson Marine will not be liable for any losses, damages or injuries due to theft, fire, vandalism, acts of god, or any other conditions beyond our control to the boat/motor/trailer and contents or any other Owner's property on marina premises.
5. Boats/motors/trailers not picked up within 10 days of the date of invoice will be subject to additional hauling and storage fees.
6. Thompson Marine has all the appropriate Maritime liens, either Federal or State, upon the boat, motor(s), and accessories, to secure any storage fees, repair, gas, oil, hardware, accessories, or other services or materials provided as part of the repair or supplied to the Owner for use on the boat/trailer.
7. Interest at the rate of 2% per month, accrued daily, will be charged on all past due accounts. Boats/motors/trailers or other property left on Thompson Marine premises for a period of 6 months without the payment of storage or repair bills will be considered abandoned, and seizure and sale procedures will be instituted under the laws of the State of New Jersey. All prices are subject to change without notice.
8. In addition to parts and labor, Thompson Marine includes a "Machine Shop/Disposal Fee" as part of the repair invoice. This fee is to help defray the cost of hardware or other materials, and disposal of same, which cannot be accurately itemized, which are used in the service and storage of your watercraft/trailer/motor(s). This fee varies depending on the size of the job, Minimum of \$35, Maximum of \$85 per invoice.
9. Payment is due upon receipt of the invoice. The watercraft/motor(s)/trailer shall not be removed from the marina until all charges are paid in full.
10. Thompson Marine uses typical marine hauling, blocking and trailering methods. Owner shall not hold Thompson Marine responsible for damage resulting from boat, PWC, etc being structurally unsound for these methods of handling.
