## POLICIES AND WAIVER FOR US OF VENDOR BOOTH SPACE

1. Registration will be accepted by mail, email at [bellflowercoc@gmail.com](mailto:bellflowercoc@gmail.com) or walk-ins at the Bellflower Chamber of Commerce office. All applications must be turned in with payment by Friday October 20<sup>th</sup>, 2023.
2. Exact location of vendor booth space will be made at the discretion of the Trick or Treat event Chairperson / Committee.
3. All vendor booth spaces are 10 X 10 in size. **All vendors must provide their own canopy, table and chairs. No exceptions.**
4. All items for sale or display must be listed on the application and will be subject to approval by the Bellflower Chamber of Commerce. This is a family event and all contents of your booth, including yourself and associates must be family appropriate. No alcohol may be brought to this event.
5. Please make checks or money orders payable to the Bellflower Chamber of Commerce. NO refunds will be given.
6. Applications are approved upon the condition that all rules and regulations established by the Bellflower Chamber of Commerce will be observed.
7. The Bellflower Chamber of Commerce reserves the right to approve those groups, individuals and items that are best suited for booth location and event.
8. Each permitted vendor booth group / business shall leave the booth and immediate area in a clean and orderly condition.
9. The permitted group / business shall accept full responsibility for the conduct of those in the group / business.
10. Alcohol is forbidden.
11. Pets are not allowed.
12. Permission to participate may be revoked for failure to observe the regulations, improper conduct, or when cancellation is necessary for other reasons.
13. The Trick or Treat event will be held rain or shine.

### **\*WAIVER, RELEASE, HOLD HARMLESS AND AGREEMENT NOT TO SUE**
