HOW WE PROTECT YOUR INFORMATION

HOW WE MAY SHARE YOUR INFORMATION

SOLID RADIO COMMUNICATIONS, subject to specific lawful exceptions, shall not disclose, release or sell to third parties any personal data or information given or transmitted through the Internet. This does not include trusted third parties who assist in operating the websites, conducting business as usual or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect our rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses relevant to the brand.

However, due to the nature of the Internet as an unsecured medium of communication, the company reserves the right to refrain from giving out an absolute guarantee that the privacy or confidentiality of the personal data or information given or transmitted by the user is free from any unfavourable instances that may occur. HOW LONG WE KEEP YOUR INFORMATION

SOLID RADIO COMMUNICATIONS guarantees that your personal data shall not be stored longer than is necessary for as long as the purpose for which it was collected, and other purposes that you may consent from time to time, remain in effect until it is no longer required or necessary.

Your information shall be kept by SOLID RADIO COMMUNICATIONS for the fulfilment of its obligations and compliance with legal, regulatory, and business requirements, or other standards set forth by a governing body.

YOUR DATA PRIVACY RIGHTS

As provided under the Data Privacy Act of 2012, Data Subjects have the following rights in connection with the Processing of their Personal Data:

- Right to Information: You have the right to be informed about the collection, processing, and disposal of your personal data.
- Right to Object: You have the right to object to the processing of your personal data by explicitly withdrawing your consent previously provided upon data collection.
- Right to Access: Upon demand, you have the right to reasonable access to the contents of your personal data.
- Right to Rectification: You have the right to dispute the inaccuracy or error in the personal data and have it immediately and accordingly corrected unless the request is vexatious or otherwise unreasonable.
- Right to Erasure or Blocking: Based on reasonable grounds, you have the right to suspend, withdraw or order the blocking, removal or destruction of your personal data from the SOLID RADIO COMMUNICATIONS system.
- Right to Damages: Subject to the results of verification of investigation, you may be indemnified for any damages sustained due to unauthorized use of your personal data.
- Right to Data Portability: You have the right to request from SOLID RADIO COMMUNICATIONS a copy of your personal data that is processed by electronic means in a structured or commonly used format.
- Right to File a Complaint: If you feel that your personal data has been misused, maliciously disclosed, or improperly disposed of, or that any of your data privacy rights have been violated, you have the right to file a complaint with SOLID RADIO COMMUNICATIONS at dataprivacy@solidradio.com.ph

USE OF COOKIES

Cookies consist of parcels of information, often including unique identifiers that are sent by web servers to web browsers.
