Disclaimer Section (Important Notes)

GACC provides	The Clubhouse for rental purposes as both the Clubhouse and Sunroom for use during your function, the tables and seating for 52 (including 3 pub tables, 3 square tables, 2 long rectangular tables, and matching chairs and pub chairs), the built-in marble top bar, kitchen area and ice machine behind the bar
Lessee responsibilities	All event setup, including arranging tables, chairs, linens, decorations, and providing their own dishes, cutlery, food, drinks, etc. If the renting member is absent for any portion of the duration of the rental including set-up and breakdown, the rental will be considered a non-member rental. In this instance, the member will be charged the full non-member rate plus a \$200.00 fine. The Lessee may designate other member(s) in good stead to be present in the event of an unexpected absence during the rental.
Parking	Lessee are reserved two (2) parking spaces in GACC's parking lot on West Napoleon Avenue. Additional parking is limited to other open spaces in GACC's parking lot on West Napoleon Avenue, the grass along Kent Avenue & Argonne Street and parking spaces available at Saints Community Church located at 2001 Transcontinental Drive, Metairie, LA 70001. Any vehicles found parking at any time on the grass/sidewalk/etc. along Transcontinental Avenue or in a non-designated area (ie. Grass/sidewalk in front of the clubhouse) be will be charged \$475.00
Cancellation	\$300 cancellation fee shall be assessed if the event is canceled less than fourteen (14) days of the event.
Damages	In the event that damages are incurred to the premises during the Clubhouse rental, GACC shall provide an assessment within five (5) business days with an invoice for any repairs, cleaning, etc. required. The Lessee shall have 15 business days from the date of the invoice to make payment.
Indemnification	The Lessee agrees to indemnify and hold harmless GACC from any and all claims, liabilities, damages, or expenses arising out of or related to the use of the premises.
Termination	GACC reserves the right to terminate this Agreement if the Lessee fails to comply with any of its terms and conditions. Any fees paid shall be non-refundable in the event of a termination due to breach of Agreement.
Governing Law	This Agreement shall be governed in accordance with the laws of the State of Louisiana.
Amendments	Any amendments to this Agreement must be made in writing and signed by both parties.

By signing this agreement below and only after confirmation by GACC Front Office of my reservation, I confirm that I understand that this Agreement constitutes the entire agreement between the parties and supersedes any prior agreements or understandings.
