The design and access statement contains some relevant information on the town park, but not enough for a comparison to the development brief. This information should be paramount for an **enabling** development for a town park. The development site covers OP2, OP6, R1 and P2 of the Kintore settlement plan in the 2023 LDP. The application is a revision of the refused APP/2020/1999. It has the same $120m^2$ grass square (2 football pitches), but centrally located, and with an adjoining playpark between the square and the woods. Area, incl. car park, stated to be 3.54ha, not the required 3.8ha. Is this correct? No SuDS are included in the park area. The pavilion seems to be the same inadequate council-designed structure as before, so parking space might be reduced with container storage. The Appeal Reporter's decision should be referenced.

The town park has poor connectivity. Car access is via the proposed new roundabout. Pedestrian access from town centre through the new housing seems to be very restricted. Pedestrian access to Tuach Hill to the east and the Tuach burn to the south are via pavements on a road on the estate.

Long discussion about the good and bad on the new plans, pavilion suitability, use of green space = possible options, parking accessible housing. The outcome was to submit an objection to the current proposal.

APP/2023/1017 Section 36 Consultation for 300MW battery energy storage system. Site south of Midmill Business Park Kintore. Application for a nationally significant development. Consultation response by June 26. Public comment by June 18. Government consent will allow the 300MW battery development to go ahead, subject to Ofgem licence approval: an electricity generation licence under section 6(1)(a) of the Electricity Act 1989 authorising it to generate electricity. Licence condition E1 requires accurate information regarding their electricity storage facility to relevant suppliers. However the consent process



only requires a design envelope to be submitted rather that design details – the drawings are "indicative"

The February "public participation" event was sparsely attended. OP4 Midmill Business Park site has an Allocation of 20ha employment land. This development doesn't provide any permanent employment.

The battery storage could be located anywhere in the NE Scotland to connect to the national grid. Why Kintore?

APP/2023/1015 Alterations and dormer extension to dwellinghouse. Leylodge Schoolhouse AB51 0YB – no comments

APP/2023/0990 Alterations and extension to dwellinghouse. 1 Castle Road Kintore AB51 0WN – no comments

c) Approved but note conditions

APP/2023/0581 Formation of Football Pitch, Car Parking and Vehicular Access Without Compliance with Condition 3 (Alteration to Ground Levels) of Planning Permission Reference APP/2018/3077 Land Adjacent To Bridgefield Kintore Aberdeenshire AB51 0XB. A s.42 application to vary the oringal conditions. SEPA statement:

- 1. Flood Risk 1.1 This application is to vary the condition for APP/2018/3077 which required the football pitches to be lowered to restore the functional floodplain capacity at the site. We are of the opinion that this work must still be carried out, however, we have no objection to the proposed amendment to Condition 3 given the reasoning provided within the statement. The amendment is for an extension of time to allow a further 3 years from determination of this application for the works to be completed and for the ground levels to be lowered a further 0.3m from those previously agreed to ensure Condition 1 of APP/2020/2317 on the adjacent site can be met.
- 1.2 No other development under APP/2020/2317 can be undertaken in advance of the ground lowering works under this application but should it be decided that the proposed development under APP/2020/2317 is not to be taken forward then the lowering works would still be required within this 3-year period, although at that point the levels could be in accordance with the previous condition.
