These Trials will be held indoors in the *main Coliseum building*. *There will be ample room for crating inside the Coliseum*. Exhibitors are encouraged to bring their own chairs. The Coliseum is climate controlled and has indoor restrooms. This is located right across the driveway to the north of the Judging Arena, where Trials have been held in previous years. As you enter the Coliseum grounds from Boone St., the main Coliseum building is on the left (the Judging Arena is on the right). Any additional updated instructions will be provided in the Judging Program.

There will be two rings and, as stated on page 6 of the Premium List, both rings will be fully matted and 40' x 50' in size.

EL PASO COUNTY COLISEUM JUDGING ARENA

These Trials will be held in the indoor Judging Arena for protection from possible high winds that are common in April. Rio Grande Obedience Dog Club asks exhibitors to observe CDC guidelines at the time of the Trials. Crating in the building will be limited, with priority given to Trial Committee members and to those who volunteer to steward (see page 4). There will be covered parking spots for crating from vehicles available in the Pig Barn immediately to the east of the arena.

THE JUDGING ARENA HAS EVAPORATIVE COOLING, WHICH WILL BE TURNED ON IF REQUIRED.

Hospitality for exhibitors at the Trials will be limited. Coffee and hot water for tea, as well as creamer, sugar, sweetener, and a few sweets will be available. There will be no concessions at the site. Plan to bring your own beverages and snacks, and possibly your lunch. There are a few fast-food options within 1.5 miles of the Coliseum. Boxed lunches will be available for the Trial Committee and those who volunteer to steward.

On all three days of the Obedience Trials, Beginner Novice A and B will be scheduled to precede Novice A and B, Graduate Novice will be scheduled to precede Open A and B, and Graduate Open will be scheduled to precede Utility A and B.

At the August 2022 meeting, the AKC Board voted to make the following COVID provisions permanent:

Qualifying Scores for Obedience & Rally Titles:

- In all Obedience and Rally classes that require three qualifying scores to earn a title, the three scores may be earned under the same judge.

Assignment Limitations:

- There are no mileage restrictions for judging Obedience or Rally trials.
- There are no restrictions on the number of times an individual judge can judge a class at Obedience or Rally trials in a cluster.

ROSETTES/RIBBONS FOR OBEDIENCE AND RALLY

Rosettes/Ribbons on all days of the trials will be sponsored from the Rio Grande Obedience Dog Club Trophy Fund. Donors to the Trophy Fund will be listed in the catalog.

Green ribbons will be awarded for all qualifying scores in the regular classes. Ribbons for the four highest scoring dogs in each class will be awarded for qualifying scores.

NOTICE TO EXHIBITORS

THE RIO GRANDE OBEDIENCE DOG CLUB, INC. may decline any entry for cause or may remove any dog on account of sickness or other cause and no one shall have any claim or recourse against the Club or any official thereof.

ENTRY FEES WILL NOT BE REFUNDED in the event of (1) errors or cancellation of entries after the published closing date, (2) the dog being absent, (3) the dog being disqualified, excused by Veterinarian or Judge, or barred from competition by the Event Committee, (4) having been entered incorrectly. **A refund will be provided if a bitch comes into season. Please inform the Trial Secretary as early as possible if your bitch has come into season and you would like a refund.**

RETURNED CHECKS do not constitute a valid entry fee. The Rio Grande Obedience Dog Club, Inc. will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in his or her being put on a CASH ONLY basis.

NO ENTRY FEES will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the Club.

ALL ENTRIES are to be mailed with Fees to the Trial Secretary, Julie Rutledge, 2734 Silver Ave, El Paso, TX 79930-3016. Entries will not be accepted without fees. Acknowledgment of entries will be made as soon as practicable. Should such acknowledgment not be received by the exhibitor within a reasonable time please contact the Trial Secretary.

ACKNOWLEDGEMENT OF ENTRY RECEIVED will be sent to the email address listed on the entry form, provided that said address is legible. All final confirmations and Judging Programs will also be sent via email. PLEASE TYPE OR PRINT ENTRY FORM CLEARLY to avoid error.

DOGS MUST BE READY FOR JUDGING. The club and its committees will not be responsible for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of the dogs in the ring. Dogs need to be at the trial only at scheduled time of judging and may leave immediately thereafter unless required for further judging.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free from internal and external parasites, any communicable diseases, and have appropriate vaccinations. **EXHIBITORS ARE ADVISED TO BRING THEIR DOG'S LICENSE TAGS AND PROOF OF RABIES VACCINATION WITH THEM TO BE IN COMPLIANCE WITH EL PASO CITY ORDINANCES.**

ALL DOGS MUST be kept on leash when not crated or in exercise pens or in the ring.

EXHIBITORS are expected to keep crating and exercising areas clean.

ANY AND ALL DAMAGE caused by the exhibitor will be the sole responsibility of the exhibitor. Parents or guardians will be totally responsible for the actions and safety of their children.

Rio Grande Obedience Dog Club, Inc., will not be responsible for the loss of or damage to any dog from any cause, or for the damage caused by any dog. Every dog at this show is in the care, custody, and control of the handler or owner at all times. Rio Grande Obedience Dog Club, Inc., assumes no responsibility for any damage to property or injury to children.

The request for a transfer must be made in writing to the Trial Secretary at least 30 minutes prior to the start of each trial; **requests submitted prior to the date of the trial will be accepted.** Transfers from "A" to "B" class at the same level are allowed. Transfers will be approved provided the class is scheduled and the judge is available.

UPDATED DIRECTIONS TO THE COUNTY COLISEUM WILL BE GIVEN IN THE JUDGING PROGRAM.

The El Paso County Coliseum is across E Paisano Drive from the El Paso Zoo (south of the Zoo). It is located immediately to the southeast of the IH-10 / US-54 interchange. Entrance to the Judging Arena is on the west side of the Coliseum off of Boone St. As you enter the Coliseum grounds from Boone St., the Judging Arena is to the right. The covered parking in the Pig Barn is just east of the Judging Arena.

FROM EAST OR WEST IH-10: Take Exit 23B Paisano Dr. Turn south onto E Paisano Dr. At the first traffic circle, take the first exit and stay on E Paisano Dr. At the second traffic circle, take the second exit and stay on E Paisano Dr. Follow E Paisano Dr to the intersection with Boone St. (about 1 mile, traffic light). Turn left onto Boone St. and then turn left into the Coliseum grounds.

FROM THE NORTH ON US-54: Go south on US-54 W and take Paisano Dr Exit 20A (past the IH-10 interchange). At the traffic light, use the middle lane to turn left onto US-62 E / E Paisano Dr. A block down, turn right at the traffic light onto Boone St. and then turn left into the Coliseum grounds.
