They will turn our Christmas trees into mulch to be used on Koko Isle. All decorations & ornaments must be **<u>REMOVED</u>** from your Christmas tree, if not your tree will not be picked up. COMMUNITY ADVISORY:

The Koko Isle Bridge Is Safe and Overall, in Satisfactory Condition:

Below is an excerpt from the Koko Isle Bridge Assessment Report summary completed by WJE Engineering, Inc.

"Based on our observations and assessment findings, the Koko Isle Bridge is in an overall satisfactory condition for its age and service environment. The bridge deck is in satisfactory condition and has some concrete deterioration generally concentrated in the soffit at the west end of the deck and between the abutment back wall and diaphragm at the east end. Waterproofing systems and/or cathodic protection

systems could be used to reduce the deck deterioration. Given the good condition of the girders, deck replacement is most effective method to extend the bridge service life. The girders are in good condition with minimal chloride contamination and carbonation of the concrete detected. The abutments are in satisfactory condition with some concrete spalls occurring below the girders. The railings are in poor condition and require extensive repairs. Due to the extent of repairs required, in our opinion, replacement of the railings is a better long-term solution."

The Koko Isle Board is currently working with WJE Engineering, Inc. to develop a comprehensive multi-year maintenance plan aimed at preserving the bridge's overall integrity. Depending on the prioritization of various maintenance needs, it is possible that the railings, although unsightly, may not be the first item prioritized for repair.

Holiday Decorations: On April 29, 2024, the board approved to extend approved times for holiday decorations from Thanksgiving to January 10, 2025. The approved changes have yet to be codified in the house rules, but the board voted for a temporary/interim change for this year and will follow through with the formal amendment process to be effective next year.

NO Fireworks on Koko Isle - Including Bridge Entrance and On Docks:

House Rules: USE OF PREMISES - Page 31, par.14. The use of any type of fireworks, including sparklers, is prohibited. An immediate fine may be imposed for each instance of using fireworks and the Association may seek the eviction of the people responsible if they are tenants. Please observe our holiday rules so that all residents may have a happy, safe, and peaceful Holiday Season.

Note: Last year we received reports of Koko Isle residents launching fireworks from waterside docks, which is also prohibited. Please continue to report violations and appropriate action will be taken which could include fines of up to \$500.

Operating, flying, or landing drones is prohibited on Koko Isle. House Rules: Page 32. 18) Operating, flying or landing drones or other similar

devices from or in the common or limited common element is prohibited.

3. **Holiday Guest Parking:** To help ease the burden for guest parking over the Holidays, the Board approved tandem parking for these dates only.

Christmas Eve & Day: December 24th & 25th, 2024 New Year's Eve & Day: December 31st, 2024 & January 1st, 2025

Tandem parking will be allowed in front of your unit, as long as you **DO NOT BLOCK** your neighbors, ensuring that they have direct means of access and egress to their units.

No Parking on the bridge: "Cars will be towed" No Parking on the grass: "Cars will be towed" No Parking in "RESERVED" stalls: "Cars will be towed" Last Year's Boat Parade, 5 cars were towed from around Koko Isle and the bridge.

The number to our tow company is Tow Jams/VIP Towing (808) 593-1993. Please direct all guests to park across the bridge on public street parking and walk in if there is no available guest parking. The Tow Company will be "On Call" and patrolling Koko Isle.

Unauthorized Bulk Item Dumping caught on Camera!

Koko Isle received 2 unauthorized Bulk Item charges last month. The owner responsible was charged for the additional bulk fees.

NO Dumping your personal or bulk items in the Koko Isle dumpsters located in the Club House parking area. It is a violation of the Koko Isle House Rules to place refuse or any bulk items into the Association dumpsters. The current City & County and House Rules direct you to use Opala.org to schedule bulk item pickup.

Honolulu Disposal trucks photograph the bulk items in the dumpsters and Koko Isle is charged for unauthorized bulk items.

Please note that once Koko Isle is billed the bulk item charges, those charges are passed to the resident responsible for the violations with a possible \$250 fine.



<u>Reminder: Refuse Pick-Up</u> – Friendly Reminder, trash containers should not be placed on the roads until the morning of trash pick-up and for sure no earlier than the night before.

House Rules Page 26 REFUSE PICKUP:

- 1. Unit refuse shall be placed in the City and County containers assigned to each unit and must be kept in the back part of the carport area.
- 2. No unit refuse shall be placed outside of a unit except within said container, which shall not befilled beyond its capacity.
- 3. The unit container shall not be placed on the common elements except on the morning of a pickup day, and the unit container shall be removed from the common elements by dusk of the same day unless otherwise determined by the Resident Manager.
