Reminder Koko Isle 2024 AOAO Annual Meeting:

The Annual Koko Isle Homeowners Meeting is scheduled for Monday March 25th, 2024, *Registration begins at 5:30pm and 6:00pm meeting call to order.* Three Board positions will expire. Proxies must be turned no later than 4:30pm on March 20th, 2024.

Reminder "Proposed Amendment to Restated Declaration - Transient / Hotel Use of Units":

On February 1st, 2024, Hawaiiana Management Company, distributed a written consent form on the "Proposed Amendment to Restated Declaration – Transient / Hotel Use of Units". Please submit your written consent form indicating your vote by March 15th, 2024. 67% of the common interest must vote in favor of the amendment for it to be adopted.

<u>Urgent Dog Waste Help:</u> Attention all dog owners! We have about 53 dogs residing on Koko Isle. We need each and every dog owner to help police dog waste presence, a major nuisance and health hazard!

We need your help with these issues:

We have regular reports of dog waste NOT PICKED UP. Please pick up your dog's waste and dispose of it properly into waste receptacles or your own gray trash bin. Please DO NOT use neighbor's trash bins for your dog's waste. Please report anyone not picking up their dog's waste to the Resident Manager. There is a \$100 fine for not picking up dog's waste.



- When disposing of your dog's waste, please tie the bags closed before disposing into trash bins to help reduce fly infestation.
- We need help with the Center Park Dog Waste Trash Bin. It appears someone is cutting or breaking the cover tie-downs allowing the trash bin to remain open. Please report any suspicious activity around the Center Park Dog Waste Bin.
- As an update, to help reduce fly infestation, the Center Park Dog Waste Trash Bin is scheduled to be removed and dog owners can dispose of dog waste in the dumpster area by the Club House or in your own gray trash bin. A low easy access "Dog Waste" portal is there to assist.
- We have regular reports of residents letting their dogs out of their units unleased to do their business. Please note, pets are not allowed anytime to roam freely unleashed.

We are reaching out to all dog owners to help self-police this dog waste problem to protect the health of our neighborhood and to help reduce the fly infestation challenges.

Reminder: Unauthorized Bulk Item Dumping caught on Camera!

Koko Isle received 3 Unauthorized Bulk Item Charges this month.

NO Dumping your personal or bulk items in the Koko Isle dumpsters located in the Club House parking area.

It is a violation of the Koko Isle House Rules to place refuse or any bulk items into the Association dumpsters. The current City & County and House Rules direct you to use Opala.org to schedule bulk item pickup.

Honolulu Disposal Services report that Honolulu Disposal trucks photograph the bulk items in the dumpsters and Koko Isle is charged extra for unauthorized bulk items.

Please note that once Koko Isle is billed the extra bulk item charges, those charges are passed to the resident responsible for the violations along with a \$250 fine.

Non-Waterfront Dock Committee Update: The Non-Waterfront Dock Project is still under construction, installing 6 of the approved 8-dock plan for 12 residents! Construction affects Units 111 through Units 301, and the Waterfront Park has limited access. Concrete is scheduled to be poured Thursday Feb. 29^{th,} 2024. Units 111- 119 will experience parking disruptions and guest parking in the 100 block will be restricted so cement trucks can enter and maneuver for pouring.
