Halloween Guidance 2020

HALLOWEEN 2020: COVID BOO's and DON'Ts

YES

SAFEST ACTIVITY:
Celebrate at home with your household.

SAFE ACTIVITIES:

- Drive-in movie (one household per car)
- Drive- or walk-thru haunted house
- Drive- or walk-by holiday displays
- Decorated car parade (one household per car)

YES, but...

TAKE EXTRA SAFETY PRECAUTIONS

These activities can be done safely with extra safety precautions. Please scroll to read the requirements for each activity.

MODERATELY SAFE ACTIVITIES:

- Trick-or-treating door-to-door (contact-less)
- Drive-thru, contact-less trunk-or-treating
- Physically distanced neighborhood costume parade

NO

THESE ACTIVITIES CANNOT BE HELD THIS YEAR

Avoid the activities below as they are not safe or legal under the current emergency order.

UNSAFE ACTIVITIES:

- Large events or parties
- Non-drive-thru trunk-or-treat
- In-door haunted houses

Please note, physical distancing, mask wearing, and gathering requirements (groups of no more than 5) apply for all Halloween activities.

1. **What activities can my family take part in this Halloween?** This Halloween, please only participate in activities where your family can safely maintain physical distancing from other groups and families. The safest option is to celebrate the holiday with your family at home. Some ideas include a scary movie night, a zoom costume party, or setting up a spooky display in your front yard for your neighbors to enjoy. If you do go out, please read the FAQs below for requirements for each activity.
2. **Can I take my keiki trick-or-treating this Halloween?** Yes, but please you must keep your trick-or-treating group to a maximum of five individuals. This includes parents and young children. If you go with another family, physical distancing must be maintained.
3. **Can I take my keiki to a trunk-or-treat event?** Drive-thru, contact-less trunk-or-treat events are allowed. Each car should have members of the same household only as physical distancing cannot be maintained in a passenger car. All volunteers, staff, or other assisting in the trunk-or-treat must

be in groups of no more than five individuals. Non-drive-thru trunk-or-treat events are NOT allowed.

4. **Can I take my keiki to a drive-in movie or drive-thru haunted house or other drive-in/thru Halloween display?** Yes! Drive-in/drive-thru events are a good option for celebrating this Halloween. Each car should have members of the same household only as physical distancing cannot be maintained in a passenger car. All volunteers, staff, or other assisting in the celebration must be in groups of no more than five individuals. Non-drive-thru Halloween events are NOT allowed.
5. **Can my neighbors or family participate in a costume walk or decorated car drive-by?** Yes, your neighborhood can host a physically distanced costume walk for keiki. All participants must be in groups of five or fewer and physical distancing must be maintained. For events where participants are in vehicles, each car should have members of the same household only as physical distancing cannot be maintained in a passenger car.
6. **Can I host or participate in a Halloween party or haunted house?** No, gatherings and parties are not allowed at this time. All large group events must be conducted virtually.
7. **Does my Halloween costume mask count as a “face covering”?** Not necessarily, only if your mask can meet all the criteria for a face covering under Order 5 of the Emergency Order would it count as a “face covering”.
