Use of Common Areas

There seems to be some confusion regarding owners use of Common Areas. namely our two parks, the Waterfront and Central Park. Chapter "D" in the House Rules, item #15, outlines that these common areas are to be used for the purpose for which they were designed/built. More specifically, resident and/or private owner's events or activities are limited to the respective areas of the individual units and not allowed in any of the Common Areas.

The Clubhouse facilities, which can be reserved at no cost, are designated for your private recreational purposes, events, and activities.

Quiet Enjoyment

This is probably a good time to bring up Chapter E, items #1-6 House Rules. in Basically, we all live in a community that outlines what is acceptable behavior and/or conduct with respect to Quiet Enjoyment. Every owner who has purchased a unit on Koko Isle has agreed to read, then follow, the rules of the community. Koko Isle is not unique. All condominium communities have governing rules and regulations. So, when the Resident Manager, who is an of the agent Board. enforces the House Rules or of the anv aovernina documents, and points out violations, he is doing so at the behest of the Board. As an owner, if you disagree with any of the rules, you are entitled to write a letter of appeal to the describing Board, your objection(s). Don't blame the Manager - he is only doing his job as outlined in his job description that was written by the Board.

Excessive Speeding

As long as we are on the subject of rules, it is appropriate to remind residents of the posted 15 MPH speed limit on Koko Isle.

Since there are no sidewalks on our island, anyone out walking has no choice but to use the street for getting from one place to another. This is especially true for young children who walk on the roadway without realizing the potential dangers of a speeding truck, car or scooter. This is a prescription for a horrible tragedy. Residents are asked to give yourself additional time so you don't have to speed both onto and off our small island. The extra seconds it takes to respect the posted speed limit will not be noticed at the end of your journey, no matter how far you are going, and certainly is not worth the lifetime of heartache if someone's child is injured or killed. It would be unguestionable lifean altering event for both the victim and you.
