LOCATION: Held at **TWIN ELM GUEST RANCH, 810 FM 470, BANDERA** along the Medina River.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works.

No manufactured, imported or resale items will be allowed in the **Arts and Craft area** – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. Bandera Business Association(BBA) reserves the right to reject any display that is not in keeping with the examples submitted.

Commercial vendors are will be assigned spaces in the commercial area.

NO CITY PERMITS REQUIRED!
THIS VENUE IS OUTSIDE OF BANDERA CITY LIMITS.

REGISTRATION: Our registration fee is **\$60 per space** for the one-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photographs sent to the event coordinator by e-mail or a link to your web site that shows photos of your work, and **a check or money order payable to Bandera Business Association.**

Your check will not be cashed until you have been accepted into the show. **Deadline for received application is June 15, 2021.**

SPACES: Open spaces *only* are **10'x10'**. You provide your own canopy, and set up. **There will be a limited number of spaces available.** Electricity is limited, and will only be available only to those **demonstrating** an art or craft.

NOTIFICATION OF ACCEPTANCE: Artists will be **notified of acceptance** no later than **June 17, 2021** by Email or phone. You will receive an **information packet** by email no later than **June 23, 2021.**

There will be no refunds after June 17, 2021 and no refunds should bad weather occur.
