City Vendor Permit Requirement

The City of Bandera requires **ALL VENDORS** to obtain a permit through the City Hall. There is a separate application and fee due <u>before 5:00 pm the Wednesday before the event.</u> If this deadline is missed, there is a \$50.00 late charge to obtain a permit.

Vendors MUST pre-register and pre-pay to participate.

\$40 for a 10x10 OR if you reserve for 2 or more months and pay in advance: \$35/month ~Market Day hours: 9:00am – 4:00pm (Set up as early as 7:00am)~ Make checks payable to the Bandera Business Association.

Your check will not be cashed until you are accepted into the show. Notification will be by phone or email. Open spaces only. You provide your own canopy, tables, chairs, etc.

All registration forms must be accompanied by photos or e-mailed photos, or a web address with photos. Note: The photo requirement is waived if you are a returning vendor or have previously submitted photos of your work to Bandera Market Days.

Deadline for <u>received</u> BBA applications is the Wednesday prior to the scheduled Saturday event.
