The City of Bandera requires **ALL VENDORS** to obtain a permit through the City Hall. There is a **separate application and fee** due **before 5:00 pm, Wednesday 7-20-2022**. If this deadline is missed, there is a **\$50.00 late charge** to obtain a permit.
