Vendor Eligibility

Open to individual artists and crafters presenting original works and to farmers selling produce, canned goods and baked good. Non-profit organization may sell baked goods or items being sold to raise money for their organization. This show may be juried to maintain balance and variety. A limited number of resale and commercial items of the highest quality may be accepted. Bandera Business Association reserves the right to reject any display that is not in keeping with the examples submitted.

City Vendor Permit Requirement

The **City of Bandera** requires **ALL VENDORS** to obtain a permit through the City Hall. There is a **separate application and fee** due **before 5:00 pm the Wednesday before the event.** If this deadline is missed, there is a **\$50.00 late charge** to obtain a permit.

BBA Requirements

Vendors MUST pre-register and pre-pay to participate.

\$40 for a 10x10 **OR** if you reserve for **2 or more** months and pay in advance: **\$35/month**

~ Market Day hours: **9:00am – 4:00pm** (Set up as early as 7:00am) ~

Make checks payable to the **Bandera Business Association**.

Your check will not be cashed until you are accepted into the show. Notification will be by phone or email.

Open spaces only. You provide your own canopy, tables, chairs, etc.

All registration forms must be accompanied by photos or e-mailed photos, or a web address with photos. *Note: The photo requirement is waived if you are a returning vendor or have previously submitted photos of your work to Bandera Market Days.*

Deadline for received BBA applications is the Tuesday prior to the scheduled Saturday event.
