LOCATION: Held at **BANDERA CITY PARK, 102 MAPLE ST, BANDERA, TX 78003** along the Medina River.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed in the **Arts and Craft area** – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. Bandera Business Association(BBA) reserves the right to reject any display that is not in keeping with the examples submitted. **Commercial vendors will be assigned spaces in the "Commercial" area.**

CITY PERMITS ARE REQUIRED! WE WILL PAY THE \$15 FOR YOU

THIS VENUE IS INSIDE THE BANDERA CITY LIMITS.

IF YOU HAVE CURRENT DOCUMENTS ON FILE WITH THE CITY, NEW COPIES ARE NOT REQUIRED.

IF YOU ARE NEW TO BANDERA CITY VENDOR EVENTS, OR YOUR DOCUMENTS ARE EXPIRED, YOU MUST COMPLETE THE CITY APPLICATIONS, PLUS PROVIDE ALL SUPPORTING DOCUMENTS.

REGISTRATION: Our registration fee is **\$65 per space** for the one-day show. This includes the \$15 CITY FEE!

There will be no price limit on your items sold and no commission will be taken. Unless you have already set up in Bandera with the BBA, ALL registration forms must be accompanied by photographs, sent to the Event Coordinator by e-mail **OR** a link to your website that shows photos of your work, and a **check or money order payable to Bandera Business Association.**

Your check will not be cashed until after you have been accepted into the show.

Deadline for received applications + payment is APRIL 17, 2023. No exceptions.

SPACES: Open spaces are **10'x10'**. You provide your own canopy, and set up.

There will be a limited number of spaces available. Electricity is very limited.

NOTIFICATION OF ACCEPTANCE:

Artists will be **notified of acceptance** no later than **APRIL 21st** by Email or phone.

You will receive an **information packet** by email no later than **APRIL 25th.**

There will be no refunds after APRIL 21st, and NO refunds should bad weather occur.
