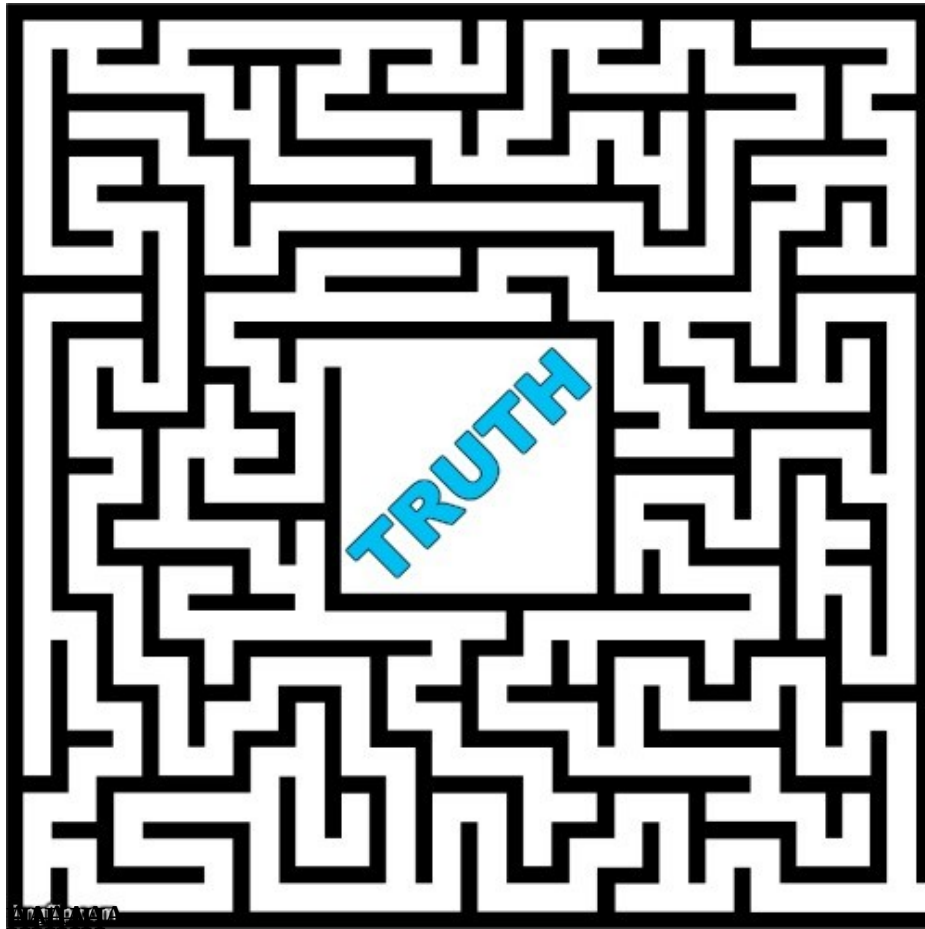

#### **“Government.”**

The etymology of the word “government” originates from ancient Latin.

The first half of the word, “Govern,” comes from “*gubernare*,” meaning “to control.”

The second half, “ment,” comes from “*mens* or *mentis*,” meaning “mind”.

So “government” means “TO CONTROL THE MIND.”

#### **Coercion is the central principle of all “government.”**

People have been trying for over a century to guide us toward living consciously to be able to see the encroachment and build up of tyrannical, fascist control taking great strides as of 2020. As astonishing as it is to those living consciously, many of the unconscious masses are blind to the dire circumstances that are our reality. They look no deeper than the surface, believing it to be without depth, programmed as they are to take part in their own enslavement (“We’re in this together!”). The consciously living have had bullhorns in hand shouting from proverbial rooftops (and often actual rooftops) passionate warnings of communist practices too many believe are for the “good of community.”

President Eisenhower himself alerted Americans to a grave situation with his farewell speech in 1961:

***“In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military-industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.” And: “The prospect of domination of the nation's scholars by Federal employment, project allocations, and the power of money is ever present and is gravely to be regarded.”***

Famously, President John F. Kennedy also warned us:

***“For we are opposed around the world by a monolithic and ruthless conspiracy that relies on covert means for expanding its sphere of influence—on infiltration instead of invasion, on subversion instead of elections, on intimidation instead of free choice, on guerrillas by night instead of armies by day. It is a system which has conscripted vast human and material resources into the building of a tightly knit, highly efficient machine that combines military, diplomatic, intelligence, economic, scientific and political operations. Its preparations are concealed, not published. Its mistakes are buried not headlined. Its dissenters are silenced, not praised. No expenditure is questioned, no rumor is printed, no secret is revealed.”***

From “A Special Report on the National Emergency in the United States of America”:

“There IS a national emergency today—one of life and death proportions—but it is NOT the emergency used by our government to continue its abuse of power. It IS this very abuse, this unbridled rape of the American spirit, that is the crux of the emergency we are in today, the cause of all the loss of hope, drug and alcohol addiction, irresponsibility in morality and ethics, lack of respect for life, and violence. But this true emergency cannot be cured by setting aside the Constitution; no, it can only be controlled by returning to the laws of God and Country which have been stolen from us by those in whom we placed our trust to protect the national interest.” [...] “Actions speak louder than words, and the actions taken over the past decades have resulted in the unparalleled decline of American economic and political power, and a weakening of American values and spirit.” [...] “That a state of emergency exists cannot be disputed. People resist Truth because it threatens to change their world view. This is a psychological condition called Cognitive Dissonance, which brings mental anguish and discomfort from viewpoints discordant with your own. People do not want to feel this uncomfortable “pain” so they shut down Truth without understanding it was the Truth, and instead opt to hold mere beliefs because it is comforting and it is “what they know” and it is what the majority of people in their lives also believe.

In addition to Cognitive Dissonance undermining our quest for Truth, the ego can also be injurious to us and our familial relationships. Most people on this planet who shun Truth are experiencing the same things. At one point or another we have all supported our own enslavement and enabled crimes against humanity, all by simply ignoring Truth.

## ~~~ Enemies & Emergencies ~~~

***“To ask the right question is already half the solution of a problem.” — C. G. Jung***

Let's begin with a question. But before it is asked, and before you shape your response, bear in mind these two FACTS:

- 1) The Federal Reserve is a private bank, not a “government” institution. They create all “money” in existence that is no longer backed by gold, printing it off machines and loaning it to the “government” with interest. (This is where the National Debt comes from.)
- 2) Under the Constitution for the united states of America, the “government” can coin its own money (i.e., print its own money) WITHOUT any debt burdening future generations of Americans.

THE QUESTION: Considering the above indisputable FACTS, WHY then is the U.S. “government” BORROWING money from a private bank and accruing (to date) over 26 TRILLION dollars in debt which future generations of men, women and children (and their grandchildren's grandchildren's grandchildren) are burdened with repaying?

The Truth is that the entity they borrow the “money” from (the Federal Reserve) is owned by a handful of psychopathic international banking families who actually own the “government” and dictate its policies. Plans for the Federal Reserve bank got its foothold in November of 1910, when seven men secretly met at the Jekyll Island Club off the coast of Georgia with the intention of reforming the nation's banking system. These men represented the biggest banks in the US:

**Nelson W. Aldrich, father-in-law to John D. Rockefeller**  
**Henry P. Davison, Sr. partner of J.P Morgan Company**  
**A. Platt Andrew, Assistant Secretary of the Treasury**  
**Benjamin Strong, head of J.P Morgan Bankers Trust Company**  
**Paul M. Warburg, representing the Rothschilds and Warburgs**  
**Charles D. Norton, Pres. of 1st National Bank of New York**  
**Frank A. Vanderlip, representing William Rockefeller**

They created the Federal Reserve banking system and their secret meeting never came to light until 1930. Interestingly, three extremely wealthy men opposed the creation of the Federal Reserve. They were John Jacob Astor, Benjamin Guggenheim and Isador Strauss. It's possible they could have done great damage to its creation, perhaps even stopped it with their wealth and influence. Unfortunately, all three of them died April 15, 1912. On the Titanic.

***“Capital must protect itself in every possible manner by combination and legislation. Debts must be collected, bonds and mortgages must be foreclosed as rapidly as possible. When, through a process of law, the common people lose their homes they will become more docile and more easily governed through the influence of the strong arm of government, applied by a central power of wealth under control of leading financiers. This truth is well known among our principal men now engaged in forming an imperialism of Capital to govern the world. By dividing the voters through the political party system, we can get them to expend their energies in fighting over questions of no importance. Thus by discreet action we can secure for ourselves what has been so well planned and so successfully accomplished.”*** — Montagu Norman, governor of the Bank of England, 1920 – 1944 Reprinted in the Idaho Leader, USA, on August 26, 1924 and read twice into the Australian Federal Hansard by John Evans MP in 1926, and by MD Cowan MP, in the 1930 – 1931 session.

No matter what so-called “president” is at the helm of “government,” he is merely taking orders and must do as he is told.

***“The real truth of the matter is, as you and I know, that a financial element in the large centers has owned the government of the U.S. since the days of Andrew Jackson.”*** – Franklin D. Roosevelt in a letter written Nov. 21, 1933 to Colonel E. Mandell House.

The deliberately dumbed-down people of these united States of America believe that “Congress is the legislative branch of the federal government that represents the American people and makes the nation's laws” (from U.S. Capitol Visitor Center, <https://bit.ly/3mGuzd2>).

Here is a short list of what Congress has the power to do:

- Make laws
- Declare war
- Raise and provide public money and oversee its proper expenditure
- Impeach and try federal officers
- Approve presidential appointments
- Approve treaties negotiated by the executive branch
- Oversight and investigations

The “president” **must** get Congressional approval for anything on this list (and more) that he wants to do. But remember, what the “president” wants isn’t really coming from him, because he is controlled. He is being dictated to. The global criminal controllers dictate to the “president” what policies, actions and “laws” they want in place (such as invading a country, giving Israel’s military \$38 Billion, etc.), and having a Congress that must approve these things would not be conducive to their success. So on March 9, 1933, this was enacted:



**“The actions, regulations, rules, licenses, orders and proclamations heretofore or hereafter taken, promulgated, made, or issued by the President of the United States or the Secretary of Treasury since March the 4<sup>th</sup>, 1933, pursuant to the authority conferred by Subsection (b) of Section 5 of the Act of October 6<sup>th</sup>, 1917, as amended [12 USCS Sec. 95A], are hereby approved and confirmed. Mar. 9, 1933, c. 1, Title 1, Sec. 1, 48 Stat. 1.”**

In other words, Congress PRE-APPROVED anything the “president” and the Secretary of Treasury had done AFTER THEY DID IT. And “heretofore and hereafter” anything the “president” and the Secretary of Treasury wants to do is PRE-APPROVED and does NOT require Congressional approval.

But what is it that Roosevelt wanted which Congress pre-approved and confirmed? He wanted, in his words, “...broad Executive power to wage a war against the emergency [The Great Depression, deliberately CAUSED by the banks], as great as the power that would be given to me if we were in fact invaded by a foreign foe.” – Franklin D. Roosevelt.

A state of emergency was created (a “war”), and every “president” to date has extended this emergency under one political maneuver after another. Why?

**Under a state of Emergency, the Constitution is suspended, therefore, the rights of every citizen of the United States (a status you were tricked into) is suspended. YOU HAVE NO RIGHTS. NOT IN THEIR JURISDICTION.**

Louis T. McFadden, who was the Chairman of the House Banking Committee back in the 1930s, exposed what the Federal Reserve really is, saved for all posterity in the Congressional Record, House pages 1295 and 1296 on June 10, 1932:

***“Mr. Chairman, we have in this country one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board and the Federal reserve banks. The Federal Reserve Board, a Government Board, has cheated the Government of the United States and the people of the United States out of enough money to pay the national debt. The depredations and the iniquities of the Federal Reserve Board and the Federal reserve banks acting together have cost this country enough money to pay the national debt several times over. This evil institution has impoverished and ruined the people of the United States, has bankrupted itself, and has practically bankrupted our Government. It has done this through the defects of the law under which it operates, through the maladministration of that law by the Federal Reserve Board, and through the corrupt practices of the moneyed vultures who control it. Some people think the Federal Reserve banks are United States Government institutions. They are not Government institutions. They are private credit monopolies which prey upon the people of the United States for the benefit of themselves and their foreign customers; foreign and domestic speculators and swindlers; and rich and predatory money lenders....”***

That was in 1932. Since then, they have in FACT bankrupted the “government.” Since then, how much more have they impoverished and ruined us? How much more corrupt has it become?

***"Mr. Speaker, we are here now in chapter 11. Members of Congress are official trustees presiding over the greatest reorganization of any Bankrupt entity in world history, the U.S. Government. We are setting forth hopefully, a blueprint for our future. There are some who say it is a coroner's report that will lead to our demise....."***— Speaker-Rep. James A. Traficant, Jr. (Ohio) addressing the House, United States Congressional Record, March 17, 1993 Vol. 33, page H-1303

From COMMERCIAL LIENS: A MOST POTENT WEAPON (edited by Terra Libra staff), pg. 58 [emphasis mine] (<https://bit.ly/2LKOCdt>): "The explanation of crimes [...] stem from other hidden crimes being forced upon the people of this [every state] REPUBLIC. Such crimes and this Affidavit of Information is filed in the overall context of the Bankruptcy of the United States (i.e. District of Columbia, as per jurisdiction set forth in the U.S. Constitution Article I, Section 8, clause 17 and 18 and Article IV Section 3 clause 2). **The United States bankruptcy is a direct result of the Federal Reserve Act of December 23, 1913, in which the delegated authority of Congress to be responsible for the nation's currency was illicitly, unconstitutionally, and treasonously surrendered to the privately owned Federal Reserve Corporation (a foreign agent), whose class A stockholders are various international banks. In place of real money as legal tender (gold and silver coin U.S. Constitution Article I Section 10, Coinage Act April 2, 1792), the Federal Reserve issued private commercial paper, drawn on the credit of the United States, consisting of only bookkeeping entries of no substance or reality, on which a real compound interest was charged. The U.S. Treasury paid the ever-increasing interest in gold and was eventually depleted, with a higher debt than ever. The planned inevitability occurred: BANKRUPTCY."**

In case you didn't quite catch that, the Federal Reserve also robbed us of all real Constitutional money (silver and gold) and replaced it with "Notes"—promissory "Notes," to be exact, a.k.a. "debt." This is an unconstitutional act and is therefore illegal.

The collateral on massive "government" loans and the irreconcilable debt, is Human Capital—that's you, your children, your parents, their parents, and everyone you know, have known and ever will know until this ends: all men, women and children in the united states of America. It is the same in all other countries as well. You are the human collateral on this massive debt.

What else did they do in 1933?

### **They made you the enemy of the United States of America**

In Section 2 of the Act of March 9, 1933, Subdivision (b) of Section 5 of the Act of October 6, 1917 [known as The Trading with the Enemy Act] (40 Stat. L. 411), as amended, is hereby amended to read as follows [emphasis ours];

**During time of war or during any other period of national emergency declared by the President, the President may, through any agency that he may designate, or otherwise investigate, regulate, or prohibit, under such rules and regulations as he may prescribe, by means of licenses or otherwise, any transactions in foreign exchange, transfers of credit between or payments by banking institutions as**

**defined by the President and export, hoarding, melting, or earmarking of gold or silver coin or bullion or currency, by any person within the (united States) or anyplace subject to the jurisdiction thereof....**

“Within.” One little word made us all the enemy of the United States of America, as we were no longer differentiated from any other enemy. Also, these special powers that can be wielded against enemies of the United States of America—namely you and your family—can be wielded not only in times of war, but also in times of “National Emergency.” And remember that we have been in a state of “National Emergency” SINCE 1933, for one real or (as is most often the case) fabricated so-called “emergency,” such as COVID-19®, as of the writing of this Compendium.

Every man, woman and child in America, with the exception of very few, have that in common: Since 1933, we are all officially considered belligerent enemy combatants of the U.S. “government.”

Another thing we have in common is that we are all victims of a constructive fraud perpetrated upon us at birth with the Birth Certificate: Since birth, the government has utilized the credit and future earnings of living men and women, creating and operating a private offset account through the use of your “strawman” or “cestui que vie” Trust name (JOHN HENRY DOE, your all-caps name), without the knowledge, consent or permission of the living beneficiary, John-Henry: Doe, acting to your detriment against the basic precepts of a trust. Your legal (all-caps) Trust name (MARY JANE DOE) is engaged in the business of asset management and banking. And having been made the legal representative of this Trust, without your consent or knowledge, are responsible for its bills, fines, fees, taxes, etc. This is the first trespass against us at the moment of our birth. We all share this reality.

Your bills, mortgage and tax bill in your name in all capital letters—IS NOT YOU. It is an abstract legal construct created without your permission and for which you are financially responsible because you have been deceived and entangled in their corporate Admiralty Maritime jurisdiction by simply not knowing any better to say NO and reorganize your legal Trust status.

NEED TO KNOW:

February 21, 1871: With no constitutional authority to do so, Congress Passes an Act to Provide a Government for the District of Columbia, also known as the “Act of 1871”. This created a separate form of government for the District of Columbia, which is a ten mile square parcel of land (see: Acts of

the Forty-first Congress, Section 34, Session III, chapters 61 and 62). It created a corporation called THE UNITED STATES.

The Act of 1871 was passed when the country was weakened and financially depleted in the aftermath of the Civil War. It was a strategic move by foreign international bankers who were intent upon gaining a stranglehold on the coffers and neck of America.

With this Act, the organic Constitution was vandalized and sabotaged when the title was capitalized and the word “for” was changed to “of” in the title. This newly altered Constitution does not benefit the Republic, nor was it intended to. It benefits only the corporation of the UNITED STATES OF AMERICA and operates entirely outside the original (organic) Constitution.

The Act of 1871 is the FOUNDATION from which all government officials have committed treason against the People.

Think of it this way: A bunch of greedy, rich psychopaths created a business and tricked you into being their employee. They then bound you to their rules and regulations with penalties for violations, and confiscated your natural rights for some privileges they allow you to perform and that they can take away anytime they want and for any reason, whether legitimate or not.

An excellent example of this is the Driver’s License: This is a privilege they give you for being their employee/slave, and they can take it away, fine you, impound your vehicle, and throw you in a cage. Free men and women do not need permission to travel in pursuit of their life, liberty and happiness. They have an inherent right to do so and no one but God can take that away.

#### 28 U.S. Code § 3002 – Definitions

As used in this chapter:

#### **(15) “United States” means— (A) a Federal corporation;**

RECAP: Without your permission, a bunch of greedy, rich psychopaths created a business (THE UNITED STATES OF AMERICA), turned you into their employee, a.k.a. the authorized agent administering the estate of a decedent (dead person) represented by your name in all caps which couldn’t exist without your birth. Then they exchanged your natural, immutable rights for some rules and regulations with the threat of violence and coercion hanging over your head in the event that you refuse to pay the penalties for violating any of them, and all of this perpetrated upon you who they have officially and legally labeled their enemy since birth.

When you say you are a U.S. citizen, you are saying you are a citizen of the District of Columbia. In reality, you are the undesirable United States citizen (of the CORPORATION) while also being an American Citizen (of one of the united states of America—NOT the same as the capitalized “United States” of America). (See U.S. v. Austin Gary Cooper, Case #89-109-Hoever, 1996.)

***"Therefore, the U.S. citizens [citizens of the District of Columbia] residing in one of the states of the union, are classified as property and franchises of the federal government as an "individual entity."  
—Wheeling Steel Corp. v. Fox, 1936; 298 U.S. 193, 80 L.Ed. 1143, 56 S.Ct. 773.***

Now more than ever people are waking up to these Truths, and the necessity for deprogramming themselves and to sever all invisible adhesion contracts which the CORPORATION ("government") deceived them into. We the People are realizing that we need to correct our status and standing and become men and women on the land again, and not 14<sup>th</sup> Amendment Federal slave class citizens with "privileges" that can be taken away as opposed to basic human rights that can NEVER be diminished. Because no corporate "government" bureaucracy can abolish the immutable basic rights men and women acquired NATURALLY by being alive.

The process for becoming a private man or woman operating in commerce, and for CORRECTING "governments' presumptions about you, is called the Secured Party/Creditor process, and more people every day are becoming aware of this necessity and taking action.

## **~~~ The Hegelian Dialectic ~~~**

It is important to understand the definition of the Hegelian Dialectic as a segue into the topic of 9/11. The Hegelian Dialectic is a framework for manipulating our thoughts and actions into conflicts that lead us to a **predetermined solution**. It is the foundation upon which the Club of Rome operates, one of many of the sociopaths' instruments being used to form the One World Government, also known as the New World Order. The Club of Rome is described as a crisis think tank which specializes in "crises creation" for uniting the world and conditioning (brainwashing and propagandizing) us to the idea of global solutions to local problems.

Another way to look at it is manipulation of our trust in "government," or authority in general. And although "authority" is a myth, most people living unconsciously have been trained to believe in this idea that one person can be an authority over another without realizing it is actually slavery that they are accepting. Often times the solution for a catastrophic event is a theatre war, as is the case of every war not declared by Congress after WWII.

In 1962, Operation Northwoods would have been just such a catastrophic event, had it not been rejected by President Kennedy. Operation Northwoods was a proposed series of recreant false flag events meticulously planned out and presented to President Kennedy. The plan encompassed blowing up U.S. naval ships and hijacking and crashing commercial airliners (sound familiar?). This treasonous plotting was the work of the Department of Justice and the Joint Chiefs of Staff with the aim of garnering support for war against communist Cuba by making them out to be the aggressors. Similar tactics have been employed by the U.S. "government" and other "governments" since then, while Operation Northwoods was shelved for forty years. In 2001 it underwent some adjustments and finally

rolled out as the 9/11 false flag event, making Al Qaeda responsible and thereby opening the bombing bays over Afghanistan and Iraq: It was a perfected Hegelian Dialectic at work.

The Gulf of Tonkin incident is a famous false flag/Hegelian Dialectic event that is almost accurately (and surprisingly) exposed by Wikipedia. (The Truth about a false flag event only comes out many decades later, when most everyone involved and responsible is dead and gone, such as is the case with the Gulf of Tonkin incident.)

The Gulf of Tonkin incident was a “government” lie to justify a war against Vietnam, proven by the Pentagon Papers, Robert McNamara’s memoirs and NSA publications from 2005. The lie was that an American ship had been bombed by a Vietnamese ship (what Wikipedia calls a “confrontation”). This is the event that started the Vietnam war.

***“No matter how paranoid or conspiracy-minded you are, what the government is actually doing is worse than you imagine.” — William Blum, former U.S. State Department employee.***

Another attempted and infamous false flag/Hegelian Dialectic was in 1967: Israeli fighter jets and torpedo boats attacked the well-marked American USS Liberty battleship. This U.S. “government”-sanctioned attack was to be blamed on Egypt so that the U.S. could join the war, but it failed, resulting in the mass murder of 34 servicemen leaving 171 wounded. During this event, Secretary of Defense Robert McNamara recalled fighter jets and ships sent to protect the USS Liberty for reasons that remain “unclear,” if you follow History.com’s sugarcoated and propagandized version of the event. The Truth is much more dire than that: The “government” wanted the USS Liberty sunk to the bottom of the sea with no survivors. A hard-to-find audio of Israeli communications during this event confirms their awareness that the ship they were attacking was American.

The Reichstag Fire was one of Hitler’s false flags. The insidious Oklahoma City Bombing was another inside job with a predetermined solution. The Boston Bombing is laughably easy to prove as a total fraud. The staged Sandy Hook School “shooting,” the Dallas “shooting,” The Las Vegas “shooting,” the Parkland School “shooting,” as well as countless other staged mass shootings around the globe, including car attacks, so-called attempted plane bombings...

The list of Hegelian Dialectic false flags and other staged events is very, very long.

Whenever contact is lost with any airplane, fighter jets routinely take to the air to investigate. This commonly occurs about 100 times per year in well under 20 minutes. But on 9/11, nearly two hours passed without any interceptions.

***“We are on the verge of a global transformation. All we need is the right major crisis, and the nations will accept the New World Order.” — David Rockefeller, United Nations dinner, 1994.***

There’s no denying that 9/11 was a terrorist attack. The Project for the New American Century (PNAC) was an American think tank based in Washington, D.C. established in 1997 as a non-profit educational organization. In Section V of Rebuilding America’s Defenses entitled “Creating Tomorrow’s Dominant Force,” we have this quote published one year BEFORE 9/11:



***“Further, the process of transformation, even if it brings revolutionary change, is likely to be a long one, absent some catastrophic and catalyzing event—like a new Pearl Harbor...”***

Proof that the U.S. “government” is not looking out for you, that it does not care about you, that it does not hold freedom, liberty or even life itself in any regard, and that as a CORPORATION manifests the agendas of psychopathic foreign gangsters (banking families) with the end result of total global control as their crowning glory, we will need to take a look at 9/11.

And we will do so in honor of the 2,996 American lives that were stolen that day, as well the (approximately, and still counting) 1.5 MILLION innocent foreigners who lost their lives in the ensuing retaliatory “wars.”

The “government’s” official 9/11 explanation is that Osama bin Laden orchestrated 9/11. If you also believe this, it means you have done zero research and that you have probably never heard of WTC Building 7 (a.k.a. the “Soloman Brothers Building”).

WTC 7 was a 47-story steel-framed building that collapsed at 5:25 p.m. on 9/11 along the path of greatest resistance into its own footprint in 7 seconds flat with an admitted free fall of 100 feet. Having a forged birth certificate makes Mr. Soetoro ineligible to be President and invalidates everything he did while in office. <https://bit.ly/2MaOeob>

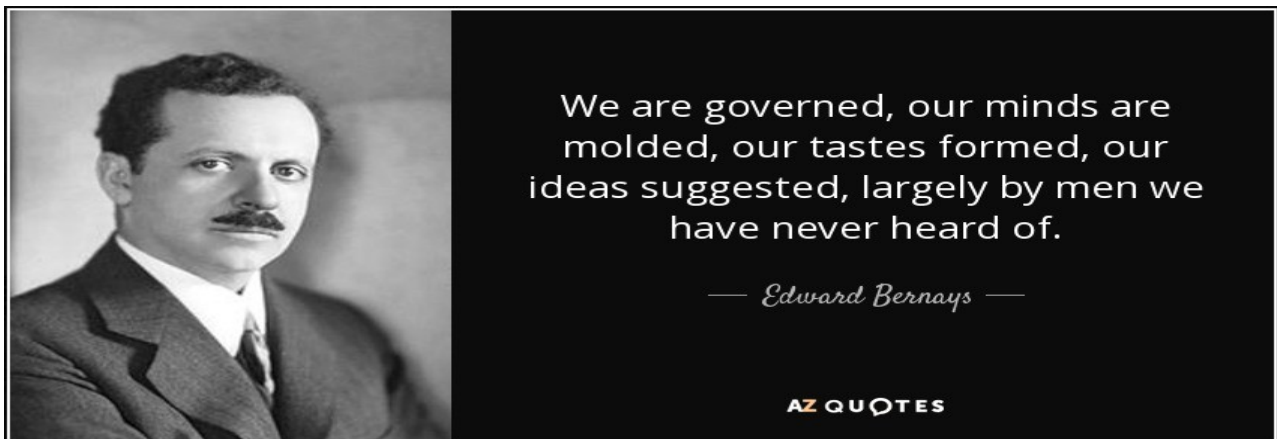

If that's what peace looks like, I don't think we've ever seen a real war yet. But according to "government" doublespeak, "War is Peace."

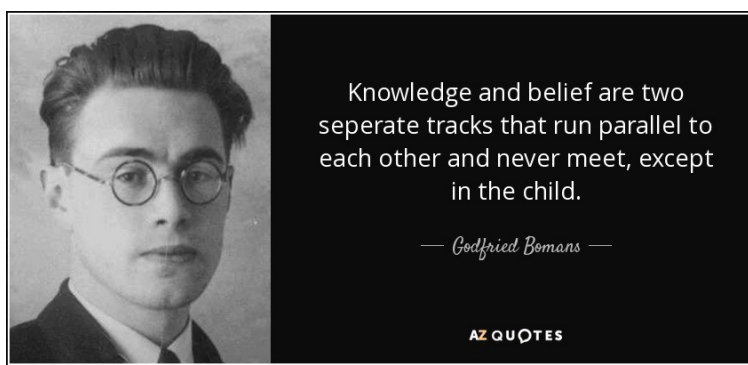

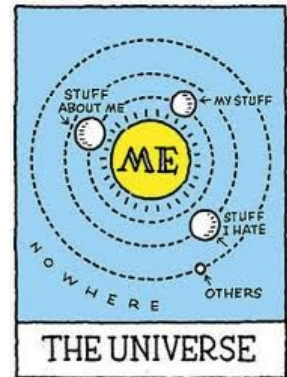

One of the most dangerous things is the attitude of solipsism.

Solipsism is the belief that there is no such thing as Truth, and that we can make up what Truth is.



Solipsism means that knowledge of anything outside one’s own mind is unsure.

Natural Law teacher and Truth advocate Mark Passio instills in us that merely believing what you want to believe without validating or disproving it results in all the suffering we are experiencing around the world. 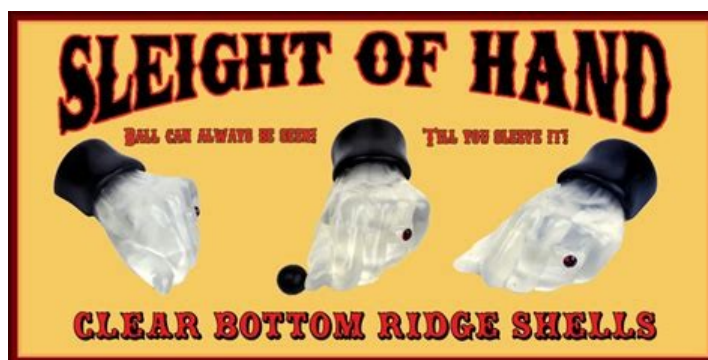

We had the complicity of the government of Zambia [...] to put these false stories into his newspapers. But after that point, the journalists, Reuters and AFP, the management was not witting of it. Now our contact man in Europe was and we pumped just dozens of stories about Cuban atrocities, Cuban rapists... In one case we had the Cuban rapists caught and tried by the Ovimbundu maidens who had been their victims. And then we ran photographs that made almost every newspaper in the country of the Cubans being executed by the Ovimbundu women who supposedly had been their victims.”***

**Interviewer: “These were fake photos?”**

***“Oh, absolutely. We didn’t know one single atrocity committed by the Cubans. It was pure, raw, false propaganda to create an illusion of communists, you know, eating babies for breakfast.***

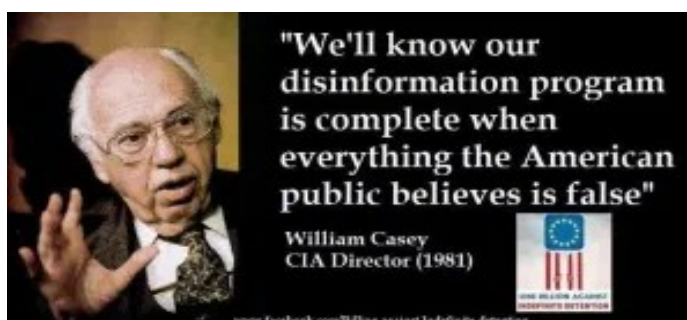

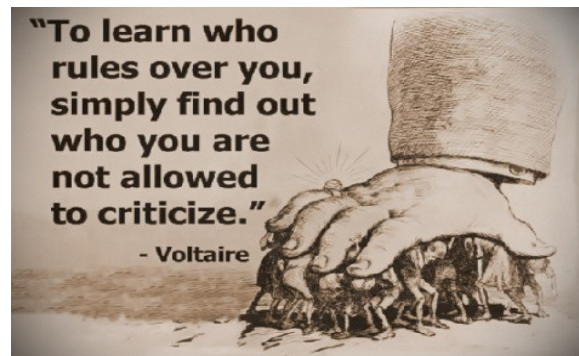

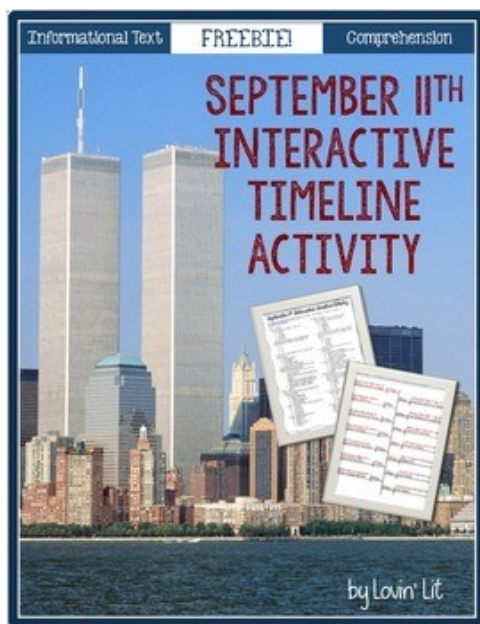

- Conform: Intellectually and socially

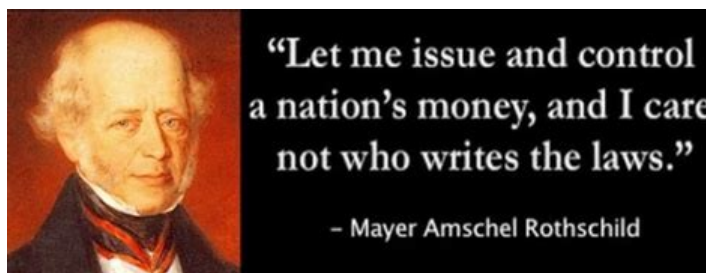

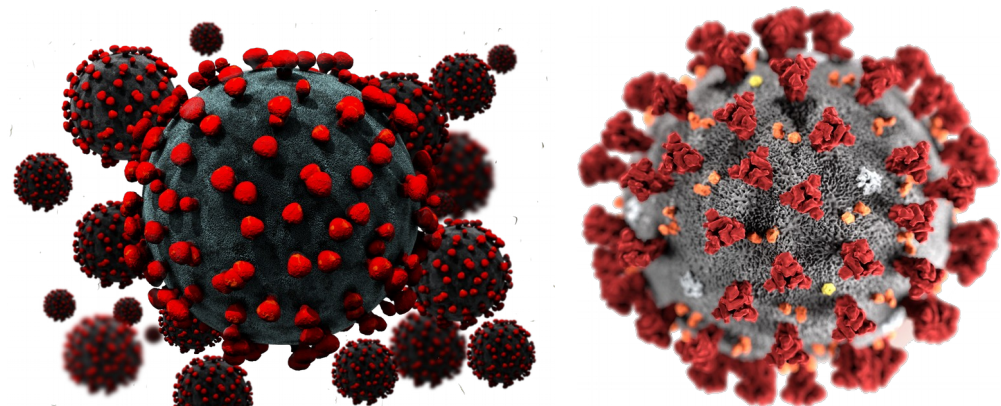

They are NOT COVID-19® viruses.

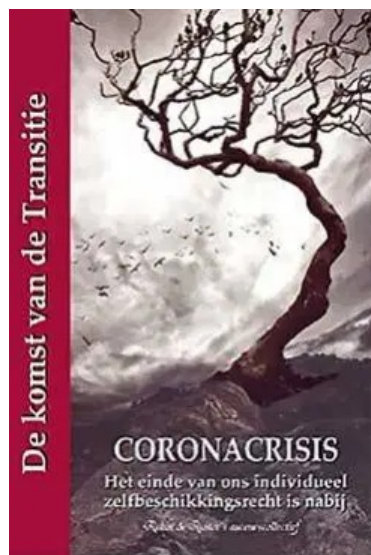

As you read, you might find yourself questioning your own understanding of where disease comes from to begin with. There are two theories:

Terrain Theory is the belief that our healthful internal environment (immune system) has the power to fight off “unfriendly” organisms.

The most widely accepted is Germ Theory, the cornerstone of modern medicine popularized by Louis Pasteur (1822-1895). Germ Theory is the proposal that germs outside ourselves get inside us and cause disease, even in perfectly healthy people with strong immune systems. The astronomical profits of the pharmaceutical industry are reliant on Pasteur’s Germ Theory, even though it has been proven to be a fraud.

Louis Pasteur is the inventor of an invisible contagion that he couldn’t have possibly detected, as the electron microscope was invented in the early 1900s. His lie continued to induce fear around the world while supplying Big Pharma with billions in profits annually.

Whichever theory one ultimately buys into doesn’t really matter, as there is no evidence of the so-called COVID-19® disease and no scientific basis to support a “pandemic.”

IT IS VERY IMPORTANT that as we seek Truth to live consciously that we do not shut down the possibility of learning by throwing the baby out with the bath water, as they say. If you are of the belief that there is an actual virus spreading around the world and killing millions, then you should know that the strong anti-viral effect of chloroquine on SARS-CoV had been proven by an extensive scientific study by the National Institutes of Health (NIH) directed by Dr. Anthony Fauci in August 2005.

The conclusion of this study titled “Chloroquine is a potent inhibitor of SARS coronavirus infection and spread” was that “Chloroquine has strong antiviral effects on SARS-CoV infection of primate cells. These inhibitory effects are observed when the cells are treated with the drug **either before or after exposure to the virus, suggesting both prophylactic and therapeutic advantage.** [...] Chloroquine is effective in preventing the spread of SARS-CoV in cell culture.” <https://bit.ly/37KkRkS>

This of course means that Dr. Fauci has known for over 15 years that chloroquine and its milder, inexpensive derivative hydroxychloroquine (HCQ), will not only treat a current case of coronavirus but will prevent future cases. So HCQ functions as a cure and a true vaccine.

Now ask yourself why a cure for COVID-19® is being suppressed and made illegal?

According to many America’s Frontline Doctors and many others, HCQ has cured 100% of (alleged) COVID-19® patients, and yet it is deemed an “unproven” drug and to prescribe it is a violation of the Federal Food, Drug and Cosmetic Act. Pharmacies have even refused to fill prescriptions for the drug.

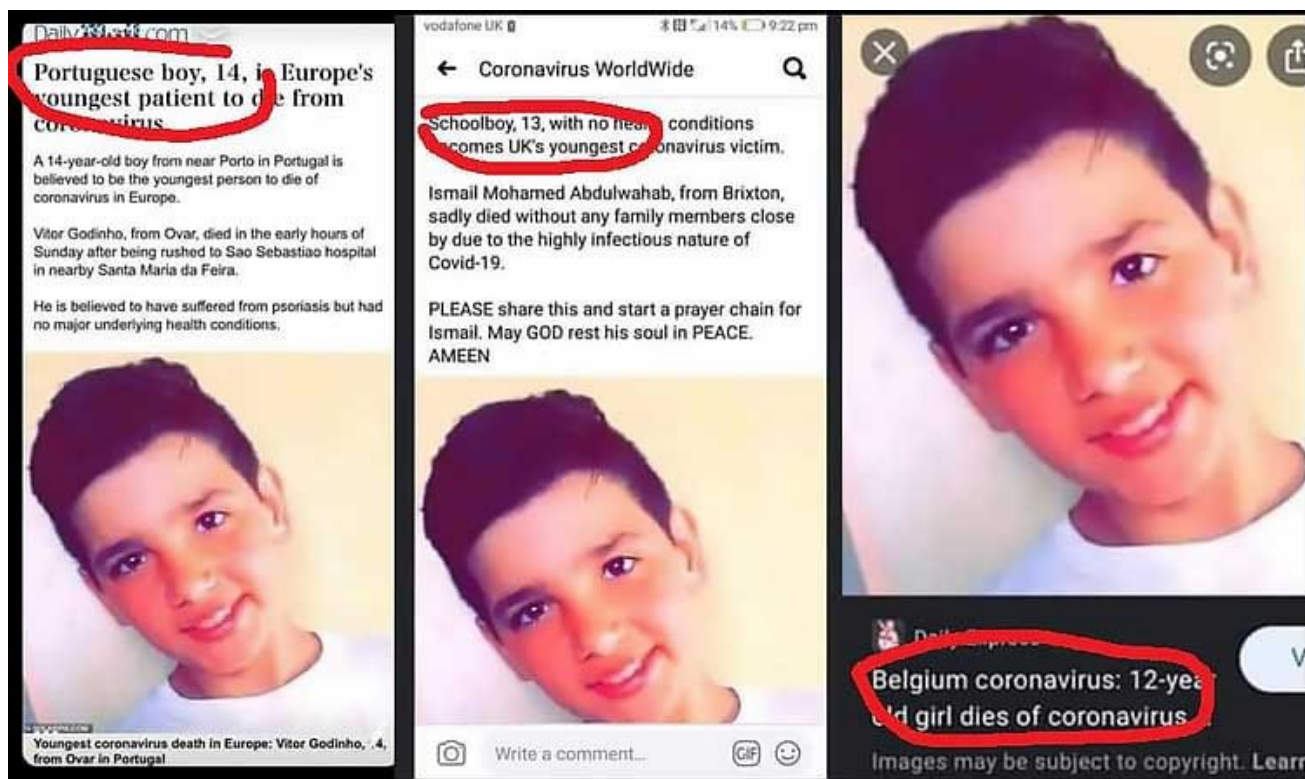

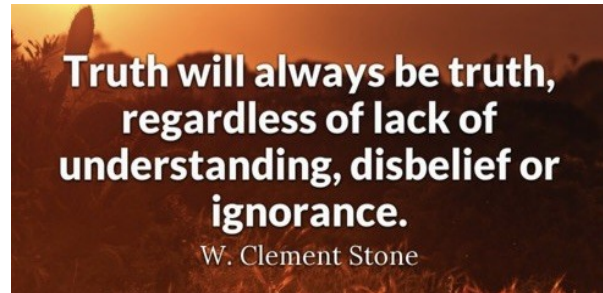

Despite that, nobody can be said to have died from COVID-19® because there is no proof of existence of a pathogenic virus known as SARS-CoV-2 which causes COVID-19®: It has never been purified or isolated.

Koch’s Postulates (pronounced *Coke*) are a set of four criteria designed to establish a causative relationship between a microbe and a disease. Koch’s Postulates have not been fulfilled for the COVID-19® virus and therefore it has not been proven to be infectious. ### Performance Characteristics

#### **Analytical Performance:**

##### *Limit of Detection (LoD):*

LoD studies determine the lowest detectable concentration of 2019-nCoV at which approximately 95% of all (true positive) replicates test positive. The LoD was determined by limiting dilution studies using characterized samples.

The analytical sensitivity of the rRT-PCR assays contained in the CDC 2019 Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel were determined in Limit of Detection studies. **Since no quantified virus isolates of the 2019-nCoV were available for CDC use at the time the test was developed and this study conducted,** assays designed for detection of the 2019-nCoV RNA were tested with characterized stocks of in vitro transcribed full length RNA (N gene; GenBank accession: MN908947.2) of known titer (RNA copies/μL) spiked into a diluent consisting of a suspension of human A549 cells and viral transport medium (VTM) to mimic clinical specimen. Samples were extracted using the QIAGEN EZ1

This reveals that the development of the test for a specific virus was created WITHOUT the one element NECESSARY for its specificity—the isolated and purified virus.

To “quantify” a virus is to “measure” a virus, so the CDC is saying that THEY HAVE NO MEASURABLE AMOUNT OF THE VIRUS. Which means they have no virus. Which means they have no proof that COVID-19® even exists.

A Mennonite was asked why their community has been completely unaffected by COVID-19® and they replied, “Because we don’t watch TV or listen to the radio.”

In Ireland, multi-award winning investigative journalist Gemma O’Doherty sent a Freedom of Information Act (FOIA) request for Health Services Executive (HSE) to supply the records proving the SARS-CoV-2 virus has been isolated, and HSE responded: “Following consultation with my colleagues, both from the scientific and medical areas of the HPSC can confirm that we withhold no records in relation to your request. These are the reasonable steps I have taken to ascertain the whereabouts of existence of such records and unfortunately I must inform you that having undertaken these searches we were unable to locate the records in question....”

- A reliable test cannot be created for a virus that has not been isolated.
- A disease cannot be blamed on a virus if the virus has not been isolated.

- A new variant or “mutant strain” of a virus cannot exist if the original virus has never been isolated.
- A vaccine cannot be developed unless a virus has been isolated.
- A vaccine cannot possibly be proven to work against a virus that has never been isolated.

The Truth is, no “pathogenic virus” has EVER been found in a human or an animal. Viruses are an immuno-response produced by our bodies at the cellular level, they are not pathogens that float through the air or remain on surfaces to infect people. IN A NUTSHELL: In April 1917, when the United States entered into WWI, the Rockefeller Institute for Medical Research (the pharmaceutical industry in general) was growing its roots. With the U.S. Army expanding to 6 million men, the Rockefellers used them as human guinea pigs to conduct vaccine experiments, administering their first bacterial meningitis vaccinations derived from horses to soldiers at Ft. (Research the “Tuskagee Syphilis Experiment” to learn that the government had used humans as guinea pigs for 40 years, between the years 1932 – 1972, pretending to give free treatment to 622 African-American men suffering from syphilis, but giving them placebos instead to observe them as the untreated syphilis ravaged their bodies and ultimately killed them. <https://bit.ly/3poJyJD>)

The phrase “influenza” or “flu” was adopted to explain something they had no explanation for in 1918, which was bacterial pneumonia, found in 92.7% of the autopsies of vaccine victims. The term “Spanish flu” was a purposeful misdirection to disguise the origin of the “pandemic.”

Still toeing the false “influenza virus infection” lie, the National Institute of Allergy and Infectious Disease (NIAID) reports: “The majority of deaths during the influenza pandemic of 1918-1919 were



not caused by the influenza virus acting alone [...] most victims succumbed to bacterial pneumonia following influenza virus infection. **The pneumonia was caused when bacteria that normally inhabit the nose and throat invaded the lungs** along a pathway created when the virus destroyed the cells that line the bronchial tubes and lungs.”

***“A future influenza pandemic may unfold in a similar manner.”***  
**—NIAID authors, Anthony S. Fauci, et al. (2008)**

The published reports "clearly and consistently implicated secondary bacterial pneumonia caused by common upper respiratory flora in most influenza fatalities," says Dr. Morens. "Pathologists of the time," he adds, "were nearly **unanimous** in the conviction that **deaths were not caused directly by the then-unidentified influenza virus, but rather resulted from severe secondary pneumonia caused by various bacteria.** Absent the secondary bacterial infections, many patients might have survived..."

**That's right, they have  
done this before.**



Approximately 92% or more of the 50 million (possibly up to 100 million) people who died from the Spanish flu between the years 1918 and 1919 were the victims of experimental Rockefeller vaccinations and the ensuing treatments used for the fake “viral” pandemic. It was an epidemiological experiment upon a very limited population without informed consent, just like COVID-19®.

### VACCINES CAUSE DISEASES.

Smallpox vaccine caused syphilis, paralysis, leprosy, and cancer. Polio shots, diphtheria toxin-antitoxin, typhoid vaccine, as well as measles, tetanus and all other shots often cause various other stages of disease such as post-vaccinal encephalitis (inflammation of the brain), paralysis, spinal meningitis, blindness, cancer (sometimes within two years,) tuberculosis, (two to twenty years after the shot), arthritis, kidney disease, heart disease (heart failure sometimes within minutes after the shot and sometimes several hours later). Nerve damage and many other serious conditions also follow the injections.

It's no surprise that the court case to prove that a measles virus exists wasn't reported on by Mainstream Media: In Germany, Dr. Stefan Lanka offered €100,000 to anyone who could prove that a measles virus existed. Five experts, including Dr. Andreas Podbielski, were involved in the case and presented results of scientific studies which they claimed proved the existence of a measles virus, but on February 16, 2016, the Federal Supreme Court (BGH) confirmed the judgment by the Higher Regional Court of Stuttgart (OLG) and ruled that Dr. Stefan Lanka did not have to pay them the €100,000 reward, because the court found that none of the six publications which had been introduced to the trial contained scientific proof of the existence of the alleged measles virus. <https://bit.ly/3lnbfAk>

**The measles vaccine is still being injected into babies to this day. But if there is no proof of a virus that causes measles, then what are they injecting into the babies and why?**

Whatever “measles” is or was, the death rate had declined by 98% from 1915-1958—prior to any vaccination being introduced.

In 1988 and 1989, 69% and 89% (respectively) for “measles” cases in American school-aged children had been vaccinated.

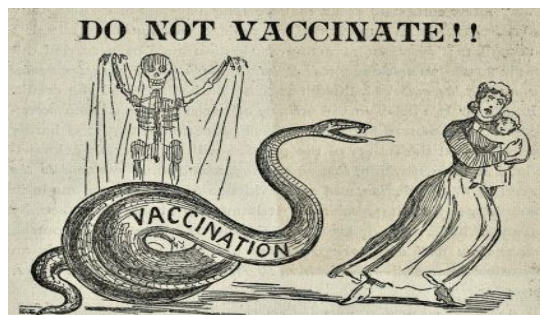





#### **4.4 Special warnings and precautions for use**

##### Hypersensitivity and anaphylaxis

Events of anaphylaxis have been reported. Appropriate medical treatment and supervision should always be readily available in case of an anaphylactic reaction following the administration of the vaccine. Close observation for at least 15 minutes is recommended following vaccination. A second dose of the vaccine should not be given to those who have experienced anaphylaxis to the first dose of the COVID-19 mRNA Vaccine BNT162b2.

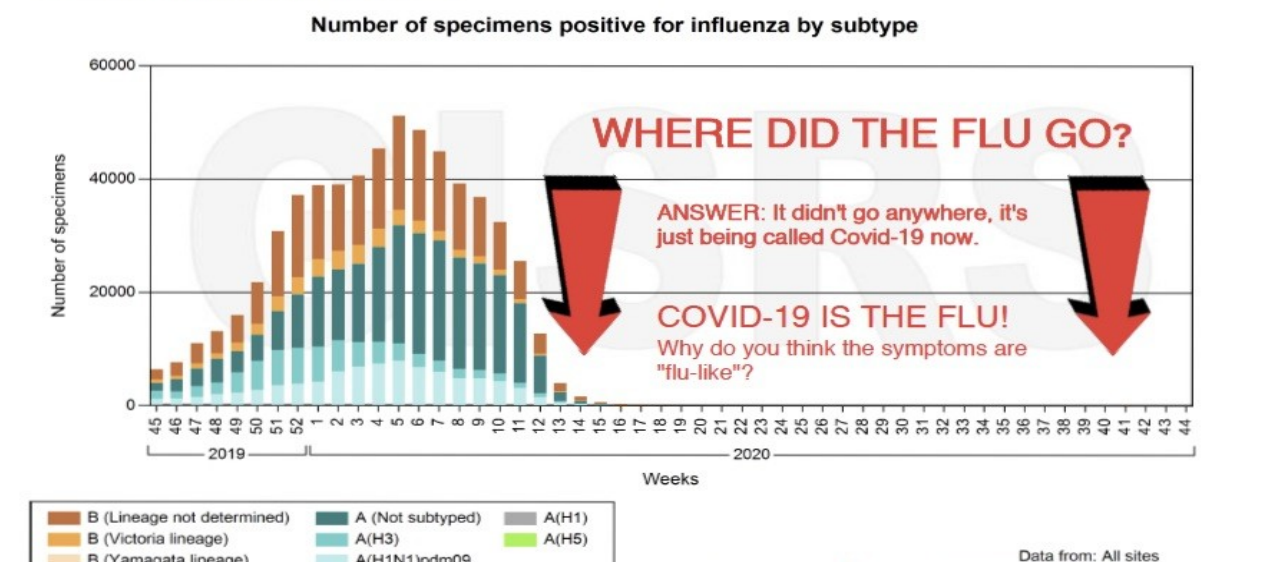

#### Global circulation of influenza viruses



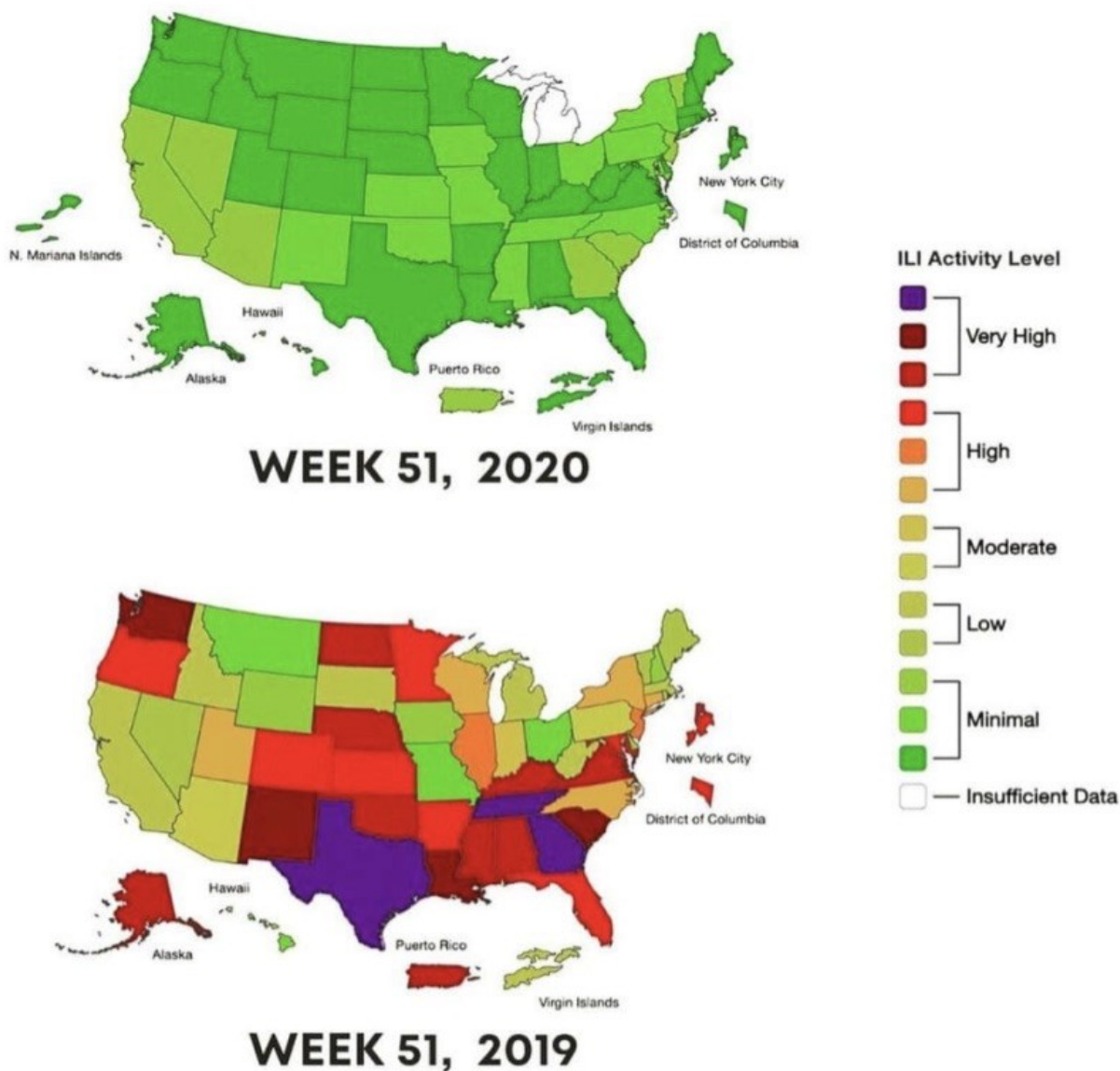

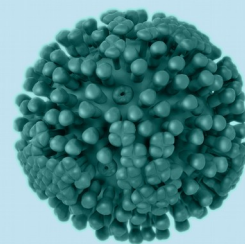

This invention was made by the Centers for Disease Control and Prevention, an agency of the United States Government. Therefore, the U.S. Government has certain rights in this invention.

**FIELD OF THE DISCLOSURE**

This invention relates to a newly isolated human coronavirus. More particularly, it relates to an isolated coronavirus genome, isolated coronavirus proteins, and isolated nucleic acid molecules encoding the same. The disclosure further relates to methods of detecting a severe acute respiratory syndrome-associated coronavirus and compositions comprising immunogenic coronavirus compounds.

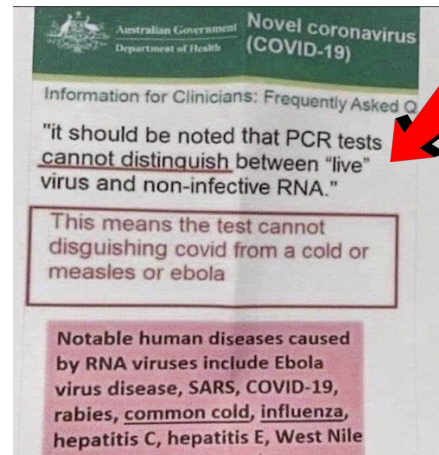

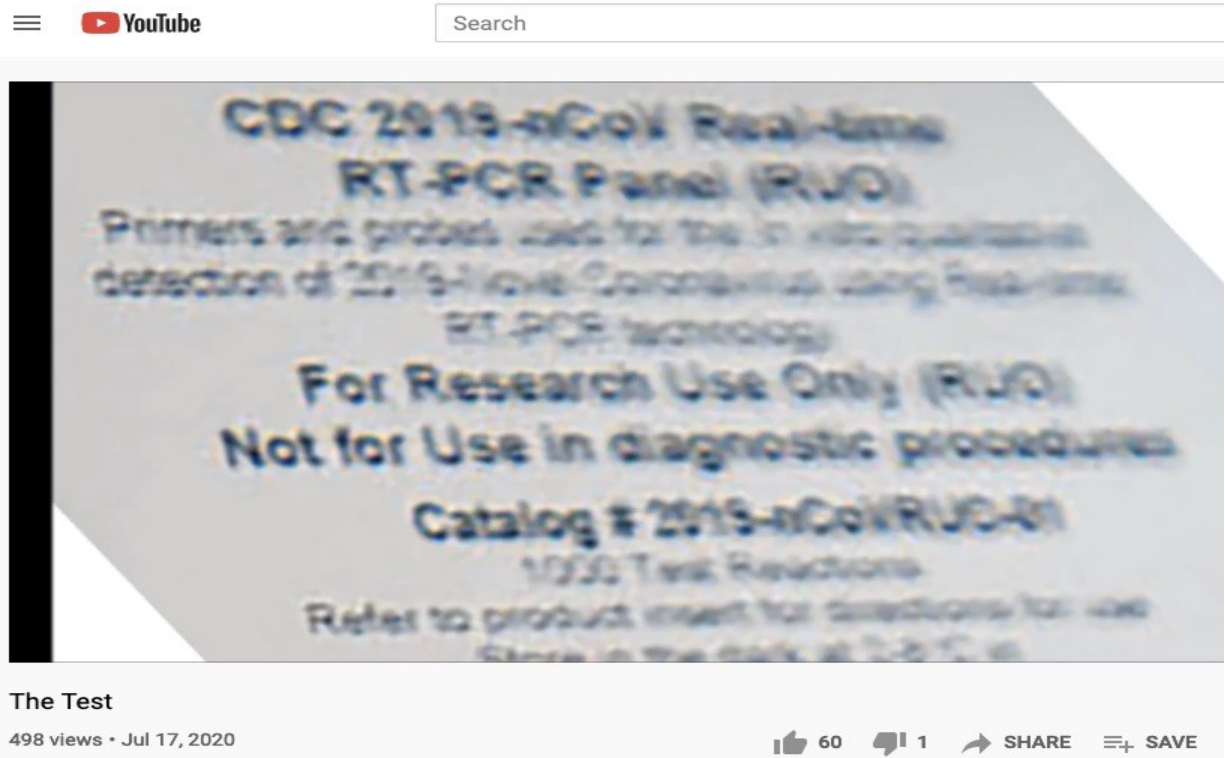

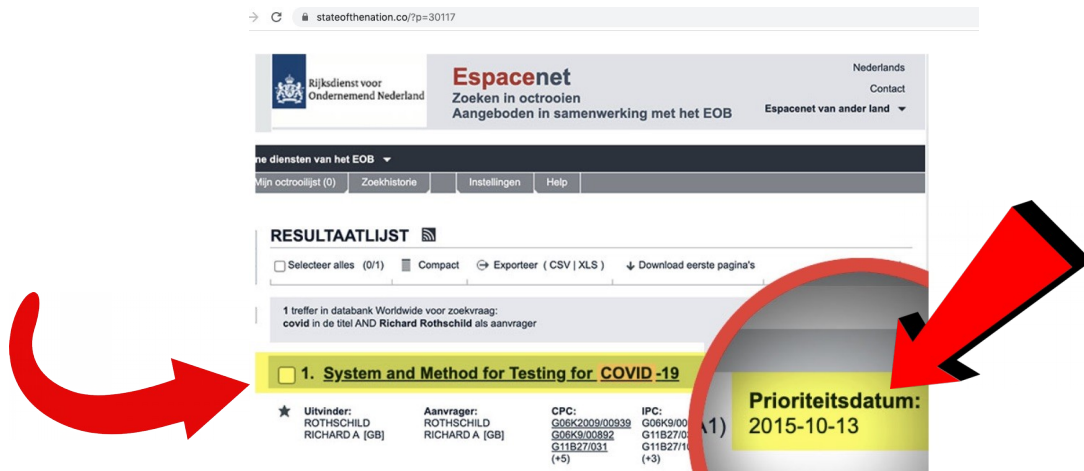

### Abstract

**Aims of the study:** Patient comprehension is a critical part of meeting medical ethics standards of informed consent in study designs. The aim of the study was to determine if sufficient literature exists to require clinicians to disclose the specific risk that COVID-19 vaccines could worsen disease upon exposure to challenge or circulating virus.

**Methods used to conduct the study:** Published literature was reviewed to identify preclinical and clinical evidence that COVID-19 vaccines could worsen disease upon exposure to challenge or circulating virus. Clinical trial protocols for COVID-19 vaccines were reviewed to determine if risks were properly disclosed.

**Results of the study:** COVID-19 vaccines designed to elicit neutralising antibodies may sensitise vaccine recipients to more severe disease than if they were not vaccinated. Vaccines for SARS, MERS and RSV have never been approved, and the data generated in the development and testing of these vaccines suggest a serious mechanistic concern: that vaccines designed empirically using the traditional approach (consisting of the unmodified or minimally modified coronavirus viral spike to elicit neutralising antibodies), be they composed of protein, viral vector, DNA or RNA and irrespective of delivery method, may worsen COVID-19 disease via antibody-dependent enhancement (ADE). This risk is sufficiently obscured in clinical trial protocols and consent forms for ongoing COVID-19 vaccine trials that adequate patient comprehension of this risk is unlikely to occur, obviating truly informed consent by subjects in these trials.

**Conclusions drawn from the study and clinical implications:** The specific and significant COVID-19 risk of ADE should have been and should be prominently and independently disclosed to research subjects currently in vaccine trials, as well as those being recruited for the trials and future patients after vaccine approval, in order to meet the medical ethics standard of patient comprehension for informed consent.

Like the machinations of any major covert operation whose success is dependent upon compartmentalization, so too has the COVID-19® “pandemic” scheme been consummated. 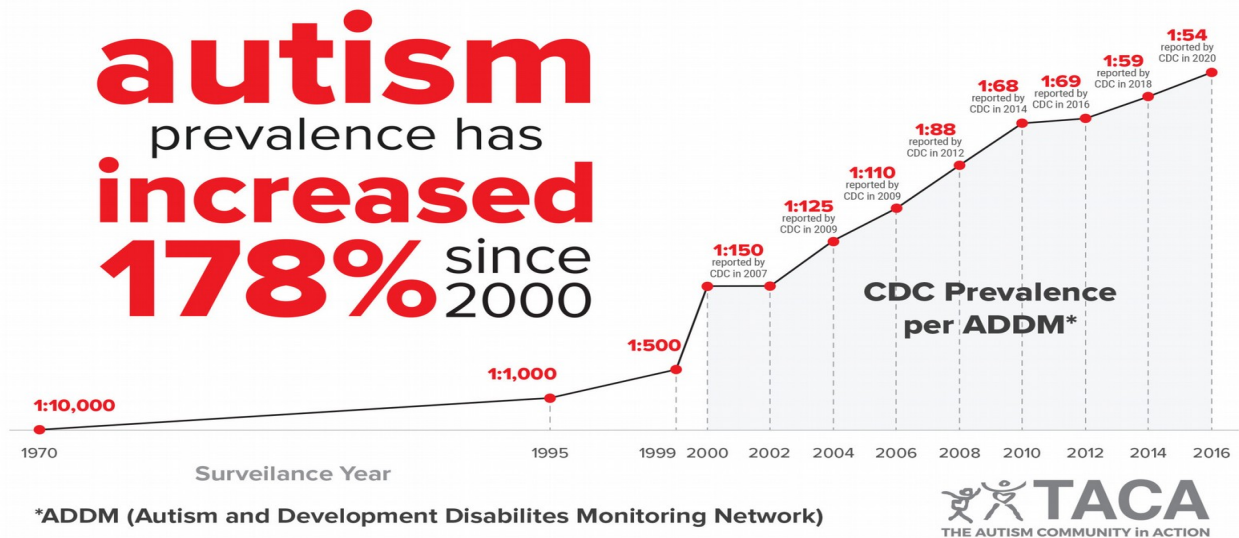

- The COVID crisis will be used to extend the life of this dying economic system through the so-called Great Reset.

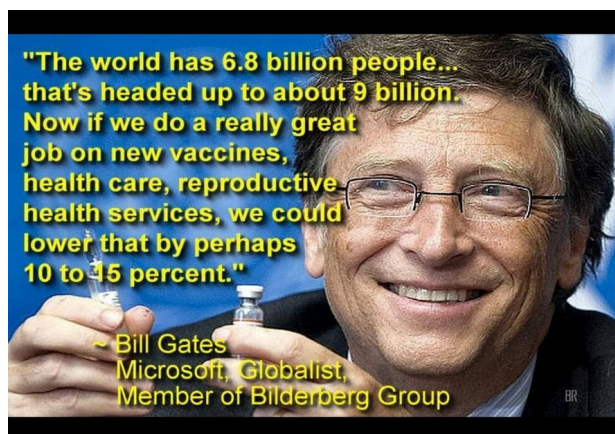

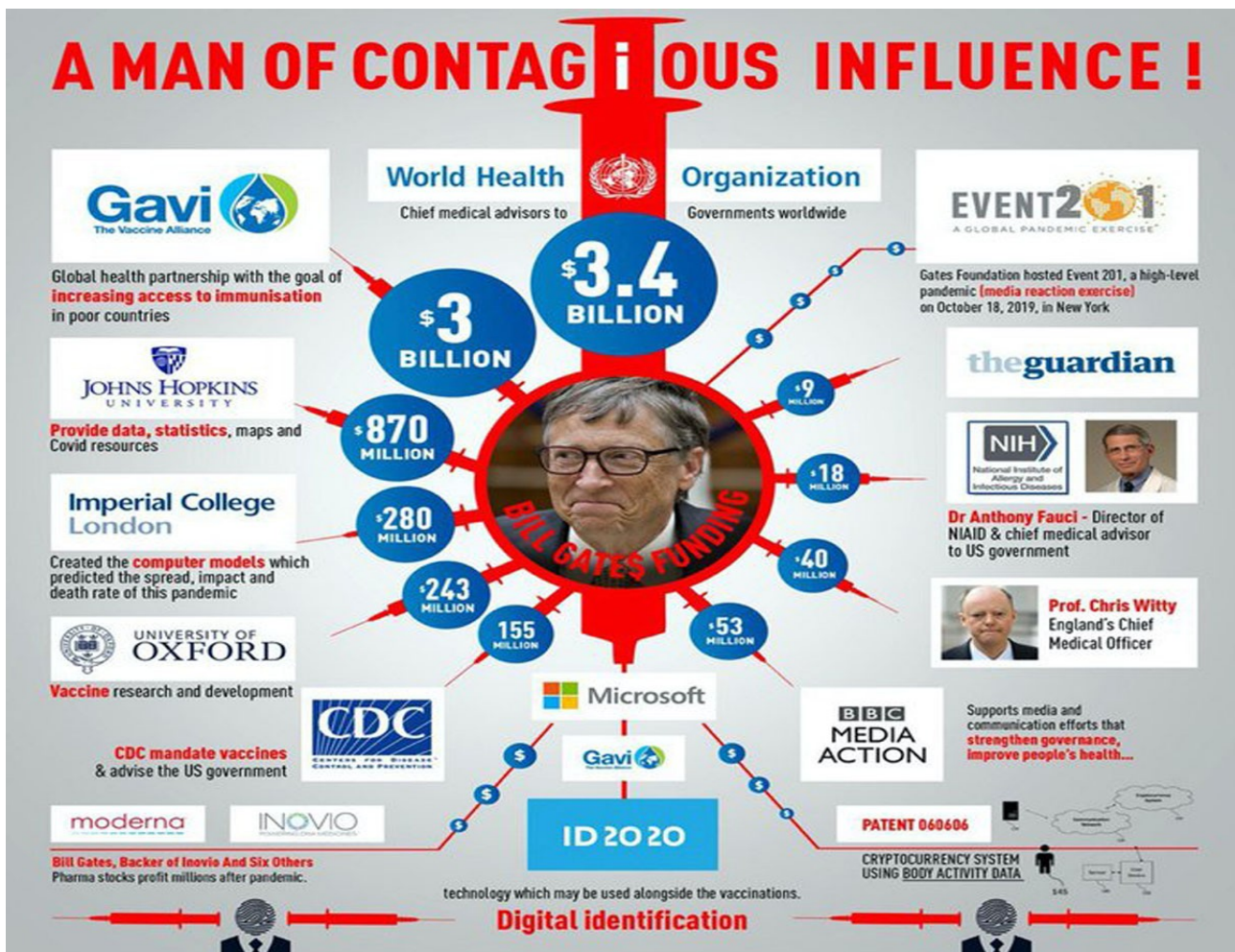

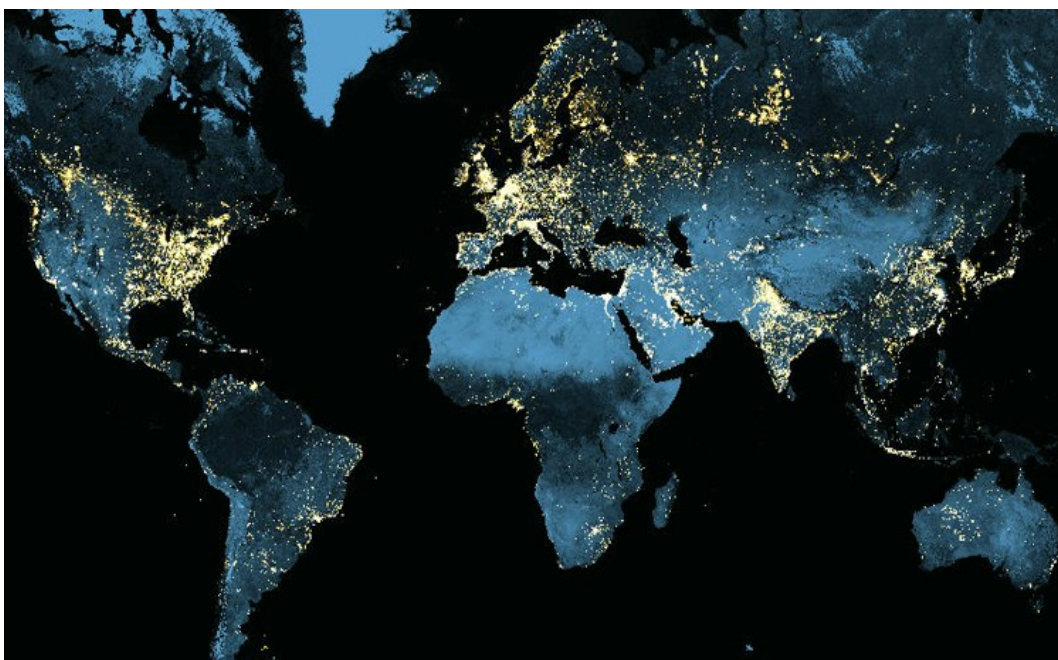
