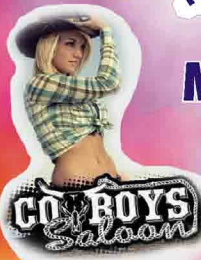

I thought I'd say a little about sharing our roads with all the cars and trucks that sometimes seem like their out to get us!! I think you know what I mean.

I taught **Motorcycle Safety Awareness** in local high schools for about two or three years awhile back, hopefully we got through to a few of the students, Sometimes I wonder if it worked, but we did try.

**ABATE** has been trying to do whatever we can to make the roads safer for "bikers". **ABATE** puts out signs like, **Watch Out for Motorcycles, Look Twice Save a Life**, but I don't think people read them; if they do I don't think they let it **sink in!!** People just don't pay as much attention to what's going on around them, especially when they're *talking* or even **texting** on **cell phones**, it should be **against the law!**, but it's not in the State of Florida, at least, **not yet** but we're working on it, so what else can we do?

We have to take it upon ourselves to be more aware of what's going on around us. Here are a few things we can do:

- Expect the unexpected
- When coming to a intersection "slow down" look in every direction then proceed
- When approaching a drive way, or exit of parking lot, expect someone to pull out in front of you
- Expect the car next to you to cut you off
- Drive defensively at all times

I know we shouldn't have to, but it might **Save Your Life!**

**Always** keep your mind on what **you're doing**, "**be aware**" of your surroundings.

**ABATE** is always trying to make the roads more safe, **ABATE** is fighting for stiffer penalties for those who are responsible for motorcycle accidents, and **ABATE** is always fighting for our motorcyclists rights.

We **can't do it alone**; we need your help and support.

# FLORIDA PROPOSED BILLS

Florida House

HB 3 –SB 66 Child Safety Devices in Motor Vehicles; Child Safety Devices in Motor Vehicles: Provides child restraint requirements for children of specified ages who are less than specified height

HB 13 –SB 52 Use of Wireless Communications Devices While Driving; Use of Wireless Communications Devices While Driving: Creates "Florida Ban on Texting While Driving Law"; prohibits operation of motor vehicle while using wireless communications device for certain purposes.

HB 15 - Protest Activities; Protest Activities: Prohibits engaging in protest activities within specified distance of property line of location of funeral, burial, or memorial service; provides criminal penalties.

HB 61 - Traffic Safety; Traffic Safety: Creates Minor Traffic Safety Act; prohibits use of electronic communications devices by drivers younger than 18 years of age; provides for voluntary contributions to AAA Foundation for Traffic Safety on driver license applications.

HB 91 - Traffic Infraction Detectors; Traffic Infraction Detectors: Removes provisions relating to installation & use of traffic infraction detectors to enforce specified provisions when driver fails to stop at traffic signal; removes provisions that authorize DHSMV, county, or municipality to use such detectors

HB 97 - Concealed Weapons and Firearms; Concealed Weapons and Firearms: Creates exception to preemption of regulation of firearms to Legislature to allow state agency or local government to prohibit possession of concealed firearms & ammunition at specified publicly sanctioned or sponsored events conducted in public buildings or at government-sponsored outdoor public venues.

HB 119 –SB 92 Searches and Seizures; Searches and Seizures: Prohibits law enforcement agency from using drone to gather evidence or other information; provides exception; authorizes aggrieved party to initiate civil action in order to prevent or remedy violation; prohibits use of evidence obtained or collected in violation of act in criminal prosecution.

HB 123 - Use of Deadly Force; Use of Deadly Force: Requires overt act to support belief that use of deadly force for specified purposes is necessary; defines "unlawful activity" for specified purposes; provides that immunity from civil & criminal liability for certain uses of deadly force does not apply to injuries to children & bystanders not affiliated with overt act.

HB 323 –SB 230- Flag Etiquette; Flag Etiquette: Requires that Governor adopt protocol on flag display; requires protocol to have guidelines for proper flag display & for lowering state flag to half-staff on certain occasions; authorizes Governor to adopt, repeal, or modify any rule or custom as Governor deems appropriate which pertains to display of state flag.

Senate

SB 136 - Self-defense; Self-defense: Authorizing a person to use deadly force, in the defense of property, to prevent the imminent commission of a forcible felony; directing the Department of Law Enforcement to collect, process, maintain, and disseminate information and data on all incidents concerning the alleged justifiable use of force in this state; requiring each law enforcement agency within the state to monthly report to the department all incidents and cases in which a claim regarding the justifiable use of force is raised, etc.

and spill over into the neighboring Indochinese countries of Cambodia and Laos.

The Geneva partition was not a natural division of Vietnam and was not intended to create two separate countries. But the South government, with the support of the United States, blocked the Geneva scheduled elections for reunification. In the context of the Cold War, and with the recent Korean War as a precedent, the U.S. had feared that a reunified Vietnam would elect a Communist government under the popular Hồ Chí Minh, either freely or by South Vietnam and its Western allies portrayed the conflict as based in a principled opposition to communism—to deter the expansion of Soviet-based control throughout Southeast Asia, and to set the tone for any likely future superpower conflicts. The North Vietnamese government and its Southern dissident allies (NLF) viewed the war as a struggle to reunite the country and to repel a foreign aggressor—a virtual continuation of the earlier war for independence against the French. (Remember it once was called “French Indonesia”)

In Vietnam the United States was extremely conscious of the perceptions it portrayed to the world, not only militarily but politically as well. Throughout the Vietnam War, the United States government, aided by the USIA (United States Information Agency), worked hard at sculpting effective propaganda in an effort to persuade the American public, as well as the rest of the world, that the war, what we heard a lot, was a ‘just’ war and as such deserved public support. The goal was to create an atmosphere that enabled the U.S. to proceed in Vietnam as it saw necessary. cont. pg.16

After my last article on Propaganda I received a visit by my neighbor, who happens to be an ABATE member that commented that I didn't mention all the misinformation that was spewed out by our government during the Vietnam conflict.

Who am I to argue? He did three tours in Nam from 63-66 and is highly decorated including 3 Purple Hearts. This E5, Ronald L. Clark, who was called “Rambo” by his fellow service men, was there in the time according to reports when the US was only there as an “Advisor” till on 8 March 1965, two battalions of U.S. Marines waded ashore on the beaches at Danang and with declassified documents available now paints a little different story to the saga of our involvement.

After France's attempted recolonization of Indochina was defeated in 1954 by the Viet Minh at the battle of Điện Biên Phủ, an agreement to temporarily partition the country in two with a de-militarized zone (DMZ) was reached at the Geneva Conference (1954). The “Vietnam War” ostensibly began as a civil war between feuding governments. Being Western-oriented and perceived as less popular than Hồ Chí Minh's northern government, the South Vietnam government fought largely to maintain its governing status within the partitioned entity, rather than to “unify the country” as was the goal of the North. Fighting began in 1957 and with U.S. and Soviet-Chinese involvement would steadily escalate

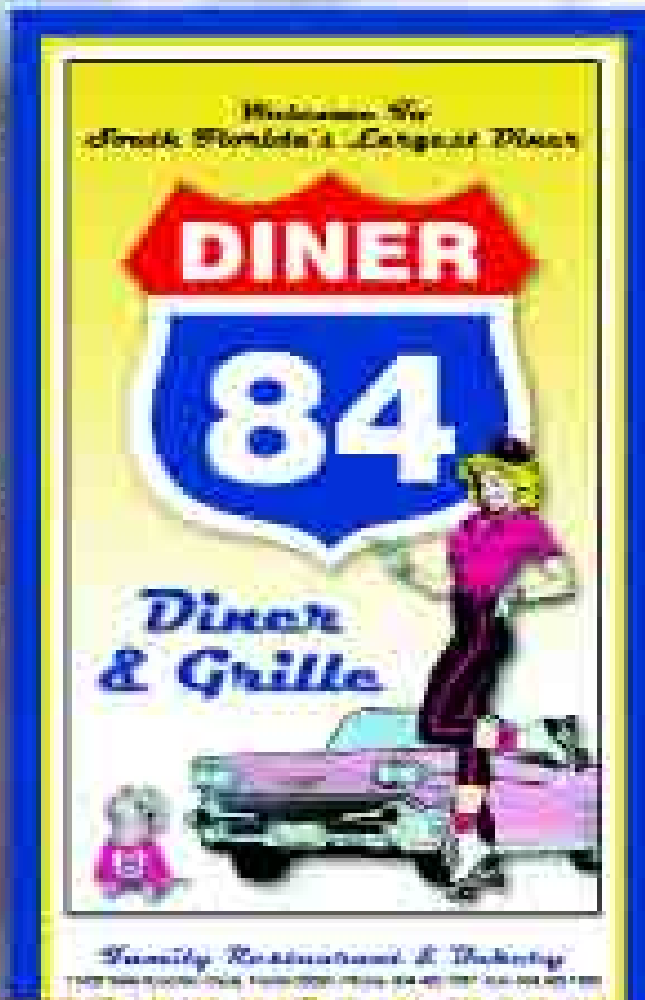

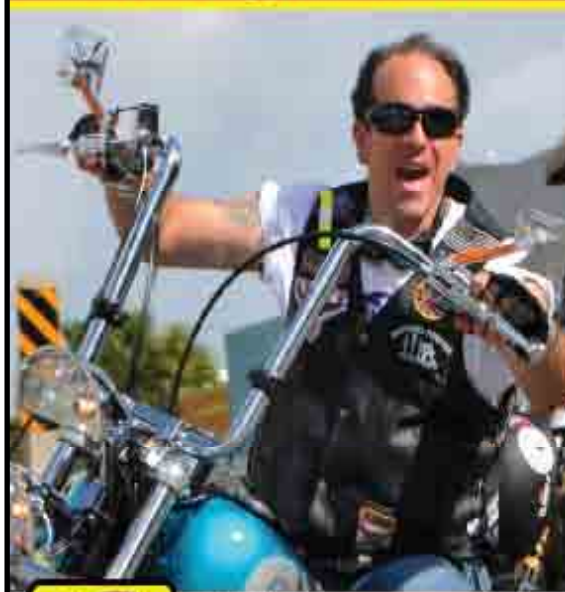

An example of this propagation technique is evidenced by the manner in which news events were announced to the media in Vietnam.

Top administrators, such as Robert McNamara, who were guaranteed to draw a large crowd of reporters, would announce small escalations and developments in Vietnam. However, larger scale commitments were communicated through lower level officials in an attempt to limit the scale of information dissemination. This mistrust of the public and pattern of non-communication influenced the style in which Francis Coppola directed Apocalypse Now. Without proper information the public was unable to form an educated opinion on Vietnam, which inhibited their ability to become emotionally or passionately involved with the war.

The domino theory was a foreign policy theory during the 1950s to 1980s, promoted at times by the government of the United States that speculated that if one land in a region came under the influence of communism, and then the surrounding countries would follow in a domino effect. From the late 1950s to 1975, the United States fought in its only war that did not end in a U.S. victory. During this war, the actions that fulfilled the policies of the United States changed often over the course of four presidents and about eighteen years.

America started to slide down a slippery slope of military involvement - it launched the MAAG: Military Assistance Advisory Group. Then, in 1953, Dwight D. Eisenhower was inaugurated as President. As he sends more and more monetary aid to the French, he coined the phrase "domino effect." Simply put, the domino effect stated that if one Southeast Asian country fell to communism, then all of Southeast Asia would fall including Japan and even Australia. And to that end, Eisenhower said, "...The possible consequences of the loss of free countries in Southeast Asia are just incalculable to the free world." Many succeeding presidents used this term to justify their increasing involvement in Southeast Asia.

If you get a chance and you have the time, read the once censored, Declassified, Top Secret, "Pentagon Papers" officially titled "Report of the Office of the Secretary of Defense Vietnam Task Force", was commissioned by Secretary of Defense Robert McNamara in 1967. There are 48 boxes and approximately 7,000 declassified pages. Approximately 34% of the report is available for the first time online at National Archives <http://www.archives.gov/research/pentagon-papers>

SB 152 - Motor Vehicles; Motor Vehicles: Citing this act as the "Minor Traffic Safety Act;" prohibiting a person younger than 18 years of age from operating a motor vehicle while using a wireless communications device or telephone; requiring that the course content of driver improvement schools include awareness training about using certain electronic devices while driving; providing for a voluntary check-off on motor vehicle registration forms to make a contribution to the Auto Club South Traffic Safety Foundation; requiring traffic law and substance abuse education program content to include awareness of using certain electronic devices while driving; restricting the number of passengers under the age of 18 permitted in a vehicle operated by a person under the age of 18 unless accompanied by a driver at least 21 years of age, etc.

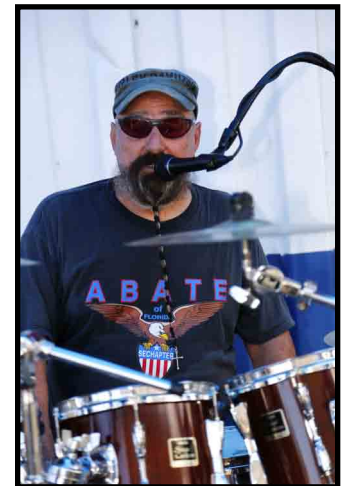

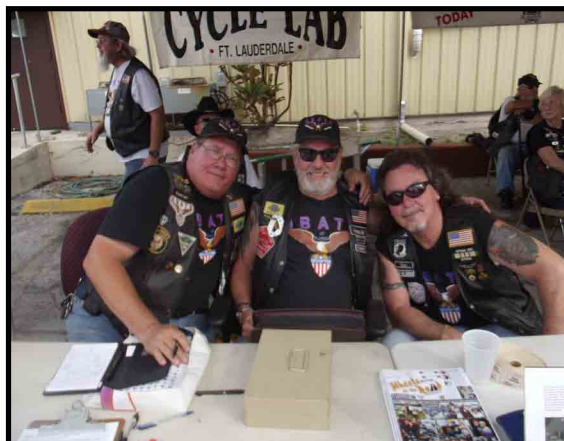

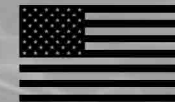

## From Your Safety Director

### Safe riding is always good riding.



Riding safely is mostly a matter of knowledge and attitude, and riding safely doesn't have to be boring. In fact, practicing safe techniques could add years of fun to your life.

Simply put, here are 10 habits to practice that will help keep you safe and make riding more enjoyable.

**1. Be ready: mind, body, and bike.**

There are three ways riders should ready themselves for a ride.

**First**, there is mental readiness. Are you ready to concentrate on riding?

**Second**, you must be physically prepared. Start with good protective gear.

**Third**, you must make sure that your bike is up for the job.

**2. Be smooth**

It takes plenty of concentration, but smooth control of your ride has plenty of specific benefits.

**3. Know where you are.**

Being aware of what is in your immediate space cushion will always help you guide your ride safely.

**4. Use your head (to look where you're going.)**

This may sound slightly remedial but it is an under-appreciated habit of a skilled rider. It becomes even more important in corners where riders tend to be mesmerized by the area of pavement directly in front of their bike.

**5. When your line of sight or path of travel becomes restricted, reduce your speed and use great care.**

On the surface this seems to be a no-brainer, but think back to the last time a car you were following began to slow down. Did you slow and maintain a safe following distance, or did you end up tailgating until the car turned or stopped?

This is a very common mistake that many of us are guilty of committing. Unless "the force" is strong with you (and there are not many Jedi Knights on this planet), it is tough to avoid what you cannot see.

**6. Before proceeding through any intersection, check left, check front, check right, then check left again.**

**7. Whenever you slow, first check your rearview mirror.**

Too often, what is out of sight is out of mind. As you slow down for any turn or a stop, you need to be aware of what is happening behind you.

**8. Keep a 2-4 second following distance.**

Following too closely to the vehicle in front of you is arguably one of the greatest sins committed by most riders on a regular basis.

**9. Ride with a great attitude.**

A bad attitude will be reflected in your riding and a preoccupation with whatever made you grumpy will only distract you from the job at hand: safely riding your motorcycle.

**10. Practice**

The very best time to practice these habits is every time you go out for a ride. Spend at least a few minutes every ride concentrating on each of these habits and soon they will become second nature to you.

### CONGRESS GIVES TAX BREAK TO ELECTRIC MOTORCYCLE BUYERS

Tax hikes and spending cuts dominated holiday headlines as the federal government teetered on the edge of the Fiscal Cliff, but the legislative package passed on New Year's Day to resolve the issue, dubbed the American Taxpayer Relief Act of 2012, included several tax credit extensions that didn't generate as much media interest – including one for electric motorcycles.

Oregon Senator Ron Wyden (D) sponsored the amendment extending the EV tax credit, which covers 10% of the cost of a qualified electric vehicle, up to \$2,500. Vehicles must be a two- or three-wheeled plug-in electric designed “primarily for use on public streets, roads, and highways” and “capable of achieving a speed of 45 miles per hour or greater.”

Electric-powered two wheelers have been without a federal purchase incentive since the end of 2011, when the original tax break expired that was part of the \$800 billion stimulus package passed in 2009.

A coalition of EV motorcycle companies, through Plug-In America, lobbied Congress to extend the tax credits, which are also retroactive and apply for electric motorcycles or EV chargers purchased in 2012 as well.

Wyden argues that extending the tax credit will help

generate jobs in the growing electric motorcycle industry. “The electric motorcycle industry is poised to create tens of thousands of U.S. jobs over the next five years, led by companies like Oregon’s Brammo,” said Wyden. “This amendment helps promote the development of a promising U.S. industry and support the transition to a low-carbon American economy.”

### E-CYCLES PROJECTED TO OUTSELL PLUG-IN CARS

According to two new Pike Research reports, electric scooters and motorcycle sales are going to eclipse that of plug-in vehicles by the end of this decade.

In one report from Pike Research which looks at electric motorcycles and scooters, the study predicts that “annual sales of e-motorcycles and e-scooters will reach 18.6 million by 2018.”

Pike Research points primarily to industries such as delivery companies, police and security forces, and even taxi services in some locations as the prime mover for the increase in sales of electric motorcycles and scooters.

Another recently released Pike Research report predicted that annual worldwide sales of electric vehicles will reach 3.8 million by 2020. This includes plug-in electric vehicles and hybrid electric vehicles selling in the Asia Pacific, North America, and Western Europe.

“Sales of EVs have not lived up to automakers’ expectations and politicians’ proclamations, but the market is expanding steadily as fuel prices remain high and consumers increasingly seek alternatives to internal combustion engines,” says senior research analyst Dave Hurst. “Indeed, sales of plug-in EVs will grow at a compound annual growth rate of nearly 40% over the remainder of the decade, while the overall auto market will expand by only two percent a year.”

Taken together, the two Pike Research reports indicate that two-wheel EV sales will outperform electric

four-wheelers by a margin of 5-1 by the end of the decade. Currently, China is the biggest market for the sale of these electric vehicles, accounting for 81% of the global electric motorcycle and scooter market.

### EPA TO DROP FOUR GALLON MINIMUM GAS PURCHASES

Ethanol-laden gasoline is known to cause engine damage, and many manufacturers warn that using the product will invalidate warranties, so when the EPA approved E15 (fuel blend containing 15% ethanol) it raised concerns amongst motorcyclists, off-roaders, snowmobilers, boaters and others who use vehicles and equipment driven by small gas-powered motors...none of which are approved for its use.

The EPA’s response was to require a minimum four gallon purchase, the misguided rationale being that it would dilute any residual E15 remaining in a gas pump’s lines. Again, the U.S. Environmental Protection Agency came under fire, with powersports and automotive groups pushing back against the federal agency’s push for the grain alcohol-blended biofuel.

Apparently realizing that a viable solution to the problem needs to be conceived, the EPA is abandoning its four-gallon minimum on blender pumps that dispense both E10 and E15 from the same pump, and instead the government body says it will likely require gas stations to label shared pumps, as well as offer a dedicated E10 pump/hose for non-approved vehicles.

In the meantime, the U.S. Court of Appeals for the District of Columbia has denied a rehearing on the EPA decision to put E15 on the market. The federal appellate court decision is a setback for the oil-and-gas industry, which opposes the use of E15 and a federal biofuel blending mandate that requires refiners to blend 36 billion gallons of biofuels into traditional transportation fuels by 2022.

### NEW YEAR, NEW LAWS

The new year puts new laws on the books across the country, with state and local governments ringing in 2013 with a mix of new laws ranging from the innovative to the odd; one in Kansas City says house-

holds can't have more than four cats, while a town in Massachusetts is banning businesses from selling plastic bottles. In Florida, drivers can once again flash their headlights to warn others of upcoming speed traps, which was previously outlawed. Meanwhile, driverless cars in California got the green light to hit the public roads, but one of Illinois' 150 new laws prohibits motorcycle riders from popping wheelies -- Public Act 97-743 imposes a fine of \$1,000 on anyone who pops a wheelie on a motorcycle while speeding.

#### WOMAN FIRED OVER HUSBAND BEING IN A MOTORCYCLE CLUB

Her husband's membership in a motorcycle club has cost the job of a human resources technician with the city of Kingman in northwest Arizona, according to a Phoenix lawyer who is representing the woman in her bid for reinstatement.

The city served 11-year employee Melissa Summerson a notice of intent the day after Christmas and terminated her employment Dec. 28, attorney David Kresin told the Las Vegas Review-Journal. "She was terminated for the stated reason of her husband's membership in a family motorcycle club - the Desert Roadriders," he said, adding that the dismissal violates her constitutional right to freedom of association. "There's no allegation that Ms. Summerson personally did anything wrong in her job or engaged in any conduct personally that violated any of the city's rules, and we believe there's no cause for termination as she's been an outstanding employee with a great record for her entire employment."

#### CRIMINALS MORE PRONE TO CRASH THEIR MOTORCYCLES

Motorcyclists who have criminal records are twice as likely to get into accidents on the road than their law-abiding peers, a new Swedish study has found.

The findings come from an examination of more than 5,000 motorcycle accidents carried out by Karolinska Institute epidemiologist Michael Forede.

He went through statistics and looked at motorcycle

riders who have a license and then cross-referenced the names with the criminal register.

"If you've been convicted of a crime before, we see at least double the risk that you'll get into a serious accident," Forede told the TT news agency.

Among non-offenders, there are 4.1 accidents per 1,000 license-holders annually. However, that figure jumped up to 27.7 when looking at drivers who had at least two criminal convictions.

Forede shared his findings at the Transportforum conference in Linköping, Sweden. "Maybe we should educate people who break the traffic laws," suggests Forede.

One operator, who is enforcing the ban, said police asked him and others to sign an agreement that the dress code standard relating to bikies was upheld.
