- 2. Tell someone. In a study, people who shared what was happening with a friend or family member were told, It's a scam.
- 3. Do your own research. Don't click on links or use phone numbers, email addresses or account numbers provided by scammers.
- Set up a crisis only code word with family members. Agree on a word to use in an emergency that everyone can remember. (AARP Article)

The following legislators were in attendance:



Our questions dealt primarily with Vouchers, Charter Schools, Funding our Public Schools, Safety and Mental Illness. Please follow up and continue to reach out to your representative by phone, email or snail mail with your concerns. It's important that they hear from us. Senator Massey mentioned that we should not participate in those group emails, as for the most part they pay no attention to them, but will respond to personal stories and emails. All the representatives nodded and were in agreement with her.

We need to be diligent on the voucher issues as Governor Lee will be calling a special session soon after the election to try to get this law passed.
