Financial Security: At a funeral last week a friend, "Jane" related that they were almost victims of the "grandchild in trouble" scam. They received a call from some foreign place saying that their grandson was in jail and needed to talk. The kid on the phone sounded exactly like the grandson they remembered and had a good reason not to call the parents. He needed bail money. They asked him authentication questions about parents' names, birthdays, hobbies, etc. and he got all of the answers correct. They went to the bank the following morning to wire transfer substantial money overseas. The bank promptly warned that these calls were always a scam and convinced Jane to call parents. The kid was at home doing homework!

This is speculation. Between the Equifax hack and social media, they know almost every detail of the young generation's lives. The scammers had probably called the target kid on his smart phone for a fake survey that interested him and got a voice recording. A very skilled scammer mimicked the voice and talked convincingly to grandparents.

The lesson learned is "do not believe your ears". No grandchild is ever going to call his grandparents because they all know about this scam.
