### Artificial Intelligence (AI) capability being used to impersonate people

We have previously discussed the "impersonation" scams used to try to get senior citizens to send money for some fake emergency. You may recall that I got one of these calls some years ago claiming that my grandson was in jail and wanted me to wire money. That was easy to refute since I do not have any grandchildren!

Karen Trent sent an article (<https://www.idz.us/knowledge-center>) about how AI technology has greatly increased the chance that I will not be able to sort out the scams so easily next time. AI can sort through all the internet sites and know my family history; they can mimic voices, and create false narratives based on birthday and holiday greetings. If my scammers are using AI, they will probably not make the same mistake next time! My dumb husband has our complete family tree posted online!

Other than relatives and law enforcement, some of people being impersonated include government officials, court officers, celebrities, and even neighbors. Anytime someone is asking for immediate money transactions like gift cards, wire transfer, or money orders; be very cautious.

## LEGISLATIVE NEWS

I am so excited that our Knox County Board of Education voted 6-3, Dec. 4th to affirm that every child in the district, regardless of immigration status, has the right to a free public education and asked our state lawmakers to reject efforts to make school systems collect or verify the immigration status of students. the bipartisan agreement was to include this measure among their legislative priorities. This approved measure, titled "Free Education for All Children," restates the district's position that Tennessee's constitution guarantees access to public schools for all students. It also asks state lawmakers to reject any future state mandates that would require districts to collect or verify the immigration status of students.

This was in response to a state Legislative bill that would give school districts the authority to ban undocumented students or charge them tuition. This bill passed the Senate during the 2025 session and is up for further consideration in the House during the 2026 session. The bill is a direct challenge to a 1982 U.S. Supreme Court ruling that prevents public schools from excluding students based on immigration status.

For months, Knox County citizens adults and students have been writing, calling, and showing up asking our school board to reject this bill: at times filling both the boardroom and the overflow room. Anne Templeton and Katherine Bike crafted the legislative priority. ## "Our Link to the Future"

Almost 50 years ago, two accomplished KCRTA educators, Tom Underwood and Reuben Hunter, decided there was a need to initiate a scholarship for young aspiring teachers who could be considered worthy of replacing strong retiring classroom teachers. They wanted the applicants to have a passion for teaching and a financial need as they completed their final steps in acquiring their teacher certification. Mr. Underwood and Mr. Hunter further decided that the recipients could use the scholarship money for any purposes they needed to help them finalize their studies. The first "Our Link to the Future" scholarship in the amount of \$500 was awarded in the early 1980s.

On November 20, 2025, KCRTA's Scholarship Foundation awarded nine (9) \$3000 scholarships to students from Lee University, Johnson University, and The University of Tennessee. Applications were received from two other universities as well. These nine recipients were selected from thirty-seven (37) applications. The members of KCRTA who attended the Scholarship Foundation Luncheon listened attentively and applauded enthusiastically as they heard each recipient's story, vision, and accomplishments. These students were excellent students with compassion for others, passion for teaching and love of learning. It was a great day of celebration!

I left the luncheon with a sense of tremendous pride, not only because of the awarding of scholarships to nine teachers ready to approach the classroom with passion, but also because of: 1) the nine retired teachers who served on the Scholarship Selection Committee who gave their time to the process and then presented these winners with pride and support: 2) the KCRTA members who have donated to the scholarship fund for years; and 3) the fact that Tom Underwood was there to witness this great celebration. (I wish Reuben Hunter could have been there to see how his vision has grown through the years too.) Thank you, also, to all of you in KCRTA who worked and helped make this day possible.

## The US Penny: Making sense (CENTS) of it all!

According to Mr. Google one day in December of 2025, compiled information surrounding the United States **One-cent piece**, sometimes referred to as "a penny", production has been ceased on November 13, 2025. The U.S. cent was modeled after the British penny and thus this nickname stuck for over 200 years of use.

The first main point is, the one cent piece, the penny, is still legal tender and can be used for monetary transactions in the United States. As time marches, on the Penny will be reduced by attrition in our economy. Mathematics instructors should be on alert to include rounding up and rounding down exercises for student learners.

The first "Flowing Hair" cent, was minted by the U.S. Mint in 1793 and served as the official one cent coin! This was after the coinage act of 1792, established the National Mint now referred to as the U.S. Mint. The earliest usage of the cent designation, prior to vintage US coinage in 1793 was the "Fugio cent" minted in 1787 by authority of the Congress of the Confederation in New Haven, Connecticut from the metal copper bands around gunpowder kegs. Some collectors consider this the first penny in America.

Only one person, one image at a time has been displayed on the front of the one-cent piece. From beginning to the end of production (a total of 232 years), the US Mint has been producing the penny for business strikes. The following is a brief outline on the Penny's produced during those 232 years.

Large Cents (1793 - 1857)      Flowing Hair Cent (1793)      Liberty Cap Cent (1793 - 1796)  
Draped Bust Cent (1796 - 1809)      Classic Head Cent (1808 - 1814)      Coronet or Matron Head Cent (1816 - 1839)      Braided Hair Cent (1839 - 1857)      Small Cents (1856-2025)      Flying Eagle Cent (1856 - 1858)      Indian Head Cent (1859 - 1909)      Lincoln Cent (1909 - 2025)\*  
\*Abraham Lincoln was the first US president to be illustrated on any coinage

I hope all enjoyed what they were given at the KCRTA November Scholarship Luncheon. Moreover, the exceptional share from Anthony Hancock concerning the penny was electrifying.

All in attendance received One 2025 US one-cent piece, business strikes. The nine (9) Scholarship Recipients received "Their two cents worth" including a 1957 FIRST day cachet for the "Teacher stamp", #1093.

Many thanks to Libby Burney and others for allowing me to express heartfelt gratitude on information and delivery on the Last United States American one-cent pieces to be generated by the United States Mint.

And one more thing YOUR PENNYS could be considered collector coins. It's never too late to start a penny collection! Some estimate that there's 300 billion pennies somewhere, possibly in collection jars, and various locations around the world. More than likely, there will be special sets in subsequent years, low manage, drawing attention to the US one cent piece. These will all be controlled by the Untied States meant for future release. You can check out your current pennies on hand by researching on the American Numismatic Association website. **Mike Blakenship, Parliamentarian**
