Legislative News - Tennessee Legislature is Currently Out of Session Until 2026

Tennessee's 114th State General Assembly's adjournment was April 22, 2025. After a special session where vouchers for private schools passed, this legislative general session continued in the vein of having bills that were detrimental to public schools. Here are examples of bills that were passed and one that was rolled until 2026 since it passed in the Senate, but did not get approval in the House.

*HB0958 (Slator) and SB095 (Powers) - Amends TCA Title 49

Bill proposes to create a seven-member task force to ensure Tennessee can effectively respond to any potential deregulation or dismantling of the Education Department at the federal level. The task force created by this legislation will identify K-12 Education funding, federal requirements for receiving federal funds and the number of positions paid for by the federal dollars. The Task Force will be required to submit policy recommendations to the General Assembly by December 31, 2025.

- *Passed Full Senate by 27 to 5 vote on 3/25/25.
- *Passed Full House by 74 to 23 vote on 4/21/25. House moved to substitute SB095.
- *HB0662 (White) and SB0714 (Taylor)
- *Allows Commissioner of Education to seize control of districts not meeting arbitrary performance criteria by replacing locally elected school boards with a state appointed Board of Managers.
- *Passed Full House by a 63 to 30 to 2 PNV on 4/22/25 House moved to substitute Senate Bill 0714.
- *Passed full Senate on 4/22/25 by a 26 to 6 vote
- *Amendment: Would add 9 "advisors" from Memphis-Shelby over a two-year period to mentor and advise the Memphis-Shelby County School Board.

This bill was heavily amended in both chambers. If this can be done for one community in Tennessee, what is stopping it from

happening in other communities within in the State?



Legislative News Continued:

*HB0793 (Lamberth with co-sponsors Garrett, Capley, Butler, Todd, Martin, Rudd, Zachary, Reeves, Lafferty, Oggett, Fritts, Powers, Cepicky) and SB0836 (Watson with co-sponsors Yager, Johnson, Stevens, White)

As introduced, authorizes Local Education Agencies (LEAs) and public charter schools to refuse to enroll students who are unlawfully present in the United States. Amends TCA Title 4 and Title 49.

- *Passed Full Senate on 4/10/25 by 19 to 13 vote (sent to House)
- **House Sponsor Lamberth rolled the bill to 2026.

AMENDED - allows LEAs and public charters to charge tuition to students - without legal status. If parents cannot afford tuition, schools can deny admittance.

*If eventually passed, this bill would challenge the 1982 Plyer v. Doe Supreme Court case from Texas. (Lawsuits would be imminent at all levels).


*HB062 (Mayberry) and SB1083 (Johnson)

Amend TCA, Title 5, Title 6, Title 7, Title 8 and Title 49, relative to hiring practices of governmental entities.

This act is known as the "Dismantle DEI Act."

- *House passed as amended 73 to 24 vote on 4/17/25.
- **Senate substituted House Bill and passed on 27 to 6 vote on 4/22/25.
