Subject: CYBER SAFETY TIPS FOR SENIORS!

- *Use Strong Passwords: Strong passwords are a first line of defense against identity theft and fraud. Use on in-home devices, personal devices, social media, and banking portals.
- *Install Security Software: Use anti-virus and anti-spyware software to protect yourself online. Make sure the software is installed properly and run regular updates to mitigate new threats.
- *Set up two-step authentication: This can add an extra layer of security to protect your health information.
- *Be careful with Attachments: Don't open attachments from unknown senders or attachments that seem suspicious. Attachments can contain viruses that can infect your computers.
- *Be wary of Messages: Don't click on links or respond to pop-up windows in emails, texts, or on your computer from unfamiliar senders or people you don't know well. Be especially wary of unexpected or strange messages. You can also ignore unsolicited phone calls and robocalls.
- *Shop at Reputable Retailers: When shopping online, stick with retailers you know and trust. Avoid retailers you've never heard of, as they may try to steal your information or not deliver the promised product.

Expanded Membership Eligibility

At our May luncheon and business meeting, the Members in attendance amended the Association's Bylaws by adopting the following new language for ARTICLE II Membership Section 3:

Any retired teacher, administrator, supervisor, or educational support personnel previously employed in the public school sector or in higher education may become a member upon the payment of dues as set out in ARTICLE X herein.

This amendment opens KCRTA membership to retired educational support personnel and individuals who were employed in higher education. While you may be unfamiliar with the term educational support personnel, you might recognize these individuals as "classified" employees. Educational Support Personnel are educational workers holding positions that do not require teaching certification. They are the teaching assistants, office staff, cafeteria workers, janitorial staff and others who make our schools work.

Please share this good news with those you know who are now eligible for membership in our association. Their membership will strengthen our ability to promote efforts that are good for public education and that protect our retirement benefits.
