### **Subject: Check Washing Fraud Alert!**

Several legitimate news sources have recently been reporting on the "check washing" fraud problem. Briefly this involved intercepting paper checks from the mail system and altering the payee and the amount and cashing it directly from your bank. No person is really looking at canceled checks to determine if there is evidence of alterations. It is all done by cameras and computers.

The problem can begin with your street mailbox with the flag raised. Thieves can drive by and remove the outgoing mail (perhaps bill payments). Senior citizens are more likely to use paper statements and paper checks and have the mail retrieved by your mail person. Even drop boxes outside Post Offices have been compromised and outgoing mail stolen.

There are two ways to reduce the risk. The first way is avoiding the use of street mail boxes for outgoing checks. The best way to send mail that includes checks is to use the interior drop slots inside a post office. Use your street box with flag up only for non-check mail.

Another way to reduce risk is to use pens that are difficult to erase. Evidently most ball point pens are easy to erase using chemicals. Several university studies have shown that the use of liquid ink with "roller ball" tips are the most difficult to wash and alter. In one study the best pen of this type was the Uniball 207. This is not an endorsement.

I hate all this! For some payees I still prefer paper statements and paper checks. My husband pays a lot of bills online, but there are some payees that I still prefer to handle with old-fashioned paper!

# **Expanded Membership Eligibility**

At our May luncheon and business meeting, the Members in attendance amended the Association's Bylaws by adopting the following new language for ARTICLE II Membership Section 3:

Any retired teacher, administrator, supervisor, or educational support personnel previously employed in the public school sector or in higher education may become a member upon the payment of dues as set out in ARTICLE X herein.

This amendment opens KCRTA membership to retired educational support personnel and individuals who were employed in higher education. While you may be unfamiliar with the term educational support personnel, you might recognize these individuals as "classified" employees. Educational Support Personnel are educational workers holding positions that do not require teaching certification. They are the teaching assistants, office staff, cafeteria workers, janitorial staff and others who make our schools work.

Please share this good news with those you know who are now eligible for membership in our association. Their membership will strengthen our ability to promote efforts that are good for public education and that protect our retirement benefits.

# **July 2024 Legislative News**

I want to encourage everyone to vote in the upcoming Federal/State Primary, County General, and Town of Farragut Municipal Elections. These elections typically have low voter turnout, so **we can have a BIG impact** if we get out and vote in these elections especially for our school board candidates. Early voting is Friday, July 12-Saturday, July 27, and election day is Thursday, August 1.

We need to support candidates who support our public schools and not those with a partisan agenda.

**District 2** covers the North Knoxville communities served by Central and Fulton Hgh Schools. **Incumbent Jennifer Owen** (1) is running again. She taught for 18 years and has been on the school board for 8 years. Also running are Pat Polis (1) and Anne Templeton (D).

**District 3** covers the Cedar Bluff schools. Incumbent Daniel Watson has decided not to run. **Patricia Fontenot-Ridley (D)** has been a teacher for 30 years and retired this past May from Belle Morris Elementary School. She grew up going to District 3 schools before graduating from Farragut High School. Angie Goethert (R) has volunteered for years in her children's classrooms and served as the parent-teacher association president at Hardin Valley Academy. In 2021, she helped lead an unsuccessful lawsuit against Knox County Schools over its COVID-19 mask mandate.

**District 5** covers far-west communities including Farragut. Incumbent Susan Horn has decided not to run again. Terrye Whitaker (D) has a bachelor's degree in education. She moved to Knoxville in 1981. Whitaker has worked for the University of Tennessee and has served as a substitute teacher with the district. Whitaker's daughter graduated from Farragut High School. Lauren Morgan (R) has three children in Farragut Schools and has been volunteering in various capacities.

**District 8** The eastern-most district in the county has the Carter and Gibbs schools. Travis Wright (7) won the primary and has already taken the oath of office to fill the void left by Mike McMillan.
