## Legislative

Valerie Biberdorf and I, along with a few members of the Knox County Education Coalition have continued to meet with our Knox County Legislators, these past several months. Our relationships with local legislators continues to strengthen and grow as we complete our first round of meetings with them and begin our second. Our state surplus continues to rise to historic proportions and our schools are still underfunded. Our focus remains on funding, however there are several bills which need our attention.

First and foremost is the 3rd grade retention bill which was passed in 2021 but goes into effect this spring. "The intention behind this policy is to improve student achievement. There is evidence to suggest that retaining students in third grade may have negative impacts that outweigh any potential benefits. A better approach would focus on very early evaluation for struggling readers, and a robust program of academic supports and interventions beginning in kindergarten and continuing as long as needed. Retention should be limited to Pre-K, kindergarten or possibly first graders; third grade is too late. Contact your Tennessee legislators and ask them to invest in academic supports and interventions for our youngest school children and to leave retention decisions to teachers and parents, where they belong." If Knox County has 1000 home school students taking part, it would cost about \$5 million/year new local tax revenue.

#### **KCRTA Scholarship Foundation**

The Knox County Retired Teachers Association Scholarship Foundation is a 501  $\odot$  (3) non-profit tax-exempt organization. The goal of the Foundation is to provide financial assistance in the form of scholarships to students who are classified as full-time seniors or graduate students, who are pursuing a Tennessee teaching certification. The scholarships are awarded to students enrolled in a college or university in East Tennessee.

Since the 1980's, the scholarship foundation program has been a major emphasis of the Knox County Retired Teachers Association, and each November the KCRTA Scholarship Foundation holds its annual scholarship foundation awards ceremony and luncheon at The Foundry. For many years there were three standing scholarships---the Tom Underwood and the Reuben Hunter, named for the two men who established the scholarship program (1993), and the Colleen Bennett who left an endowment at her death to sustain the program. Since 2018, the families of Bill Crosland and Cindi Schowalter have funded a scholarship in their names. In addition, each year, the Knox County Retired Teachers Association, honors a member whose outstanding service to the organization merits recognition. Other named scholarships come from donations in memory of or in honor of those whose friends and/or family members wish to recognize someone special.

Although the scholarship initiative as we know it today has grown substantially and has evolved into a thriving, recognized effort of the KCRTA, it still remains true to the goals and core values established by its founders. Scholarship recipients are chosen from the applications of exceptional future educators enrolled in an East Tennessee college or university teacher education program. Each fall a selection committee, made up of former educators, critiques the scholarship entries. Over the years, the amount awarded to students has increased from \$300 during the first three years to the current total of \$1,500.

Gifts are welcomed in any amount and may be designated for either the Scholarship Fund or the Endowment Fund.

## **Spotlight on KCRTA Centenarian**

Emma Ruth Catlett turned 101 in February this year. She began her teaching career in Sevierville before coming to Knoxville City Schools at Brownlow Elementary from 1957 to 1968 and then to Chilhowee Elementary from 1968 to 1982. She retired in 1982 after 26 years of teaching in the City Schools. Believing that everyone should have access to a public library, Mrs. Catlett worked tirelessly with members of the Northview Community Association to get the leaders of Sevier County to see the need for a public library in Kodak. The Catlett family made a significant contribution to acquire the land and build the library. Mrs. Catlett was one of the founders of the Friends of the Kodak Library. She served on the library board for many years, helping to raise funds for building and supporting the library after it opened. According to Mrs. Catlett, the library is flourishing and in fact is "bursting at the seams".
