President's Message

I graduated from high school in 1969. That fall, I entered East Tennessee State University and later transferred to the University of Tennessee. My parents were factory workers who believed in the power of Education and I was the first from either side of my family to attend college. This month, members of KCRTA will reaffirm our belief in the power of Education by awarding nine scholarships to individuals who are currently preparing for careers in education.

If you have paid for a child or grandchild to attend college, you know the cost of a college education has increased significantly since we matriculated. According to the Education Data Initiative, the average cost of a year's tuition and fees at a public four-year college in 1969 was \$323. The National Center for Education Statistics placed the 2020-21 average cost at \$10,560 or a 2580% increase over 1970-71 prices. Thanks to two hardworking parents, I graduated in 1973 without a penny of debt; however, according to the Department of Education, the average debt for a June 2023 graduate was \$37,650. It's clear that obtaining a college degree is a huge financial commitment and financial assistance is essential for many students. U.S. News and World Report published a 2022 survey revealing that scholarships and grants typically cover 26% of college costs in 2021-22.

KCTRA members are proud of our continued support of future educators. On November 16th at The Foundry, we will recognize and celebrate this year's scholarship recipients at our annual Scholarship Luncheon. I hope to see you there. **Remember this special luncheon requires a RSVP.**



Subject: PBI Letter in reference Move It Data Breech

Retired teachers may receive a letter with PBI> letter head. Careful reading of this document reveals that Pension Benefit Information (PBI) is the audit contractor to TCRA. Evidently, they were impacted by the MOVEit computer virus date breech publicized in June 2023. My letter indicates that my name, SSN, and birth date may have been compromised.

The MOVEit virus problem is well documented on internet and printed media. Many federal and state private organizations were impacted as well.

They are offering to enroll effected retirees into Kroll's Monoitoring Seervices at no charge. This Service includes credit monoitoring and fraud consultation. I plan to do this.

If this seems confusing, you might want to share the PBI letter with a trusted financial advisor or a knowledgeable friend.
