# PREFACE

It is a matter of immense pleasure to submit the self- study report of SDWG Govt.College Beetan to the NAAC, Bangalore for accreditation (Cycle-1). This SSR has been compiled with the collective efforts made by all the members of the staff. All the figures provided in this SSR have been meticulously collected and analyzed after intensive and extensive discussions among the staff at various levels. Our college is affiliated to the H.P.University, Shimla which is first in the country to introduce and implement CBCS (RUSA) system in toto w.e.f 2013-14. Our college has applied for recognition under section 2(f) of the UGC Act on 04.02.2016 and the response of the UGC in this regard is awaited.

The learned faculty of the college is straining every nerve to make RUSA a success for the betterment of students and the society at large. In order to achieve the goals that the college has set for itself, we get regular formal and informal feedback from our students, parents, OSA and IQAC and its external members. The college had started its journey with Arts stream classes. In 2014, the Commerce stream was started in the college and now w.e.f. June 2016, the Science stream classes are going to start. Our college plans to start P.G. courses and other self-financed courses like BBA,BCA, etc. to increase its student strength and optimum utilization of its building.

Our college had submitted the LOI for IEQA evaluation to the NAAC on 23.04.2015 with **Track ID HPCOGN22631**. However, our college could not clear IEQA and was asked to re-apply LOI after six months and the college was given suggestions on 17 points for improvement. Ever since our college has been working sedulously towards making improvement in the 17 suggested areas. Of these through the assiduous efforts of the staff, our college has made significant improvement in 11 areas like computer, internet facility, sports, extension activities, computer students ratio, admission against reservation, etc. We are making all-out efforts to make advancement in the remaining areas, too, at the earliest.

We have uploaded our self-study report on our college website [www.gcbeetan.co.in](http://www.gcbeetan.co.in) we have also simultaneously re-submitted our LOI on-line to the NAAC for scrutiny and confirmation of our IEQA status. We are anytime ready to submit the required number of hard copies of our SSR along with a digital version (CD) of the SSR to the NAAC.

We are curious to know our IEQA status and looking forward to a fruitful interaction with the NAAC Peer Team for accreditation of our college.

## BRIEF HISTORY OF THE COLLEGE

SDWG Government College Beetan was established in 1997 by Sant Baba Dhangu Wale Ji as a private college to serve the educational needs of the area. The college is situated on Nangal- Mahilpur road about 25 kms from the district headquarters at Una and is well connected by roads. The old building of the college consisting of fourteen spacious classrooms and a separate Administrative Block housing Principal office, Superintendent office and Staff room was constructed by the private management. The college is affiliated to the H.P. University Shimla. On 23<sup>rd</sup> August, 2004, the college was taken over by the Government of Himachal Pradesh. The foundation stone of the new ultra-modern building of Sant Dhangu Wale Gujjar Government College Beetan was laid by Shri Virbhadra Singh Ji, Hon'ble Chief Minister of Himachal Pradesh in the presence of Shri Mukesh Agnihotri Ji, Hon'ble Industry Minister of Himachal Pradesh on 9<sup>th</sup> November, 2006. An amount to the tune of Rs. 7,28,52,000/- was spent on the construction of this state-of-the-art building. The classes along with administrative offices were shifted to the new building on 01.08.2011. . Presently, the old college building in the campus is being temporarily used by the Government run Industrial Training Institute, Pubowal.

Till 2014 there was only Arts stream in the college. The Commerce stream was introduced in the college in June, 2014 and now due to the persistent efforts made by the present Principal, Abhilasha Sharda at various levels, the Science stream classes are going to start w.e.f. June, 2016. H.P. Government's notification and necessary permission to this effect have been received by the college.

Besides Himachal Pradesh, the students of the adjoining state of Punjab are also getting education in the college. The college caters to the needs of higher education of students belonging to different communities of Hindus, Sikhs and Muslims. The college gives liberal scholarships and fee concessions to students belonging to SC, ST, OBC, IRDP, BPL, EWS, etc. as per the Government norms. Hopefully, the college is going to transform the life of the rural population by raising their higher educational standards.

## EXECUTIVE SUMMARY

SDWG Govt.College Beetan was established in September 1997 as a private institution. The college was taken over by the Government of Himachal Pradesh on 23-08-2004. The college is affiliated to the H.P.University, Shimla. From 2004 to 2014, the classes in the Arts stream only were taught in the college. In June 2014, the Commerce stream was started and now in June, 2016 the Science stream is going to start.

The vision of the college is to enlighten students through providing holistic education to them in keeping with the college motto "From Darkness to Light". The mission of the college is to make students responsible citizens with cosmopolitan outlook. The college seeks to make students good leaders to spread the light of knowledge. We have applied for recognition under section 2(f) of the UGC. Presently, the college seeks NAAC accreditation (Cycle-1)

A summary of the criterion wise analysis of the college in the last four years is given below:

### **I Curricular aspects:**

SDWG Govt.College Beetan offers B.A. and B.Com. programmes and the Science stream classes are going to Commence w.e.f. June,2016. Majority of our teachers act as evaluators and supervisors to assist in University examinations.

### **II Teaching-Learning and Evaluation:**

Our college is affiliated to the H.P.University Shimla and follows its policies in regard to teaching-learning and evaluation. The following action plans are deployed by the college for effective implementation of the curriculum:

- At the beginning of the semester each faculty member submits a syllabus- plan to the principal.
- An academic calendar is prepared in advance and published in college prospectus.
- Each department maintains the progress through Mid-Term Test and End Semester Examinations.
- To assess the headway made by the college, the head of the institution conducts meetings with all faculty members at the beginning and end of each semester.

- Time- table is chalked out well in advance before the beginning of each semester.
- To make teaching-learning process more effective, the students are encouraged to make use of computer and internet. For this to happen, free internet is being provided in the library for the students. Stress is laid on fostering a sense of social responsibility among the students. Students are made aware of the burning issues besetting the students.

Teachers are encouraged to attend seminars, orientation courses, refresher courses and short- term courses to keep their knowledge updated.

### **III Research, Consultancy and Extension:**

The College encourages the teachers to pursue and guide research. The English faculty has guided one Ph.D. scholar who has been awarded Ph.D. degree by the Himachal Pradesh University in 2014. Assistant Professor of the department of Hindi has been awarded Ph.D. degree in 2015 by the University of MANONMANIAM SUNDARANAR, TIRUNELVELI (Tamil Nadu) in 2015.

Our Principal is pursuing her Ph.D. in the subject of Mathematics from the University of Himachal Pradesh, Shimla.

It is the stated mission of the college to rid students of superstitions and to think rationally and scientifically.

### **IV Infrastructure and learning-Resources(ISR):**

The college has a state of the art three- storey building. There are more than 50 airy and spacious rooms equipped with tube- lights and fans, etc.

### **V Student support and progression:**

- The college tries to fulfil its vision and goals through the following measures:
- The college provides welfare schemes, scholarships and fee concession for students belonging to SC/ST/OBC/EWS,etc.
- Remedial classes are held for help of learners and students who are academically weak.

- Co-curricular and extra-curricular activities are organized by the college throughout the year to realize our vision and mission.
- The students are counseled in the beginning, during and the exit point to meet the challenges of life.
- To address complaints of the students Grievance Cell and Anti-ragging Cell are constituted in the college.
- The students are encouraged to approach their teachers and Principal without any hesitation for the solution of their problems.
- There is one gymnasium for the physical fitness of the students in the old building of the college.
- Value education is imparted to the students for their ethical development.
- Our college envisions quality education for the all-round development of the students. The IQAC plays a pivotal role in assuring quality education.

## **VI Governance, Leadership and Management:**

- The college is committed to provide quality education to the underprivileged first generation learners.

We provide complete information about all the activities of the college like co-curricular, extra-curricular scholarships, prizes, sports, exam schedules, etc.Admission related advertisement is given well in advance in the local newspapers.**

- **The college follows the standard process prescribed by the H.P.University Shimla/H.P.Govt. Seats are given on the basis of merit. Marks obtained in 10+2 form the basis of merit. Reservation policy is followed as per the instructions of University /H.P.Govt. We have an Admission Committee to supervise the process of admission. The committee takes care of the interest of the students belonging to the reserve categories.**

- **Admission rules and Eligible Conditions for U.G.Classes**

A candidate seeking admission to the 1<sup>st</sup> semester BA/B.Sc./B.Com.(Pass) must have passed 10+2 or an equivalent examination of a Board/University with pass in five subjects including English.

- Prior to 2014, the college offered only the Arts stream. In 2014, the Commerce stream was started in the college. In June 2014, 42 students opted for commerce and in June 2015, 62 students took admission in B.Com 1<sup>st</sup> Semester. This shows an ever- increasing upward trend for the stream of Commerce as compared to Arts.

## 2.2 Catering to Student Diversity

- **The college is very much alive to the needs of the students who are differently-abled. The college does not have any challenged students. However, all the teachers and students are always ready to extend any help if such an eventuality arises in the future. The college ensures that all existing structure as well as future construction projects in the campus are made disabled-friendly. The college has special facilities such as ramp, wheel chair and railing, etc. to meet the special needs of differently-abled students.**

- **In order to bridge the knowledge gap of the enrolled students, the college conducts classes for the academically weak students. The students' weakness in any subject is identified through the class-room tests by the subject teachers. The college chalks out the time-table accordingly.**

- **The college has Women Cell that specially makes the students gender-sensitive. Sexual harassment is a grave violation of human rights. It is gross infringement on life and liberty. The college Women Cell ensures equality of all the students. The college adopts a policy of all inclusiveness. Lectures are delivered to empower especially the girl students. The college is ready**

to swing into action if any thing untoward happens. However, no such case has been reported so far in the college.

The college launches various campaigns to keep the environment clean and conducive to studies. The college NSS keeps planting different trees and flowers in the college campus and in its vicinity.

- All the students are assessed at different levels through class tests and University exams. The faculty guides and monitors the student's performance very closely. Students who are very bright, talented and hard-working are given special questionnaires to solve them. These questions are generally of higher I.Q. More intelligent students are asked to read and solve problems which are not prescribed in their syllabus.

- The college has constituted Admission Committee, Counseling Cell and Examination Committee to collect the figures of all types of academic performance of the students. The faculty conducts remedial classes for the students who are otherwise underprivileged to improve their academic performance.

## 2.2 Teaching-Learning Process:

2.3.1 How does the college plan and organize the teaching, learning and evaluation schedules? (Academic calendar, teaching plan, evaluation blue print, etc.)

- The college is affiliated to the H.P.University, Shimla. It follows



evaluation policy as prescribed by the University. The academic calendar is published well before commencement of the session. The entire teaching plan is prepared in the beginning of the session. The faculty members make their contribution by implementing the entire process of teaching, learning and evaluation. Academically, students are encouraged to browse extra relevant material in the library at their own level. Hence, all the planning and the execution of teaching, learning and evaluation schedules are implemented by the college very effectively. All the teaching-learning and evaluation schedules are thoroughly discussed with the Principal before their final implementation.

2.3.2 How does IQAC contribute to improve the teaching –learning process?

- The college has recently formed IQAC which is contributing hugely to improve the teaching learning process. It is the endeavour of the IQAC to ensure that the quality of teaching learning gets improved through various activities. It ensures that all the students of the college should have access to internet facility provided by the college. The feedback is obtained from the students and parents to improve the teaching-learning process.

2.3.3 How is learning made more student-centric? Give details on the support structures and systems available for teachers to develop skills like interactive learning, collaborative learning and independent learning among the students?

- The college gives priority to make learning more and more student-oriented. The active participation of students in all the activities like group discussions, competitions, debates and quizzes, skits and other co-

curricular and extra-curricular activities is ensured. The students are encouraged to discuss and express their views freely. So that they become creative writers and speakers. The Principal interacts with the SCA members regularly and they discuss the changes they would like to see in the college with regard to the prevalent teaching methods. The teachers make it a point to provide the students all the necessary learning material to use beyond the classroom teaching.

2.3.4 How does the institution nurture critical thinking, creativity and scientific temper among the students to transform them into life-long learners and innovators?

- SDWG Govt.College Beetan stresses on the active participation of students in all the activities of the college ----- academic, co-curricular, extra-curricular, sports etc. Students are encouraged to express their creativity through writing in college magazine 'Jagriti'. An effort is made to make the students sharpen their critical faculties by participating in activities like debates, quizzes and declamation contests etc. The department of English time and again arranges Spelling-Bee events to hone their linguistic skills. It is one of the stated objectives of the college to get students rid of superstitions and to make them think rationally, logically and scientifically.

- The college is well connected with internet facility. The computer lab is playing a very vital role in giving students the required access to remain updated with the recent knowledge, innovation and technology .Students can access college library which is well equipped with text books,

reference books, newspapers, journals, magazines and computers.

- The students and faculty are exposed to advanced level of knowledge mainly via the internet facility available in the college. The teachers attend various seminars, orientation courses, refresher courses and workshops etc. for the content enrichment and learning various pedagogical techniques. Students are encouraged to visit various industrial units which are located in the vicinity of the college.

- The college has counseling cell, career guidance and placement cell to provide psychological support and guidance to the needy students. The college emphasizes on teaching the students who are weak in their subjects due to their poor educational & financial background by arranging for remedial classes in the college. The time-table is chalked out keeping in view the needs of the students who are otherwise weak.

- In order to make college students knowledgeable various innovative teaching learning processes are adopted. The help of internet is presently sought. Maximum use of black board is ensured. Teachers use approaches in teaching like lectures, discussion and taking feedback. The focus is on the latest trends and techniques and so that students do not lag behind from getting exposure to any field.

- **The college has a well equipped library with intelligent staff. The library staff aids the faculty as well as the students in readily providing teaching material as and when required. All the prescribed text books along with reference books are provided to the students. The library remains open on all days barring Sundays and other gazetted holidays. For the underprivileged students, the book-bank facility is available.**

- Since the college is affiliated to the H.P.University, Shimla it cannot initiate reforms on its own. The college follows the changes or reforms if any as made by the University. At present, the University has switched over from the annual system of examination to the semester system. The University has changed the entire syllabus under CBCS (RUSA) system and the same is framed by the college since 2013-14 session. However, the college holds staff meetings regularly and suggestions regarding any change or reform are sent to the University through the Principal for consideration of the same.

- **Evaluation reforms of the H.P. University, Shimla to which the college is affiliated are implemented in toto by the college. The college has formed various committees for the proper implementation of the evaluation like Exam Committee, Grievance Redressal Cell, and IQAC, etc. The entire process of effective implementation of the evaluation reforms is overseen by the Principal.**

- **The formative as well as the summative assessments are adopted as per the prescribed procedure by the H.P. University. Proper feedback is obtained from the students. The staff members also give their comments after the examination is over.**

- **The class tests, Mid-Term Tests followed by the End Semester Examinations invariably positively impacts students' performance and achievement. For example, students' performance in the classroom tests lead to their improvement in Mid-Term Tests and similarly, students performance in the Mid-Term Tests lead to their improvement in the End Semester Examinations conducted by the H.P. University, Shimla itself.**

- **The H.P. University shifted from the annual system of examination to**

the semester system under CBCS (RUSA) from the 2013-14 session. Since then, the entire process of examination /evaluation/assessment has been changed and presently the Internal Assessment process has been made even more transparent. Now the students have the option to see their answer books for themselves if they are not satisfied with their scores. The marks for Internal Assessment are given as under.

The college keeps track of students' activities and performance since their admission in the 1<sup>st</sup> semester till the End Semester Examinations.**


