

OUTERIMCON DEALERS ROOM CONTRACT October 12 – 13, 2019

Dealers Room spaces may be purchased under the following guidelines: \$100.00 per space. This fee includes one full membership, one 6' x 6' space, one 6' table and two chairs. **Additionally, 1 helper membership can be purchased for \$20.00.** Additional memberships may be purchased at the Current Membership rate on the date of purchase. **IMPORTANT NOTE** – Dealers will be limited to two 6' x 6' spaces (2 spaces). Although we will try, we cannot guarantee meeting special requests. Dealers will have to provide their own table covering. OuteRimCon is not required to provide anything else. Power can be provided free however, it is based on a first come first served basis and is limited. Dealers must provide their own extension cord. We will try to meet special requests as noted on the application, but cannot guarantee to do so or to assign a specific space or location. Dealers agree to use assigned space for sale or exhibit of material that is of a science, science fiction, fantasy, gaming or other “fannish” nature. Dealers agree that they have legal title to material offered for sale and are responsible for ensuring that the material is in compliance with all State and Federal laws, regulations and ordinances in force at the site of and at all times during the convention. Dealers agree that they are **self-insured**. Dealers agree that all merchandise sold is to be as represented and that all appraisals made by dealers are to be made at their own risk. Dealers are strongly urged to be ready to open when the room opens, and to maintain their spaces until the room closes each day of the convention. Dealers Room hours will be to be Saturday; 10:00 am – 5:00 pm and 10:00 am – 3:00 pm Sunday. Set-up for the room will be Saturday; 7:00 am – 9:30 am Dealers must be set up and ready for business by 9:45 am. Doors open 10:00 am

IMPORTANT per the Columbia Memorial Space Center which is the location of the convention all dealers must have liability coverage and a Downey Temporary Business License. See application for more information.
