Obedience Club of San Diego County, Inc. ("OCSDC," "we" or "us") operates ocsdc.org, ("Site") and our service ("Service(s)").

Your membership information will never be sold or shared with any outside sources. You understand that The Obedience Club of San Diego County, Inc. will comply with all rules and regulations regarding membership information that are required by the American Kennel Club, and the State of California.

All information regarding visitors to our Website, our customers, our customer's contacts or other consumers that our customers reach through our Service are treated carefully; we respect your privacy.

By using our Site, you acknowledge and agree to this Privacy Policy as well as our Terms and Conditions.

This Privacy Policy describes the types of personal information we collect on the Site and via our Service, whether online, offline or by contacting us by phone, email or text, how we may use the information and the purposes for which we may use it, with whom we may share it and the choices available to you.

What We Collect

We collect information you provide directly to us. For example, we collect information when you make a donation, participate in any interactive areas or features of the Services, sign up to receive email updates or other notifications (such as text and email message alerts), fill out a form, participate in a survey, contest or other promotion, communicate with us via third-party social media sites, or otherwise communicate with us. The types of information we may collect include your name, email address, postal address, phone number, credit card and other payment information, and any other information you choose to provide.

Other Information We Collect When You Use Our Services

- When you access or use the Services, we automatically collect certain information about you, including: Log Information: We collect information related to your access to and use of the Services, such as your Internet Protocol ("IP") address, your operating system, the type of browser you use, your activity on the Services (such as access times, pages viewed, and links clicked), and the webpage that you visited before navigating to the Services.
- Transactional Information: When you make a purchase or a return, we collect information related to the transaction, such as product details, purchase price, and the date and time of the transaction.
- **Device Information:** We collect information about the computer or mobile device you use to access the Services, such as the hardware model, operating system and version, unique device identifier's, and mobile network information.
- Location Information: We may derive the approximate location of your device from your IP address. Information Collected by Cookies and Similar Tracking Technologies: We (and our service providers) use various technologies to collect information, including cookies and web beacons. Cookies are small data files stored on your hard drive or in device memory that, among other things, help us to improve the Services and your experience, see which areas or features of the Services are popular, and count visits to the Services. For more information about cookies and how to disable them, please see the YOUR CHOICES section of this Privacy Policy below. Web beacons are small electronic images that may be used on the Services or in emails and that help to deliver cookies, count visits to the Services, monitor user activity on the Services, and understand usage and campaign effectiveness.

Information We Collect From Other Sources

We may obtain information from other sources and combine it with information we collect through the Services. For example, if you make a donation to a third-party website, such as Donor Box or Act Blue, for our benefit or if you sign up to host or volunteer for an event associated with us via a third-party website, such as MobilizeAmerica, we will obtain certain information about you from the third party that operates that website.

How Do We Use the Information We Collect?

We use information we collect for the following purposes:

- to provide, maintain, and improve the Services;
- to provide you with services, products, or information you request, and to send you related information, such as notifications and confirmations;
- to send you technical notices, updates, security alerts, and support and administrative messages;
- to respond to your emails, submissions, comments, questions, and requests, and to provide customer service;
- to request feedback, and to otherwise contact you about your use of the Services;
- to send you newsletters, and to otherwise provide you with news and information that we think
 will be of interest to you, such as sending you information to keep you informed about various
 campaigns, candidates, issues, events, resources, promotions, contests, products, and
 services:
- to help connect you with other supporters, and to solicit volunteers, donations, and support for the OCSDC, issues, events, and organizations that we support;

We may collect the below categories of information for the following business or commercial purposes (as those terms are denied in applicable law):

- Providing the Services;
- Our operational purposes;
- Auditing consumer interactions on our site;
- Detecting, protecting against, and prosecuting security incidents and fraudulent or illegal activity;
 Bug detection, error reporting, and activities to maintain the quality or safety of our Service;
 Improving our existing Services and developing new services (e.g., by conducting research to develop new products or features);
- Other uses that advance our commercial or economic interests, and Other uses about which we notify you

What Information Do We Share With Third Parties?

We may share information about you as follows or as otherwise described in this Privacy Policy:

- with vendors, consultants, and other service providers or volunteers who are engaged by or working with us and who need access to such information to carry out work or to perform services on our behalf;
- when you give us your consent to do so, including when we notify you on the Services that the
 information you provide will be shared in a particular manner and you provide such
 information; when we believe in good faith that we are lawfully authorized or required to do so
 or that doing so is

- reasonably necessary or appropriate to comply with applicable laws or legal processes or to respond to lawful requests, claims, or legal authorities, including responding to lawful subpoenas, warrants, or court orders;
- when we believe in good faith that doing so is reasonably necessary or appropriate to respond
 to claims or to protect the rights, property, or safety of the OCSDC, our users, our volunteers,
 copyright owners, third parties or the public, including to protect such parties from fraudulent,
 abusive, inappropriate, or unlawful activity or use of the Services; and
- in connection with, or during negotiations of, any merger, reorganization, acquisition, asset sale, financing or lending transaction, or in any other situation where information may be disclosed or transferred as one of the assets of the OCSDC.

We also may share aggregated or de-identified information with third parties that cannot reasonably be used by such third parties to identify you.

• The above excludes text messaging originator opt-in data and consent, which information will not be shared with any third parties, provided that the foregoing does not apply to sharing (1) with vendors, consultants and other service providers who need access to such information to carry out work on our behalf (and who will not use such information for their own purposes); (2) if we believe disclosure is required by any applicable law, rule, or regulation or to comply with law enforcement or legal process; and (3) if the user consents to our sharing of such information.

What Information May Be Shared in Connection with Social Sharing Features of the Services?

• The Services offer certain social sharing features and other integrated tools (such as the Facebook "Like" button), which let you share actions you take on the Services with other media. Your use of such features and tools enables the sharing of certain information with your friends or with the public, depending on the settings you establish with the thirty party that provides the social sharing features and other integrated tools.
