PRESIDENT'S MESSAGE

Greetings Everyone!

The OCSDC recently found out that the IRS records and the OCSDC Bylaws are in conflict, with 2 different fiscal years on record. The OCSDC Bylaws indicate the fiscal year is November 1st to October 31, while the IRS says our fiscal year is October 1st to September 30th.

Unfortunately, it would take an act of God to change the IRS records, so we have elected to change our bylaws to reflect IRS records. These Bylaw changes to membership will be voted on at our May 20th General Meeting, which will take place at 7PM at the north end of the zoo parking lot.

The Changes to Our Bylaws in a Nutshell

Please note that changes are in red.

ARTICLE IV - CLUB YEAR, ANNUAL MEETING & ELECTIONS

SECTION 1. CLUB YEAR. The Club's fiscal year shall begin on the first day of November October and end on the last day of October September. The Club's official year shall begin immediately at the conclusion of the election at the annual meeting in October September and shall continue through the election at the next annual meeting.

SECTION 2. ANNUAL MEETING. The annual meeting shall be held in the month of October September. Newly elected Officers and Directors for the ensuing year shall take office at the annual meeting, and each retiring officer shall turn over to his or her successor in office all properties and records relating to that office within 30 days after the election.

SECTION 3. ELECTIONS. Voting for Officers and Board of Directors will be held in the month of October September at which time Officers and Directors for the ensuing year shall be elected by secret, written ballot from among those nominated in accordance with Section 4 of this Article. The nominated candidate receiving the greatest number of votes for each office shall be declared elected. The seven nominated candidates for other positions of the Board who receive the greatest number of votes for such positions shall be declared elected. If there is no opposition to the slate put forward by the Nominating Committee, no vote is necessary and the slate is duly elected.

SECTION 4. NOMINATIONS. No person may be a candidate in a Club election who has not been nominated. During the month of August July, the Board shall select a Nominating Committee consisting of three members, not more than one of whom may be a member of the Board. The Board shall name a Chairman for the Committee, and it shall be his or her duty to call a committee meeting which shall be held before the third Wednesday in September.

The Committee shall nominate one candidate for each office and six candidates for the six other positions on the Board, and after securing the consent of each person so nominated, shall immediately report their nominations in writing to the Secretary.

Upon receipt of the Nominating Committee's report, the Secretary shall, before the third Wednesday in September August, notify each member in writing, of the candidate so nominated.

Additional nominations may be made at the September August meeting by any member in attendance, provided that the person so nominated accepts when his name is proposed, and provided further that if the proposed candidate is not in attendance at this meeting, his or her proposer shall present a written statement to the Secretary from the proposed candidate signifying his or her willingness to be a candidate. No person may be a candidate for more than one position, and the additional nominations which are provided for herein may be made only from among those members who have not accepted a nomination from the Nominating Committee.

Nominations cannot be made after the September August meeting, or in any manner other than as provided in this Section.

On Becoming an AKC Member Club

As many of you know, the Obedience Club of San Diego County is in it's 75th year of existence in San Diego County. Two kinds of clubs, "Licensed" and "Member" are affiliated with the American Kennel Club. We are currently a long established "Licensed Club" and we are looking at the benefits of becoming a "Member" Club. Below is a list of benefits that we do not now enjoy, as a Licensed Club.

Representation: Only member clubs have Delegate representation. Delegates vote on rules governing the sport of purebred dogs and attending meetings at which our feelings/concerns can be addressed in a more timely manner..

Licensed clubs are not formally represented during discussion on the rules of our sport, on by-laws, votes or the election of the AKC board.

The delegate body, comprised of fellow member club delegates, approve a club's AKC membership status. Member clubs have absolute legislative protection to a member club's corresponding date and show territory and rules can only be changed by member club delegates.

Although the Board has extended date and territorial protection privileges to licensed clubs, changes or exceptions to policy pertaining to an individual club can be made by Board vote. AKC reviews the by-laws of licensed clubs and comments on provisions it does not feel to be appropriate. However, AKC approval of licensed club by-laws is not mandatory. In extreme cases where bylaws could be detrimental as written to the operation of the club, AKC could recommend to the Board that the club's license status be provoked.

To become a Member Club, there is a one-time initiation fee of \$250.00. This balances out, because there is no fee for 1st show each year and only \$15.00 for each additional event. Delegates set the amounts of initiation fees, dues and AKC recording fees.

For licensed clubs, costs are \$50.00 for each obedience trial. License fees may be increased at any time by a majority vote of the AKC Board.

The AKC communicates important information instantaneously to all member clubs through their delegates.

For licensed clubs, much information of a general nature must be gleaned from a club's regular review of the AKC website or the AKC Gazette.

We feel that as an approved member club, we will have more say in matters that pertain to our club and through our delegate, will have much quicker access to getting any questions answered, which will afford us a little more clout within the organization. This will enhance our standing within the AKC community.

Becoming a Member club is an ongoing process that will take a little time, most likely a year or more. We feel the benefits far outweigh any negatives.

News from the AKC

The U.S. Centers for Disease Control and Prevention (CDC) released a letter advising of a change in the rules pertaining to importation of cats and dogs into the United States.

Effective August 1, 2024, the CDC is implementing a process to standardize imports that will require that all dogs being imported into the U.S. must be 6 months of age, irrespective of where they are coming from or for what purpose.

Summary:

CDC's letter states CDC is updating this regulation to protect the health and safety of people and animals, and to prevent the reintroduction of dog rabies to the United States. The regulation will address recent challenges with international dog importations and more closely align with the World Organization for Animal Health's standards for the international movement of dogs from countries determined to be a high-risk for dog rabies. Under the new rule, all dogs must meet the following requirements for importation into the United States (including those that left the U.S. and are returning—regardless of the country they are being imported from):

Be healthy upon arrival, Be at least 6 months of age, Have an ISO -compatible microchip (implanted prior to any required rabies vaccinations)

Have a CDC Dog Import Form receipt. The CDC Dog Import Form is an online form on CDC's website., Have additional documents depending on where the dog has been in the last 6 months and whether or not the dog was vaccinated in the United States. Additional requirements will be needed for dogs imported from countries designated as high-risk for DMRVV (canine rabies). These requirements may include arriving at a port with a CDC-registered animal care facility (ACF), an appointment with an ACF prior to import, and quarantine. For more details, visit cdc.gov/dog travel. The new rule replaces a temporary rule that will expire on August 1, 2024. The current temporary rule, which AKC supports, restricted the import of dogs from countries designated as high risk for rabies and other contagious diseases, while also allowing for the import of younger pets from low-risk countries as personal pets not for transfer.

Unlike legislative proposals, administrative rule changes go through a period of public comment regarding changes proposed by an agency tasked with promulgating existing law. The new rule follows a period of public comment on CDC's proposed changes governing imports of dogs and cats, which concluded in September 2023. AKC Government Relations will continue to study the new rule change and provide additional information as appropriate.
