### **1. Veterinary Treatment & Emergency Care**

- ☐ I confirm that I agree and accept that any veterinary fees incurred during the cats stay will be the responsibility of the owner and must be paid at the time of required treatment regardless of the medical complaint.

### **2. Vaccination Declaration**

- ☐ My cat is vaccinated against Panleukopenia, Herpes Virus and Calicivirus.
- ☐ Vaccination proof has been supplied and a physical record will accompany my cat at drop off.
- ☐ I understand titre testing is not accepted as an alternative at Haysden Country Cattery.
- ☐ I understand my cat will be refused admission if vaccination requirements are not met.

### **3. Microchip Declaration**

☐ I confirm my cat is microchipped and that I am able to provide the number.

### **4. Medical Conditions & Senior Cats**

☐ I understand cats aged 10+ will require an additional Senior Cat Policy form and I am agreeable to read and complete this at drop off.

### **5. Care & Accommodation**

☐ I am agreeable that alternative suitable food may be offered to my cat(s) in the event of a three day food refusal. Examples - Tuna, cooked plain chicken, weebox lick-e-lix.
