



### **Consent Form - Haysden Country Cattery**

#### **1. Authorisation for Veterinary Treatment**

I agree that in the case of suspected illness, a veterinary surgeon may be contacted and my cat's illness investigated if required (including blood tests, x-rays etc.).

I agree that any veterinary treatment that takes place will be paid for by the cat owner on the day of treatment – this may be over the phone or in person.

I agree for the cattery to administer any prescribed treatments the vet considers advisable.

I understand that any tests and treatment given will be at my own expense and due at the discretion of the vets.

I give permission for worm/flea treatment to be given as necessary by the vet and understand that I will be charged for this on the day of administration.

In the event of the cat owner being uncontactable, I give consent for euthanasia should this be recommended on humane grounds by the veterinary surgeon caring for my cat, in consultation with the cat's allocated veterinary surgeon/emergency contact.

Every effort will be made to use the cat's usual veterinary practice should your cat require veterinary treatment. Where this is not possible, the cattery's vet will be used. The cattery's vet is Dacre House, Tunbridge Wells.

I give consent that in the event of my cat needing to be taken to an isolation facility due to presenting signs of an infectious disease, they will be taken to the cat's allocated vet. If the allocated vet is unable to take the cat they will be taken to Dacre House, Tunbridge Wells.

I consent that if needed, my details can be passed to Dacre House in Tunbridge Wells including my name, contact details, address and my cat's veterinary history/notes.

## **2. Care and Accommodation**

I give my consent to the following should Haysden Country Cattery feel it appropriate for my cat(s) whilst they are in their care:

- I consent that my cats can be kept together (under instruction of the owner on arrival/cat drop off)

## **6. Failure to Collect**

In the event that you fail to collect your cat and are uncontactable, your emergency contact will be called and asked to collect your cat on your behalf.

If nobody is reachable within a 12-hour period, your cat will be taken and held at your personal vet. Any fees charged by the vet will be payable by the cat owner.
